**JOINT MOTION FOR SUSPENSION
OF OPPOSITION AND TO RESET TRIAL DATES**

Opposer DISH Network L.L.C. and Applicant NVIDIA Corporation jointly request that the Trademark Trial and Appeal Board (“Board”) further suspend proceedings in the above-entitled opposition, and that the trial dates be reset as indicated below. As grounds for this motion, the parties state that they have entered into an agreement that provides for amendment of the NVIDIA HOPPER application and for Letters of Consent by Applicant to certain applications filed by Opposer; that Applicant filed a motion to amend its application with the Board on October 3, 2022, with Opposer’s consent; that the Board approved the proposed amendments on January 25, 2023, and suspended proceedings for a further 30 days; and that Opposer has submitted the Letters of Consent to the USPTO in support of Opposer’s applications, and is waiting for them to be approved.
