# MOTION ON CONSENT TO AMEND APPLICATION AND CONTINGENT WITHDRAWAL OF OPPOSITION WITH PREJUDICE

#### I. <u>Motion on Consent to Amend Application</u>

Pursuant to TBMP 514.02, Applicant Trebco Specialty Products Inc., with the consent of Opposer Thomas M. Kelly., hereby requests that the opposed Application Serial Nos. 90033138 and 90033142 be amended as follows:

The Applicant requests that the identification of goods in the opposed application in International Class 28 only be amended to add "not for dogs or cats" to "game balls" and "plush toys, stuffed toy animals, stuffed toys, soft sculpture toys" so that the identification of goods as amended reads as follows:

"International Class 28 - "Games and toys, namely, board games, card games, party games, puzzle games, bath toys, infant toys, baby multiple activity toys and building blocks; baby and children's rattles; Games and toys, namely,
