NOTICE OF OPPOSITION

MMT, INC. (d/b/a StormTree), a Rhode Island corporation, located and doing business at 25 Blodgett Avenue, Pawtucket, Rhode Island 02860, (hereinafter called "Opposer"), believes that it will be damaged by the registration of the mark shown in Application Serial No. 88/900,803 in Class 011, filed by HYDRO INTERNATIONAL LIMITED (hereinafter "Applicant") on May 5, 2020, and opposes Application Serial No. 88/900,803.

The grounds for this opposition are as follows:

1. Opposer is engaged in the manufacture and sale in interstate commerce of a biofiltration device that removes sediment, chemical pollutants, and debris from stormwater runoff using patented "tree filtering" technology (U.S. Patent No. 8,333,885 B1, U.S. Patent No. 10,563,392) (the "Products") under the following trademarks which are registered in the U.S. Patent and Trademark Office (the "Marks")

(hereafter collectively referred to as "Opposer's Registered Marks"). The description of the goods and services of Opposers' Marks in International Class 011 are as follows: Filtering units for removing sediment and contaminants from storm water influent using a soil media; Lawn sprinkler systems comprising pumps, valves and filters; Storm water filtering units featuring non-metal filtering booms and tendrils used to reduce bacteria and hydrocarbons in standing water; Water filtering apparatus. Registration of Opposer's Registered Marks is valid, subsisting and conclusive evidence of Opposer's exclusive right to use Opposer's Registered Marks in commerce on the goods specified in said registrations.

- 2. The Marks have been used continuously in interstate commerce in connection with the Products beginning at least as early as the dates set forth above. All of the Marks are currently registered.
- 3. Opposer has made substantial investment in advertising and promoting their goods under Opposer's STROMETREE Marks since their initial use. Opposer has used, advertised, promoted and offered Opposer's goods bearing Opposer's STORMTREE Marks to the public through

various channels of trade in commerce, with the result that Opposer's customers have come to know and recognize Opposer's STORMTREE Marks and associate the same with Opposer and/or the goods sold by Opposer.

Upon information and belief, notwithstanding Opposer's rights in and to Opposer's 4. STORMTREE marks, on May 5, 2020, Applicant filed an application for registration of the proposed STORMSCAPE trademark in International Class 011 for "Apparatus for water supply and sanitary purposes, namely, a stormwater treatment and detention system within the field of bioretention comprised of baffle walls, engineered filter media and plant life; apparatus for sewer network treatment and water treatment, namely, water filter and ground soil percolation systems comprised of baffle walls, engineered filter media and plant life for the purpose of removing contaminants found in stormwater runoff within the field of bioretention; water filtering installations; water filtering apparatus; water purification installations; water sterilisers; water purifying machines; membranes for the filtration of water cartridge filtration units for treating water; filters made of fibre for water treatment; reverse osmosis water filtration units; water purification, sedimentation and filtration apparatus for clarification, thickening and filtration of water, waste water and industrial water; filters and screens for removal of solids in water treatment systems; water filtering apparatus for use in screening and separating solid matter and particulates from waste water; apparatus, installations and systems for the management, flow, storage and treatment of water, namely, a bioretention system comprised of baffle walls, engineered filter media and plant life for the purpose of removing contaminants found in stormwater runoff; apparatus, installations and systems for the control and management of water flow, including flow of stormwater, and industrial effluent, namely, a modular, partly-submerged base for use as a water filtering apparatus that contains baffle walls, engineered filter media and plant life; stormwater drainage systems comprised of a modular, partly submerged base for use as a water filtering apparatus that contains containing baffle walls, engineered filter media and plant life; parts, accessories and fittings for all of the aforesaid goods, namely, structural parts for the aforesaid goods, water filtering apparatus in the

nature of filtering water and engineered filter media, namely, filtering materials made of engineered coarse and fine sand mixed with organic material such as peat, loam or carbon; apparatus, installations and systems for the management, flow, storage and treatment of water, namely, filtration and infiltration systems, namely, a modular, partly-submerged base comprised of baffle walls in the nature of submergible fiberglass and metal or concrete walls used to direct water flow, engineered filter media and plant life; apparatus, installations and systems for the control and management of water flow, including flow of stormwater, and industrial effluent, namely, a modular, partly-submerged base comprised of baffle walls in the nature of submergible fiberglass walls used to direct water flow, engineered filter media and plant life. Said application was assigned Serial No. 88/900,803, and was published for Opposition in the Official Gazette of February 9, 2021.

5. Applicant's STORMSCAPE mark so resembles Opposer's STROMTREE marks as to be likely, when applied to the goods of Opposer, including Opposer's range of patented products, to cause confusion or mistake or to deceive purchasers resulting in damage and detriment of Opposer and its reputation.

- 6. Opposer, upon information and belief, avers that its customers are likely to be confused, mistaken or deceived as to the origin and sponsorship of Applicant's proposed goods of Application Serial Number 88/900,803 to be marketed under Applicant's proposed STROMSCAPE mark and misled into believing that such goods emanate from, are licensed by, or are in some way directly or indirectly associated with, approved by or sponsored by Opposer, to the damage and detriment of Opposer and its reputation.
- 7. Opposer, upon information and belief, avers that it will be damaged by the registration by Applicant of the proposed STORMSCAPE trademark, as set forth in Applicant's Trademark Application Serial No. 88/900,803, in that the mark is substantially similar to Opposer's STORMTREE Marks and common law rights and will be used in connection with goods that, as described in Applicant's application, would directly compete with Opposer's own patented biofiltration devices offered to the public by Opposer and/or its controlled licensees.
- 8. Lastly, a lawsuit is currently pending in the District Court of Maine brought by MMT, INC. against Hydro International Limited, Case No.: 2:21-cv-00079-JDL seeking relief under 15 U.S.C. §§1114 and 1125 for Defendant's misappropriation of Plaintiff's trademark and the associated consumer goodwill.

Wherefore, this Opposer, MMT, INC., (d/b/a StormTree), believes and avers that it is being and will continue to be damaged by registration of the proposed STORMSCAPE trademark as aforesaid, prays that the said Application Serial No. 88/900,803 be rejected in accordance with the provisions of the Trademark Act, that no registration be issued thereon to Applicant, and that this Opposition be sustained in favor of Opposer.
