**NOTICE OF OPPOSITION**

Gravy Keg, LLC, an Ohio limited liability company d/b/a Cincy Shirts and d/b/a Old School Shirts, located and doing business at 2511 Essex Place #129, Cincinnati, Ohio 45206, (“Opposer”), believes that it will be damaged by U.S. Trademark Application Serial No.



90230673 for the mark ANAHEIM AMIGOS (“Applicant’s Application”), submitted by Sports Logo International, LLC (“Applicant”), and therefore opposes same.

As grounds for opposition, it is alleged:

1. By the Applicant’s Application filed on October 1, 2020, Applicant seeks to



obtain registration on the Principal Register of the trademark (the “Mark”) for “Hats; Shirts; Shoes; Shorts; Socks; Hoodies; Jackets; Sports jerseys; Sweat jackets; Sweat pants; Sweat shirts; Sweat suits; Track suits” in International Class 25.

2. The Applicant’s Application was filed on October 1, 2020 as a 1B Intent to Use Application.

3. Since at least 2011, long before the filing date of the Applicant’s Application, Opposer has been, and still is, engaged in the sale of apparel and promotion of its brands.

4. Opposer has used the identical Mark in commerce since at least August 5, 2020.

5. Opposer has filed its own U.S. Trademark Application, Serial No. 90771879 for registration of the Mark for “Hats; Pants; Scarves; Shirts; Shorts; Socks; Sweatpants; Vests; Baby bodysuits; Cloth bibs; Jackets; Sweatshirts; T-shirts; Tank tops” in International Class 25 (“Opposer’s Application”). A true and correct copy of the Filing Receipt issued by the PTO with the specifics of the Opposer’s Application is attached hereto and made of record. Such information will soon be available in the TSDR database.

6. As shown in Opposer’s Application, since at least August 5, 2020, before the filing date of the Applicant’s Application, Opposer has continuously used and promoted the Mark in interstate commerce in connection with its goods.

7. In addition to the protection Opposer seeks by its federal trademark application, Opposer has common law rights in the Mark throughout the United States, having widely sold and distributed goods bearing the Mark. Opposer relies on its common law trademark rights in the Mark.

8. The Mark is distinctive and has secondary meaning.

9. The Mark for which Applicant seeks registration in Applicant’s Application is identical to the Mark for which Opposer has common law rights and seeks registration in Opposer’s Application.

10. The list of goods identified in Opposer’s Application and with which Opposer has been using the Mark in commerce since at least August 5, 2020, is substantially the same as the list of goods identified in the Applicant’s Application.

11. Opposer’s established use of the Mark in commerce that predates Applicant’s Intent to Use Application, Opposer’s continuous use of the Mark, and Opposer’s Application constitute conclusive evidence of the validity of Opposer’s claim of ownership of the Mark and priority of rights to the Mark.

12. Opposer will be damaged by the registration of the Applicant’s Application in that Opposer has priority rights in the Mark when used on or in connection with the goods as they are identified in the Applicant’s Application.

13. Registration of the Mark pursuant to Applicant’s Application would certainly cause confusion with Opposer’s use of the Mark.

14. In view of Opposer’s prior rights in the Mark, Applicant is not entitled to federal registration of the Mark.

WHEREFORE, Opposer prays that Applicant's U.S. Trademark Application Serial No. 90230673 be rejected and stricken, that no registration be issued thereon to Applicant, and that this Opposition be sustained in favor of Opposer.
