**NOTICE OF OPPOSITION**

Opposer, the United States Olympic and Paralympic Committee (“USOPC”), a federally chartered corporation having its principal place of business at One Olympic Plaza, Colorado Springs, Colorado 80909, believes it will be damaged by the registration of the mark shown in application Serial No. 90338288 filed November 23, 2020 by Gilberto Aguirre (“Applicant”), an individual believed to have an address of 525 Wildrose Ln, F1, Brownsville, Texas 78520, and hereby opposes registration of the mark. The grounds for opposition are detailed below.

1. Applicant has applied for registration on the Principal Register for the mark OLYMPION in International Class 025 for “Athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms.” This application was assigned U.S. Application Serial No. 90338288 (“OLYMPION Application”).

2. Applicant filed the OLYMPION Application under Section 1(b) of the Lanham Act.

3. The OLYMPION Application was published for opposition on June 8, 2021. The present opposition is timely filed.

4. The USOPC is a federally chartered corporation that serves as both the National Olympic Committee and National Paralympic Committee for the United States. As such, the USOPC is responsible for the training, entering and funding of U.S. teams for the Olympic, Paralympic, Youth Olympic, Pan American and Parapan American Games, while serving as a steward of the Olympic Movement throughout the country. The USOPC depends greatly on the licensing of its trademarks for its funding and the associated funding of the U.S. Olympic Team.

5. Pursuant to the Ted Stevens Olympic and Amateur Sports Act, 36 U.S.C. § 220506 (“the Act”), Congress granted the USOPC exclusive rights to exploit commercially certain marks and symbols related to the Olympic Games in the United States, including the term OLYMPIC and simulations thereof. *See* 36 U.S.C. § 220506(a)(2) and 220506(c)(3).

6. The USOPC owns numerous registrations for the OLYMPIC mark in association with a wide variety of goods and services. Examples of USOPC owned registrations that incorporate the OLYMPIC Trademark are included in the below table.

7. The term OLYMPIAN is widely and commonly used and recognized as referring to athletes who have participated in the Olympic Games. Therefore, the mark OLYMPIAN qualifies as a simulation of OLYMPIC protected under the Act. *See United States Olympic Committee v. International Federation of Bodybuilders, et al.*, 219 U.S.P.Q. 353, 358 (D.D.C. 1982).

8. The USOPC also owns numerous registrations for marks that include OLYMPIAN. Examples of USOPC owned registrations that incorporate the OLYMPIAN trademark are included in the below table.

Current printouts of information from the electronic database records of the USPTO showing the current status and title of the registrations in the above table are attached hereto as Exhibit B.

9. As a result of its long-standing and extensive use of the OLYMPIAN and OLYMPIC marks, the USOPC owns significant federal and common law trademark rights in these marks.

10. The USOPC has used the famous OLYMPIC trademark in interstate commerce since at least as early as 1896. The USOPC has likewise also used the OLYMPIAN mark since



at least as early as 1974. As a result of its long-standing and extensive use of the OLYMPIC and OLYMPIAN marks, and the exclusive right to use the same as granted by the Act, the USOPC owns significant trademark rights in the marks OLYMPIC and OLYMPIAN. In fact, the OLYMPIC and OLYMPIAN marks are famous trademarks of the USOPC, and became famous before Applicant filed the OLYMPION Application.

11. In anticipation of each Olympic Games, the USOPC engages in a robust licensing program, by which sponsors and other partners are authorized to use trademarks owned by the USOPC on a wide variety of goods and services.

12. The OLYMPION Application was not authorized or approved by the USOPC.

13. The OLYMPION Application should be rejected under 15 U.S.C. §1052(a) for falsely suggesting a connection with an institution. The TTAB has held that the USOPC and the Olympic Games as a whole may be viewed as an institution pursuant to 15 U.S.C. § 1052(a). See *In re Urbano*, 51 USPQ2d 1776 (TTAB 1999).

14. The OLYMPION Application is a close approximation of the OLYMPIC mark and a phonetic equivalent of the OLYMPIAN mark. The OLYMPION Application would be recognized as a close approximation of both the OLYMPIC and OLYMPIAN marks, in that it uniquely and unmistakably points to the USOPC.

15. The OLYMPION Application should also be rejected under the Ted Stevens Olympic and Amateur Sports Act, 36 U.S.C. § 220506. Moreover, the fame of the USOPC is such that, when the OLYMPION Application is used in association with athletic apparel, a connection with the USOPC would be presumed.

16. As Applicant is not connected with the USOPC, the OLYMPION Application should be rejected under Section 2(a) of the Lanham Act.

17. The OLYMPION Application should likewise be rejected under 15 U.S.C. §1052(d) as likely to cause confusion with the OLYMPIC and OLYMPIAN trademarks. The OLYMPION Application features the term OLYMPION used in association with athletic apparel.

18. The USOPC and its licensees have invested significant resources advertising and promoting goods and services under the OLYMPIC and OLYMPIAN trademarks. As such, consumers and others regard the USOPC as the origin of goods and services provided and sold under the OLYMPIC and OLYMPIAN trademarks. The OLYMPIC and OLYMPIAN marks are distinctive and have acquired fame and renown among consumers and the public at large well before Applicant's filing date.

19. Licensees of the USOPC are authorized to use its trademarks, including the OLYMPIAN trademark, on products related to sport and athletics, including in many cases athletic apparel and athletic uniforms.

20. Consumers are highly likely to assume that Applicant, which seeks to use and register the trademark OLYMPION in connection with athletic apparel and athletic uniforms, is a sponsor of the USOPC, or that the USOPC has otherwise endorsed Applicant, when the same is not true.

21. Upon information and belief, Applicant will sell its goods to the same types of consumers in the same channels of distribution as the USOPC and its licensees, including the general public. These consumers are familiar with, or actual purchasers or users of, goods and services offered or provided by the USOPC or its licensees under USOPC's Trademarks.

22. Accordingly, Applicant's use of the mark shown in the OLYMPION Application in connection with athletic apparel and athletic uniforms is likely to cause consumers mistakenly to believe that such goods are related to the USOPC or its licensees, or that such goods originate

from or are sponsored or approved by the USOPC. This confusion and mistake will cause injury to the USOPC.

23. Accordingly, registration for OLYMPION Application should also be refused under the provisions of Section 2(d) of the Trademark Act.

24. As a result of its long, extensive, and continuous use, as well other factors listed in Section 43(c) of the Lanham Act, the distinctive OLYMPIC and OLYMPIAN trademarks, prior to the filing date of the OLYMPION Application by Applicant, have become famous within the meaning of Section 43(c) of the Lanham Act.

25. Applicant's use of the mark shown in the OLYMPION Application will dilute the distinctive quality of the famous OLYMPIC and OLYMPIAN trademarks under Section 43(c) of the Lanham Act and injure the USOPC.

26. Registration of the mark shown in Application Serial No. 90/338,288 will result in damage to the USOPC under the provisions of the Ted Stevens Olympic and Amateur Sports Act, 36 U.S.C. § 220506 and 15 U.S.C. §§ 1052(a), 1052(d) and 1125(c), pursuant to the allegations stated above.

27. WHEREFORE, the USOPC requests that Application Serial No. 90/338,288 be rejected, that no registration be issued to Applicant, and that this opposition be sustained in favor of the USOPC.
