**NOTICE OF OPPOSITION**

Opposer, SLT IP Holdings, LP (“Opposer”), is U.S. limited partnership with an address at 330 West 34 Street, 15<sup>th</sup> Floor, New York, New York 10001, believes that it will be damaged by the registration of Application Serial No. 90/372,308 for the mark OUR TABLE (hereinafter “the Infringing Mark”) and hereby opposes registration of the mark to Liberty Procurement Co. Inc. (“Applicant”).

**BACKGROUND ON OPPOSER AND ITS “LAURA ASHLEY” MARK**

1. Opposer is a leading provider of a broad range kitchenware, bed & bath products, accessories, and other goods and services relating to a household brand.
2. Opposer is the owner of rights granted via federal registrations and common law rights for the mark “SUR LA TABLE.” (the “SUR LA TABLE Mark”).

The SUR LA TABLE Mark in French translates to ON THE TABLE in English.

3. Opposer and its predecessors in title have continuously used the SUR LA TABLE Mark in interstate commerce since at least as early as 1972 in connection with variety of goods and services.

4. Opposer has continuously used the SUR LA TABLE Mark in interstate commerce in connection with a variety of goods and services for many years, including, but not limited to, the goods and services covered by the registrations for the SUR LA TABLE Mark identified below, and other related registrations owned by Opposer over the years for the family of marks under the SUR LA TABLE Mark.

**OPPOSER OWNS MULTIPLE TRADEMARK & SERVICE MARK**

**REGISTRATIONS & APPLICATIONS FOR THE “SUR LA TABLE” MARK**

5. Opposer is the owner of multiple U.S. Trademark Registrations for the SUR LA TABLE Mark, including, but not limited to, the following U.S. Trademark Registrations pleaded in paragraphs 6 through 11 below.

6. Opposer is the owner of U.S. Trademark Registration No. 2,036,386 for the mark *Sur La Table* for “retail store services and mail order catalog services featuring kitchenware, cookware and the like bakeware and kitchen appliances textile fabrics” in International Class 42, registered February 11, 1997. This Registration is incontestable pursuant to Section 15 of the Lanham Act, 15 U.S.C. § 1065, and thus serves as conclusive evidence of the validity of Opposer’s “LAURA ASHLEY” mark pursuant to 15 U.S.C. § 1115(b).

7. Opposer is the owner of U.S. Trademark Registration No.

2,848,066 for the mark “SUR LA TABLE” for “Food products, namely, cooking and salad oils” in class 29 and “vinegar” in class 30 registered June 1, 2004. This Registration is incontestable pursuant to Section 15 of the Lanham Act, 15 U.S.C. § 1065, and thus serves as conclusive evidence of the validity of Opposer’s “LAURA ASHLEY” mark pursuant to 15 U.S.C. § 1115(b).

8. Opposer is the owner of U.S. Trademark Registration No. 2,594,235 for the mark “SUR LA TABLE” for “Retail store services, mail order catalog services, and internet catalog services, featuring foods, cutlery, kitchen gadgets, kitchen utensils, dinnerware, tableware, glassware, flatware, barware, housewares, table linens, kitchen towels, vases, storage containers, soaps and cleaning products, cookbooks, and household furnishings” in International Class 35 and “Educational services, namely, culinary school services” in International Class 41 registered July 16, 2002.

9. Opposer is the owner of U.S. Trademark Registration No. 3,073,426 for the mark “*Sur La Table*” for “Retail store services all featuring foods, cutlery, kitchen gadgets, kitchen appliances, kitchen utensils, kitchenware, dinnerware, tableware, cookware, bakeware, giftware, glassware, flatware, barware, housewares, table linens, kitchen towels, vases, storage containers, soaps and cleaning products, cookbooks, and household furnishings” in International Class 35 and “Educational services, namely, culinary school services” in International Class 41 registered March 28, 2006.

10. Opposer is the owner of U.S. Application No. 90/850,750 for the mark “SUR LA TABLE” for “Utensils, namely, spoons; forks; knives; vegetable slicers; non-electric peelers” in International Class 8; “Measuring cups; meat thermometers” in International Class 9; and, “Bowls; plates; pans; mugs; spatulas; skillets; cookware;



whisks; tongs; sieves; carafes; pitchers; fondue pots without heat; platters; oven mitts; ladles; garlic press; turners; citrus juicers; colanders; pizza stones” in International Class

21. This application was filed based on use dating back to as early as September 2017.

11. Opposer is the owner of U.S. Trademark Application No. 90/612,265 for the mark “SUR LA TABLE” for “Milk frothers; Food Blenders; Food Processors; Juicers; Vacuum food sealers” in International Class 7 and “Electric appliances, namely, Air Fryers, Air Fryer Toaster Steam Oven, Air Fryer Oven, Coffee Maker and Electric Digital Glass Kettle, Toasters, Panini presses, Waffle presses, Sandwich presses, Grills, Griddles, Oven Toasters, Convection Oven, Deep Fryer, Rotisseries, Kettles, Drip and Capsule (K-Cup, Nespresso, others) Coffee Machines, Electric Pressure Cooker, Slow Cooker, Multi Cookers, Induction Plates, Sous-Vide Machines, Sous-Vide Cookers, Bread Baking Machines, Ice Cream Makers; Food steamers” in International Class 11.

12. Copies of the foregoing U.S. Trademark Registrations & Applications for the SUR LA TABLE Mark are attached.

13. In addition to the registrations identified above, over the years, Opposer has owned other registrations for the SUR LA TABLE and SUR LA TABLE (Stylized) Marks in the United States.

**OPPOSER’S SUR LA TABLE MARK IS WIDELY RECOGNIZED AND**

**FAMOUS**

14. Opposer has made substantial sales of goods and services under its SUR LA TABLE Mark and has spent millions in highly successful advertising and promotional campaigns over the course of many years.

15. As a result of Opposer's long and continuous use of its SUR LA TABLE MARK and the unsolicited media coverage Opposer has been receiving over the past almost 50 years since its inception in 1972, consumers have come to associate the SUR LA TABLE Mark with the goods and services of Opposer.

**BACKGROUND ON APPLICANT AND ITS MARK**

16. By the Application filed on December 10, 2020, based on intent to use, Applicant seeks to obtain registration on the Principal Register of the trademark OUR TABLE for "Essentials oils" in class 3; "Hand-operated pineapple slicers and slicing wedgers; seafood shears; seafood mallets being kitchen hand tools" in class 8; "Poultry pop-up cooking timers" in class 9; "Cooking utensils, namely, turkey lacer kits comprising lacing pins, twine, and dressing recipe; cookware, namely, pots, pans, dutch ovens; knife blocks; hand-operated cookie presses; pie pan accessories in the nature of pie crust shields; non-electric milk frothers; pie pan accessories in the nature of pie weights; cooking utensils, namely, turkey lifters; nut choppers being nut crackers, terracotta tortilla warmers being dishes; hand-operated seafood shell crackers; seafood picks; nut milk bags being household strainers; drinking glasses" in class 21; "Table runners not of paper; pastry cloth" in class 24; and, "Bibs not of paper" in class 25

17. Since at least 1972, long before the filing date of the Application; Opposer has been, and still is engaged in the development, production, marketing and sale of textile goods, including but not limited to, household items, linens, kitchenware and many other accessories.

18. On information and belief, the goods identified in Application No. 90/372,308 represent services that will harm and injure the Opposer's goodwill and reputation.

19. If Applicant is permitted to register OUR TABLE, the registration will give Applicant a prima facie exclusive right to the use of Applicant's Mark for the goods set forth in the application. Such registration would damage and injure Opposer.

### **COUNT I**

#### **LIKELIHOOD OF CONFUSION**

20. Opposer repeats and realleges paragraphs 1-19 as paragraph 20 of this Count I.

21. Opposer's use and registration of its SUR LA TABLE Mark is long prior to the filing date of the opposed Application.

22. On information and belief, Applicant was aware of Opposer's SUR LA TABLE Mark at the time that Applicant filed his application.

23. Applicant's Mark is confusingly similar to Opposer's SUR LA TABLE Mark.

24. The goods identified in the Applicant's application are similar to Opposer's already cited registrations and pending applications.

25. Due to at least the similarity of the marks and goods and services involved, and other factors, Applicant's use and registration of Applicant's Mark will inevitably lead to confusion, to mistake, or to deception of the public within the meaning of Section 2(d) of the Lanham Act, 15 USC § 1052(d), all to

Opposer's grave and irreparable damage.

26. Registration of Applicant's Mark should be denied based on a likelihood of confusion with Opposer's prior SUR LA TABLE Mark, in violation of Section 2(d) of the Lanham Act, 15 USC § 1052(d).

## **COUNT II**

### **DILUTION**

27. Opposer repeats and realleges paragraphs 1-26 as paragraph 27 of this Count II.

28. As a further ground for the opposition, Opposer's SUR LA TABLE Mark, which has been in use in commerce for almost fifty years, and registered for more than twenty-four years, is famous within the meaning of Lanham Act Section 43(c), 15 USC § 1125(c).

29. Opposer's SUR LA TABLE Mark became famous prior to the filing date of the application for Applicant's Mark and prior to any use or any use in commerce by Applicant of Applicant's Mark, OUR TABLE, as a trademark, service mark, or trade name.

30. Registration of Applicant's Mark is likely to cause dilution of Opposer's SUR LA TABLE Mark, to the injury of Opposer, by diluting the distinctiveness of Opposer's SUR LA TABLE Mark and lessening the capacity of Opposer's SUR LA TABLE Mark to identify and distinguish Opposer's goods and services, in violation of Section 43(c) of the Lanham Act, 15 USC § 1125(c).

31. Registration of Applicant's Mark should be denied based on a likelihood of dilution of the distinctive quality of Opposer's famous SUR LA

TABLE Mark, in violation of Section 43(c) of the Lanham Act, 15 USC §  
1125(c).

WHEREFORE, Opposer respectfully prays that this Notice of Opposition  
be sustained, and that the registration of Application Serial No. 90/372,308 be rejected,  
and that the registration of the trademark therein sought, for the services therein  
specified, be denied and refused.
