NOTICE OF OPPOSITION

Viacom International Inc., a Delaware corporation with a principal place of business at 1515 Broadway, New York, New York, 10036 ("Opposer"), believes that it will be damaged by the registration of application Ser. No. 90/031,519 filed on July 1, 2020 by Freck Yourself, Inc. ("Applicant") for the mark CHEEKSLIME covering "*Cheek tint; lip tint*" in International Class 3 ("Alleged Mark" or "Application") and, having previously been granted extensions of time to oppose, hereby opposes same.

The specific grounds for this opposition are as follows:

A. Opposer Viacom International Inc.

- 1. Opposer's parent company, ViacomCBS Inc., is a premier global media company that develops, creates and provides entertainment content, services and related branded products.
- 2. Through ViacomCBS Domestic Media Networks and ViacomCBS Networks International, Opposer operates the world-famous Nickelodeon television network ("Nickelodeon"). Nickelodeon was launched in 1979 and is a recognized leader in kids and family entertainment. Nickelodeon has been the number-one-rated advertising-supported basic cable network for 24 consecutive years.
- 3. Nick Jr., Nicktoons, TeenNick and Nick at Nite are prominent television channels and/or segments related to Nickelodeon (Nickelodeon, Nick Jr., Nicktoons, TeenNick and Nick at Nite, collectively, "Nick Channels"). In September 2019, Nickelodeon's channel portfolio reached approximately 1.1 billion cumulative television subscribers in 179 countries worldwide, excluding branded programming blocks.
- 4. Beginning in the 1980s, Nickelodeon adopted SLIME as a featured entertainment element in several game shows it produced and used it heavily in marketing and promoting such game shows. SLIME was a featured part of the show *Double Dare*, which was originally produced by Nickelodeon from 1986 through 1993, and spawned a number of spin-offs and reboots, the most recent of which premiered in June 2018. In June 2013, *TV Guide* named *Double Dare* one of the 60 greatest game shows of all time. A true and correct printout of the TV Guide's website located at <www.tvguide.com/news/greatest-game-shows-1066568> showing a list of the 60 greatest game shows of all time is attached as **Exhibit A**.
- 5. SLIME was also featured on the Nickelodeon game shows *Slime Time Live*, *Wild and Crazy Kids*, and *Figure it Out*.

- 6. SLIME continues to be used in connection with the *Nickelodeon Kids' Choice Awards*, where over 11,000 gallons of SLIME are used for stunts or dumped on celebrities in various ways each year.
- 7. Opposer also uses the mark SLIME, and variants thereof, extensively in its domestic and international licensing and merchandising programs to promote its use in connection with its television programming. Through its carefully selected licensees, Opposer has manufactured, created, sold and/or offered numerous products and services under the SLIME mark, and variants thereof, including, but not limited to, free-flowing play gel, board games, computer games, clothing, shampoo, and beauty products.
- 8. Opposer's rights in the United States in the SLIME mark include Registration No. 6,043,163 for NICKELODEON SLIME covering "body care products, namely, body lotion, shower gel, hair shampoo, hair conditioner, non-medicated lip balm and non-medicated liquid soap; toothpaste" in International Class 3, based on a first use in commerce of December 2019 (the "163 Registration").
- 9. In addition to the '163 Registration, Opposer owns each of the trademarks shown in the chart below, as well as the federal registrations and pending applications identified therein (the '163 Registration together with the marks shown in the chart below, collectively, the "SLIME Marks").

The above-referenced registrations and pending applications are valid, subsisting, and in full force and effect, and the registrations and applications serve as *prima facie* evidence of the validity of the SLIME Marks and of Opposer's exclusive right to use the SLIME Marks on the goods and services listed in the registrations and applications. Further,

the Registration 2,206,408 and Registration No. 3,845,627 are incontestable pursuant to 16 U.S.C. § 1065.

- 10. The SLIME Marks are prominently featured in advertising, marketing, and promotional materials for Opposer's goods and services. In the last three years, Opposer or its licensees have spent over \$5,000,000 to advertise and promote the goods and services bearing the SLIME Marks. As a result of these efforts and extensive usage, Opposer's SLIME Marks represent an asset of enormous goodwill of inestimable value that belongs exclusively to Opposer..
- 11. Opposer has used and/or applied to register its SLIME Marks in connection with various goods and services, including, but not limited to, entertainment services, freeflowing play gel, board games, computer games, shampoo, beauty products, and other related merchandise ("Opposer's Goods and Services"), since long prior to the filing and/or priority date of the Application and, upon information and belief, since long prior to any use of the Alleged Mark in interstate commerce by Applicant.
- 12. Opposer's SLIME Marks are distinctive and became famous long prior to the filing and/or priority date of the Application and, upon information and belief, long prior to any use of the Alleged Mark in interstate commerce by Applicant.
- 13. As a result of the long, extensive and widespread use, advertising and registration of Opposer's SLIME Marks in association with Opposer's Goods and Services, consumers have become accustomed to associate marks that consist of or contain the term SLIME with Opposer.

B. Applicant Freck Yourself, Inc.

14. On July 1, 2020, Applicant, a Delaware corporation with an address at 33766 Glendale Blvd. Los Angeles, California 90039, filed the Application pursuant to Section 1(a) of

the Lanham Act to register the Alleged Mark and claimed a date of first use in commerce at least as early as January 6, 2020.

- 15. Applicant seeks to register the Alleged Mark for "check tint; lip tint" in International Class 3 ("Applicant's Goods").
- 16. The Application was filed without Opposer's authorization, consent, or prior knowledge.

COUNT I LIKELIHOOD OF CONFUSION

- 17. Opposer repeats and realleges each and every allegation set forth in paragraphs 1–16 hereof as if fully set forth herein.
- 18. Opposer's SLIME Marks are highly distinctive in relation to Opposer's Goods and Services and, due to the extensive distribution and success of Opposer's Goods and Services bearing Opposer's SLIME Marks over a period of over 40 years, are famous in the United States and throughout the world.
- 19. Opposer has used, registered, and/or applied to register the SLIME Marks long prior to the filing and/or priority date of the Application and, upon information and belief, long prior to any use of the Alleged Mark in interstate commerce by Applicant, giving Opposer priority in the rights to the SLIME Marks over Applicant.
- 20. The Alleged Mark so resembles Opposer's aforementioned previously used, registered and/or applied for SLIME Marks to be likely, when used in connection with Applicant's Goods, to cause confusion, to cause mistake, or to deceive, with consequent injury to Opposer and the public.
- 21. Specifically, and without limitation, the marketing and sale of Applicant's Goods under the Alleged Mark is likely to cause consumers to believe that Applicant's Goods are those

of Opposer, that Applicant's Goods are connected with Opposer's Goods and Services, and/or that Applicant is somehow related to or sponsored by Opposer.

22. Accordingly, the Alleged Mark is not entitled to registration pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

COUNT II DILUTION

- 23. Opposer repeats and realleges each and every allegation set forth in paragraphs 1–22 hereof as if fully set forth herein.
- 24. Opposer's SLIME Marks are highly distinctive in relation to Opposer's Goods and Services and, due to the extensive distribution and success of Opposer's Goods and Services bearing Opposer's SLIME Marks over a period of over 40 years, are famous in the United States and throughout the world.
- 25. Opposer's SLIME Marks became famous long before the filing and/or priority date of the Application and, upon information and belief, long prior to any use of the Alleged Mark in interstate commerce by Applicant.
- 26. Relevant consumers are likely to make an association between the Alleged Mark and Opposer's SLIME Marks.
- 27. The Alleged Mark is likely to dilute the distinctive quality of Opposer's SLIME Marks by blurring.
- 28. Thus, registration or use of the Alleged Mark is likely to cause dilution of the distinctive quality of Opposer's SLIME Marks in violation of Section 43 of the Lanham Act, 15 U.S.C, § 1125, causing injury to Opposer.

WHEREFORE, Opposer prays that this Notice of Opposition be sustained and that the registration sought by Applicant be denied.
