NOTICE OF OPPOSITION

G-III Leather Fashions, Inc. (“Opposer”) believes that it will be damaged by registration of the mark GOT YO BASS (“Applicant’s Mark”) by Got Yo Bass Fishing Co., LLC (“Applicant”) shown in Serial No. 90266150 in Class 25 for “Hats; Shirts; Boot gaiters; Leg gaiters; Neck gaiters” (the “Application”) and hereby opposes same on the following grounds:

1. Opposer is a New York corporation and operates in New York.
2. Since at least as early as 1879, Opposer, its affiliated entities, licensees and predecessors-in-interest, have used in commerce the well-known marks BASS, G.H. BASS, G.H. BASS & CO. and other marks comprised of the word “BASS” (collectively, “Opposer’s BASS Marks”) in connection with apparel, footwear, bags, eyewear, and other accessories and retail store services selling these goods.
3. Opposer’s BASS Marks are the subject of numerous federal registrations in connection with its goods and services, including:

4. Opposer has extensively used and promoted Opposer's BASS Marks in connection with apparel, footwear, bags, eyewear and other accessories, retail store services and other related offerings and as a result has developed valuable and substantial goodwill in such marks.

5. Opposer's registrations and use of the Opposer's BASS Marks commenced well prior to the filing date of Applicant's Mark, or any other date on which Applicant is permitted to rely.

6. Certain of Applicant's Class 25 goods as set forth in the Application are identical or related to the goods offered for sale and services rendered by Opposer under Opposer's BASS Marks, namely hats and shirts.

7. Applicant's use and registration of Applicant's Mark in connection with the indicated goods is likely to cause confusion or mistake as to whether Applicant is in some way affiliated or connected with Opposer, or that Opposer has sponsored Applicant or its goods. Therefore, the granting of a certificate of registration to Applicant would damage Opposer.

WHEREFORE, Opposer prays that the opposition be sustained, that Application Serial No. 90266150 be rejected and that registration of the Application for the mark denied.
