**NOTICE OF OPPOSITION**

Barefoot Dreams, Inc. (“Opposer”), a corporation organized and existing under the laws of the State of California, with its principal place of business located at 5302 Derry Avenue, Unit D, Agoura Hills, California 91301, believes that it will be damaged by the registration of the mark “COZY WAFFLE” (“Applicant’s Mark”) for the goods claimed in Application Serial No. 90/477815 (the “Application”), of Komar Layering, LLC, a limited liability company of New York, with a principal place of business located at 90 Hudson Street, Jersey City, New Jersey, 07302 filed on January 20, 2021 which application was published in the Official Gazette of September 14, 2021 and hereby opposes registration of the Application under the provisions of Section 13 of the Trademark Act of 1946, 15 U.S.C. §1063.

As grounds for opposition, Opposer alleges the following:

1. Opposer is the owner of all right, title, and interest in and to the trademarks THE COZY, COZYCHIC, COZYCHIC LITE, COZYCHIC ULTRA LITE, COZYCHIC LUXE and trademarks and service marks comprised thereof, which COZY formative marks Opposer has used since at least as early as August 2002 in connection with infant's and children's bed blankets and infant's and children's clothing, namely, baby bunting, cloth baby bibs, bonnets, booties, coveralls, creepers, head wear, jackets, mittens, nightgowns, pajamas, panties, pants, pullovers, robes, rompers, shirts, shorts, slippers, swaddling clothes, T-shirts, tops at least as early as November 2002 in connection with men's and women's robes and in connection with men's, women's and children's wearing apparel, namely, sweaters, hooded pullovers, ponchos, shawls shorts, wearable blankets in the nature of blankets with sleeves, wraps, coverups, zip-up hoodies, robes and cardigans since at least at least as early as December 2003 and in connection with blanket throws; pillow covers; throws; jackets; clothing wraps and shoulder wraps for children.
2. Opposer is the owner of the following U.S. trademarks (the "COZY" Registrations"), which are valid, subsisting and in the case of registration numbers 2,848,767; 2,961,872 and 4,699,932, incontestable.

In accord with 37 CFR § 2.122(d), copies of the registration certificates for the “COZY” and Registrations are attached to this Notice of Opposition as Exhibit A.

3. Opposer’s registrations listed above provide evidence of Opposer’s ownership of the COZY Marks, of the validity of the marks, and of Opposer’s exclusive right to use the marks in commerce in connection with the goods identified in the registrations (the “COZY Goods”).

4. Opposer’s COZY Marks have been continuously and extensively used, advertised and promoted in commerce in connection with the COZY Goods at least as early as 2002, well before, the applicant’s January 20, 2021 filing date of the intent to use application for the identified goods.

5. As a result of Opposer’s widespread use, advertising, and promotion of its COZY Marks in connection with the COZY Goods, such marks have become distinctive indicators of the origin of Opposer’s goods. Opposer’s COZY Marks have acquired a favorable reputation among

relevant members of the purchasing public and have become valuable symbols of Opposer's goodwill.

6. Notwithstanding Opposer's prior rights in the COZY Marks in connection with the COZY Goods, on January 20, 2021, Applicant filed the Application in the United States Patent and Trademark Office for registration of Applicant's Mark, for "underwear; baselayer bottoms; baselayer tops; bottoms as clothing; camisoles; chemises; clothing wraps; footwear; gloves; headwear; hosiery; jackets; leg-warmers; leggings; lingerie; long underwear; loungewear; neckwear; pajamas; pants; robes; shirts; sleepwear; slipper socks; slippers; socks; T-shirts; thermal underwear; tops as clothing; undergarments; undershirts, in Class 25, ("Applicant's Goods").

7. The Opposer's commercial products include men's and women's robes in class 25 sold under the mark COZYCHIC, the subject of incontestable registration number 2,961,872 as well as men's, women's and children's wearing apparel, namely, sweaters, hooded pullovers, ponchos, shawls shorts, wearable blankets in the nature of blankets with sleeves, wraps, coverups, zip-up hoodies, robes and cardigans in class 25 also sold under the registered mark COZYCHIC subject of incontestable registration number 4,699,92 and baby bunting; beachwear; bonnets; booties; cardigans; children's and infant's apparel, namely, jumpers, overall sleepwear, pajamas, rompers and one-piece garments; coveralls; coverups; creepers; headwear; hooded pullovers; hooded sweatshirts; jackets; loungewear; mittens; panties; pants; ponchos; pullovers; robes; shawls; shirts; shorts; slippers; socks; swaddling clothes; sweaters; T-shirts; tops; wearable blankets in the nature of blankets with sleeves; shoulder wraps for clothing in class 25 all sold under the registered marks COZYCHIC LITE and COZYCHIC ULTRA LITE. The term "COZY" is so closely identified with the Opposer that an article that appeared in *The New York Times* on March 19, 2021 entitled "Barefoot Dreams and the Conquest of Cozy" referenced the renown of

the Petitioner's goods, including through influential figures such as Oprah Winfrey, Khloé Kardashian, Kate Hudson and Chrissy Teigen. *The New York Times* article reflects the renown and wide spread recognition of the Opposer and Opposer's clothing items in connection with the word COZY.

8. Applicant knew of Opposer's prior rights in the COZY Marks for the goods similar to those of the Applicant, namely, underwear; baselayer bottoms; baselayer tops; bottoms as clothing; camisoles; chemises; clothing wraps; footwear; gloves; headwear; hosiery; jackets; leg-warmers; leggings; lingerie; long underwear; loungewear; neckwear; pajamas; pants; robes; shirts; sleepwear; slipper socks; slippers; socks; T-shirts; thermal underwear; tops as clothing; undergarments; undershirts, in class 25.

## COUNT I

### **Likelihood of Confusion - §2(d)**

9. Opposer re-alleges and incorporates by reference the allegations contained in paragraphs 1 through 8, above, as if set forth in their entirety herein.

10. Applicant's Mark COZY WAFFLE so closely resembles Opposer's Marks in appearance, sound and meaning and commercial impression that the use and registration thereof by Applicant of the mark COZY WAFFLE is likely to cause confusion, mistake, and deception as to the source or origin of Applicant's Goods and will injure and damage Opposer and the goodwill and reputation symbolized by Opposer's COZY Marks.

11. Applicant's Goods, if offered under or by reference to Applicant's Mark, are closely related to or identical to the goods provided by Opposer under and by reference to the COZY Marks, including as identified in paragraph 7, above, that relevant consumers and others are likely to be confused, to be deceived, and to assume erroneously that Applicant's Goods are

those of Opposer or that Applicant is in some way connected with, sponsored by or affiliated with Opposer, all to Opposer's irreparable damage and injury.

12. Likelihood of confusion, mistake and deception is enhanced by the fact that certain of Opposer's goods offered under and by reference to the COZY marks are offered, provided or intended to be provided to the same class of prospective customers as are Applicant's Goods claimed in the Application.

13. The Applicant sells its goods under the Applicant's marks on the QVC home shopping network. The Opposer also sells goods through the televised home shopping network QVC. Registration of the Applicant's mark in connection with the Applicant's goods, which will also likely to be sold on the QVC home shopping network, increases the circumstances under which the goods of the respective parties will directly compete for the same consumer and greatly enhances the possibility of a likelihood of confusion between the Opposer and the Applicant.

14. The Opposer currently sells a series of clothing items under its registered marks COZYCHIC and COZYCHIC LITE that include the terms WAFFLE BEANIE, WAFFLE THROW, WAFFLE COWL TUNIC, WAFFLE COCOON CARDIGAN. These items are available on the QVC home shopping network. Registration of the Applicant's mark COZY WAFFLE, more specifically the use and registration of COZY with the term WAFFLE on goods which are similar and in some cases identical to the Opposer's goods and which in all likelihood, will also be available on the QVC shopping network is likely to lead to consumer confusion as to the source of the goods of the Opposer and the Applicant.

15. Under the circumstances, registration of Applicant's Mark is likely to cause Opposer to lose control over the good and valuable reputation represented by and derived from its COZY Marks and their use in relation to goods closely related to Applicant's Goods.

16. Registration of Applicant's Mark, in light of Opposer's prior rights in its COZY Marks, is therefore likely to cause confusion, mistake and/or deception among members of the relevant purchasing public, resulting in damage and injury to Opposer in violation of the provisions of Section 2(d) of the Trademark Act. 15 U.S.C. §1052(d).

The required fee has been provided.

WHEREFORE, Opposer prays that this opposition be sustained and that the Board deny registration to the Application.
