**NOTICE OF OPPOSITION**

Opposer Pacific Sunwear of California, LLC ("Opposer"), a California liability company, with an address of 3450 E Miraloma Ave., Anaheim, California 92806, believes that it will be damaged by registration of U.S. Trademark Application Serial No. 90/503,209, filed in the name of Pashun Products Ltd ("Applicant"). As grounds for the opposition, Opposer, by and through its undersigned counsel, alleges the following:

1. Applicant filed U.S. Trademark Application Serial No. 90/503,209 for "PASHUN LIFESTYLE" ("Applicant's PASHUN Mark") on February 1, 2021, for use in connection with "backpacks especially adapted for holding laptops," in Class 9 ("Applicant's Goods").
2. U.S. Trademark Application Serial No. 90/503,209 was filed on the basis of an intent to use the mark in commerce under Section 1(b), and proof of use has not yet been submitted.
3. U.S. Trademark Application Serial No. 90/503,209 published for opposition on October 5, 2021.

4. On October 12, 2021, Opposer filed a First 30 Day Request for Extension of Time to Oppose, which was granted until December 4, 2021.

5. Opposer's filing of this Notice of Opposition is timely pursuant to 37 C.F.R. § 2.101.

6. Opposer is the owner of the U.S. Trademark/Service Mark Registration No. 4,119,420 for "PACSUN" filed on December 21, 2010 and registered on March 27, 2012, with a first use in commerce date of at least as early as October 21, 1987 for "clothing, namely, shirts, t-shirts, woven shirts, flannel shirts, knit tops, tank tops, dresses, skirts, sweatshirts, sweat pants, pants, jeans, leggings, shorts, jackets, sweaters, pajamas, under garments, swim suits, swim wear, scarves, shawls, belts, gloves, mittens, socks; footwear, namely, casual footwear, athletic footwear, shoes, sandals, slippers, boots, beach footwear; headgear, namely, hats, caps, visors, beanies and head bands" in Class 25 and a first use in commerce date of at least as early as November 27, 1999 for "retail store and online retail store services in the fields of clothing, headwear, footwear, bags, cosmetics, eyewear, watches, jewelry, skateboards and consumer electronics" in Class 35.

7. Opposer is the owner of the U.S. Trademark Mark Registration No. 4,537,517 for "PACSUN" filed on October 16, 2013 and registered on May 27, 2014, with first use in commerce dates of at least as early as October 1, 2013 for "eyewear; sunglasses" in Class 9.

8. Opposer is the owner of the U.S. Service Mark Registration No. 2,579,269 for "PACSUN.COM" filed on May 7, 1999 and registered on June 11, 2002, with a first use in commerce date of at least as early as June 17, 1999 for "on-line retail store services featuring clothing and sports apparel" in Class 35.

(copies of Registration Certificates and TSDR status reports attached at Exhibit 1.) These marks and registrations collectively referred to as ("Opposer's PACSUN Marks").

9. Opposer's PACSUN Marks are inherently distinctive.
10. Opposer has used its "PACSUN" mark since at least as early as October 21, 1987, and is currently using its "PACSUN" mark in commerce in the United States in connection a wide variety of clothing products.
11. Opposer has used its "PACSUN" mark since at least as early as November 27, 1999, and is currently using its "PACSUN" mark in commerce in the United States in connection with retail store services and online retail store services featuring bags.
12. Opposer has used its "PACSUN" mark since at least as early as October 1, 2013, and is currently using its "PACSUN" mark in commerce in the United States in connection eyewear and sunglasses.
13. Opposer has used its "PACSUN.COM" mark since at least as early as June 17, 1999, and is currently using its "PACSUN.COM" mark in commerce in the United States in connection with on-line retail store services featuring clothing.
14. Opposer has used one or more of Opposer's PACSUN Marks in commerce in the U.S. in connection with clothing products, bags and retail store services featuring bags since prior to Applicant's February 1, 2021 filing date of U.S. Trademark Application Serial No. 90/503,209.
15. Opposer has devoted substantial time, money, and effort in establishing and maintaining a high standard of quality for goods provided under Opposer's PACSUN Marks.
16. Opposer's PACSUN Marks have become widely and favorably known to the public in connection with bags, clothing products, and retail store services featuring bags and clothing products, and Opposer has developed substantial goodwill and recognition in Opposer's PACSUN Marks.

17. Opposer has standing to oppose U.S. Trademark Application No. 90/503,209 based on Opposer's ownership of Opposer's PACSUN Marks.

18. Upon information and belief, Applicant has not yet started using Applicant's PASHUN Mark in the U.S.

19. If Applicant has started using Applicant's PASHUN Mark in the U.S., upon information and belief, Opposer has used continuously, until the present time, one or more of Opposer's PACSUN Marks in commerce in the U.S. in connection with clothing products, bags, and retail store services featuring bags and clothing products since prior to Applicant's first use of Applicant's PASHUN Mark.

20. There is no issue as to priority as the applications for Opposer's PACSUN Marks were filed and registered prior to Applicant's filing of U.S. Trademark Application Serial No. 90/503,209 for Applicant's PASHUN Mark, and Opposer's first use dates for Opposer's PACSUN Marks are earlier than the filing date listed in U.S. Trademark Application Serial No. 90/503,209 for Applicant's PASHUN Mark.

21. Applicant's PASHUN Mark is similar in sound, appearance and overall commercial impression to Opposer's PACSUN Marks.

22. The goods covered in U.S. Trademark Application Serial No. 90/503,209 are highly related to, if not identical to, the goods and services covered in the U.S. Registrations for Opposer's PACSUN Marks.

23. Consumers are likely to mistakenly believe that Applicant's Goods are sponsored by, authorized by, endorsed, affiliated with, or otherwise approved by Opposer because Applicant's PASHUN Mark is confusingly similar to Opposer's PACSUN Marks.

24. Applicant's PASHUN Mark is likely to cause confusion, mistake, or deception in the minds of prospective purchasers as to the origin or source of Applicant's Goods due to the similarity in the marks, goods, services, consumers, channels of trade, and other factors between Applicant's PASHUN Mark and Opposer's PACSUN Marks.

25. Applicant's use of Applicant's PASHUN Mark is without Opposer's consent or authorization.

26. Opposer will be damaged by the registration of U.S. Trademark Application Serial No. 90/503,209 and registration should be refused under 15 U.S.C. 1052(d) because Opposer has earlier U.S. registrations, has priority of use, and confusion is likely.

WHEREFORE, Opposer prays that registration of the mark in U.S. Trademark Application Serial No. 90/503,209 be refused, and that this Opposition be sustained in favor of Opposer.
