**APPLICANT’S RENEWED CONSENTED MOTION
TO AMEND THE DEFINED BROW STUDIO MARK**

Pursuant to Trademark Rule 2.133(a), 37 C.F.R. § 2.133(a), and TBMP §§ 514, 605.03(b), Applicant, Rubi Arreola (“Applicant”), and Opposer, Anastasia Beverly Hills, LLC (“Opposer”), through their attorneys, hereby stipulate and agree as follows:

1. Applicant sought to register DEFINED BROW STUDIO in International Class 044 for Beauty treatment services especially for eyebrows; Cosmetic and body procedures, namely, fibroblasting, micropigmentation, cavitation, and microblading; Cosmetic eyebrow care services in the nature of waxing, brow tint, henna, and ombré; Cosmetic skin care services, namely, waxing, facials, brow shaping, brow tints, brow lifts, and brow laminations; Cosmetic tattooing services; Eyelash services, namely, lash extensions, lash lifts, and lash perms; Face and body waxing services; Microblading being eyebrow tattooing services; Salon services, namely, brow and eyelash tinting, body waxing, facial waxing, makeup services, and makeup application services; Tattooing services; Tattooing and permanent makeup services.

2. Opposer owns U.S. Registration No. 2949230 for the mark BROW STUDIO in International Class 044 for beauty salon services, namely hair removal, dressing and styling.

3. On December 15, 2021, Opposer filed a notice of opposition alleging priority and that Applicant’s use and registration of the applied-for mark DEFINED BROW STUDIO would

likely cause confusion with Opposer's registered BROW STUDIO mark.

4. Applicant and Opposer, through their counsels of record, met and conferred and mutually agreed to a settlement whereby Applicant would request the Board to allow an amendment of Applicant's standard character mark from DEFINED BROW STUDIO to DEFINED BROW.

5. Applicant therefore requests the Board to accept Applicant's amendment of its mark from DEFINED BROW STUDIO to DEFINED BROW. Attached as Exhibit A is a copy of Applicant's substitute drawing page. Applicant also requests the Board to allow the amendment of the filing basis for Application Serial No. 90227452 from use in commerce (Section 1(a)) to intent to use (Section 1(b)). Attached as Exhibit B is a verified statement that Applicant has a bona fide intention to use the mark in commerce on or in connection with the services of the subject application and that she has a bona fide intention to use the mark in commerce on or in connection with the services as of the application filing date.

6. Applicant further requests the Board to accept Applicant's amendment of its recitation of services from:

Beauty treatment services especially for eyebrows; Cosmetic and body procedures, namely, fibroblasting, micropigmentation, cavitation, and microblading; Cosmetic eyebrow care services in the nature of waxing, brow tint, henna, and ombré; Cosmetic skin care services, namely, waxing, facials, brow shaping, brow tints, brow lifts, and brow laminations; Cosmetic tattooing services; Eyelash services, namely, lash extensions, lash lifts, and lash perms; Face and body waxing services; Microblading being eyebrow tattooing services; Salon services, namely, brow and eyelash tinting, body waxing, facial waxing, makeup services, and makeup application services; Tattooing services; Tattooing and permanent makeup services

to:

Beauty treatment services especially for eyebrows; Cosmetic and body procedures, namely, fibroblasting, micropigmentation, cavitation, and microblading; Cosmetic eyebrow care services in the nature of waxing, brow tint, henna, and ombré; Cosmetic skin care services, namely, waxing, facials, brow shaping, brow tints, brow lifts, and brow laminations; Cosmetic tattooing services; Eyelash services, namely, lash extensions, lash lifts, and lash perms; Face and body waxing services; Microblading being eyebrow tattooing services; Salon services, namely, brow and eyelash tinting, body waxing, facial waxing, makeup services, and makeup application services; Tattooing services; Tattooing and permanent makeup services; **all of the foregoing offered in a beauty studio**

7. Opposer will withdraw its opposition against Applicant's application if the Board amends the applied-for mark from DEFINED BROW STUDIO to DEFINED BROW.

LEGAL STANDARD FOR AMENDMENT OF A MARK

8. 37 C.F.R. §2.72(b) states that in the context of an application based on a bona fide intent to use the mark in commerce, Applicant may amend the description or drawing of the mark if the amendment does not materially alter the mark.

9. The Board's test for determining whether a proposed amendment to a mark is immaterial is, briefly, "[t]he old and new forms of the mark must create the same general commercial impression or create the impression of being essentially the same mark."¹

APPLICANT'S PROPOSED AMENDMENT OF THE MARK DOES NOT CONSTITUTE A MATERIAL ALTERATION OF THE MARK

10. As stated above, an amendment to a mark will be accepted if the change to the mark

does not materially alter the mark as filed in the initial application.

11. The Trademark Manual of Examining Procedure (TMEP) has specific provisions related to the removal or deletion of matter from drawing.

12. Under TMEP § 807.14, “nondistinctive matter may be deleted [] if it does not constitute a material alteration. For example, the deletion of the generic name of the goods or services would not generally be considered a material alteration, **unless** it was so integrated into the mark that the deletion would alter the commercial impression” (emphasis added).

13. Under TMEP § 807.14, the conjunctive adverb “However” signals that although “Deletion of matter from the mark can result in a material alteration,” “highly stylized display features of [a] mark” such as those at issue in *In re Dillard Dep’t Stores, Inc.* 33 USPQ2d 1052 (Comm’r Pats. 1993) must be evaluated differently than nondistinctive matter. Accordingly, the decision in *In re Dillard Dep’t Stores, Inc.* has no applicability to the deletion of nondistinctive matter from a mark.

14. Under TMEP § 807.14, the deletion of the generic name of goods or services is generally not considered a material alteration. And, in some circumstances, other types of nondistinctive matter may be deleted if the overall commercial impression is not altered.

15. The component “STUDIO,” which Applicant disclaimed during the examination of the application, is nondistinctive matter. As evidence of the nondistinctiveness of “STUDIO” within the applied-for mark:

- (a) During the examination of U.S. App. Serial No. 90227452, the Trademark Examining Attorney presented evidence that “STUDIO is defined as ‘an artist’s workroom’ in ahdictionary.com . . . the mark indicates to the consumer that the services offered by the applicant . . . are offered in an ‘artist’s workroom’ with the artist in this instance being an eyebrow

designer/artist.” This evidence was the basis for Applicant’s accepting a disclaimer of exclusive rights in STUDIO apart from the applied-for mark as a whole.

- (b) During the examination of U.S. App. Serial No. 90227452, the Trademark Examining Attorney advised Applicant that “if the application is amended to seek registration on the Principal Register under Trademark Act Section 2(f) or on the Supplemental Register, applicant will be required to disclaim ‘BROW STUDIO’ because such wording appears to be generic in the context of applicant’s services.”
- (c) Even after Applicant submitted a Section 2(f) claim with respect to DEFINED BROW STUDIO, she was still required to disclaim “BROW STUDIO.”
- (d) The word “STUDIO(S)” has been disclaimed in nearly 100 active U.S. registrations covering beauty services in International Class 44. Representative examples of these registrations are attached at Exhibit C.
- (e) The word “studio(s)” appears within the recitations of services of numerous registrations for services that are the same as or legally identical to the services identified in U.S. App. Serial No. 90227452. Representative examples of these registrations are attached at Exhibit D.
- (f) “Tattoo studios” appears in the TMID Manual (Term ID 044-646).
- (g) In *In re Averi Skye Enterprise, LLC*, Serial No. 87830306 (June 22, 2020) [not precedential], the Board held “the additional wording in the mark[], WAXING STUDIO . . . is highly descriptive if not generic and has been disclaimed.”

16. To further reinforce the nondistinctive nature of “STUDIO” with respect to the applied-for services, Applicant requested the amendment of her recitation of services to include **all of the foregoing offered in a beauty studio.**

17. The component “STUDIO” is not integrated into the mark. As evidence that “STUDIO” is not integrated *into* the mark:

- (a) “STUDIO” appears at the end of the mark.
- (b) Applicant uses a logo with a d and B, but no s:



- (c) As set forth in the application’s prosecution history, “the term DEFINED in the mark means ‘to make distinct, clear, or detailed especially in outline’ according to merriam-webster.com” and “BROW is defined in merriam-webster.com as ‘eyebrow.’” The Trademark Examining Attorney therefore concluded that “[t]he combination of these terms in the mark indicates to the consumer that the services offered by the applicant feature eyebrow services that make the eyebrows distinct, clear, or detailed.” In other words, DEFINED is an adjective that describes BROW, not STUDIO or BROW STUDIO and, therefore, *with respect to the applied-for services*, STUDIO is a separable element that is not connected in meaning to DEFINED or DEFINED BROW.

18. Because beauty services are personal services that must be offered in person *somewhere*, the inclusion of STUDIO within the applied-for mark is tantamount to the inclusion of RESTAURANT for restaurant services or SCHOOL for educational services.

19. The commercial impression of DEFINED BROW STUDIO is services provided by a cosmetician to provide definition to one's eyebrows at a physical location. The commercial impression of DEFINED BROW is services provided by a cosmetician to provide definition to one's eyebrows. The inclusion of the generic or highly-descriptive *type* of physical location *where* the services are provided does not affect a consumer's recollection of *who* provides the services.

20. The *In re Hacot-Colombier*, 14 USPQ2d 1523 (Fed. Cir. 1997) decision does not apply to this motion because the Federal Circuit evaluated the *addition* of matter to a mark, not the *deletion* of matter from a mark.

21. The Board's decision in *In re Larios S.A.*, 35 USPQ2d 1214 (TTAB 1995) supports the non-materiality of the proposed amendment. The Board stated "[t]he material alteration test, as is apparent from the above, is not quite as rigorous as the substantially exact representation standard and thus allows for a bit more leeway or flexibility with respect to permissible change in a mark and the concomitant amendment of the drawing thereof." Relying on the flexibility of the material alteration test, the Board allowed the applicant to *substitute* the Spanish-language equivalent of "WINE OF" for "GREAT WINE" because, as a result of "the high degree of descriptiveness (and resultant lack of distinctiveness) inherent in the phrases 'GRAN VINO' and 'VINO DE,'" the substitution "changes nothing *of trademark significance*" (emphasis added). *Id.* at 1217-18. The intended flexibility of the material alteration standard is further reinforced by the Board's comparison of "GRAN VINO" and "VINO DE": "Such words, in terms of the trademark import or source-identifying capacity which they project as typically employed on labels for wine, are analogous to the common designations 'TABLE WINE' and 'FINE WINE'. Admittedly, the

meanings are different, but the differences in trademark significance, if any, are inconsequential.”
Id. at 1218, n.8.

22. Because, whether highly descriptive or generic, “STUDIO” is nondistinctive matter that is not integrated into the DEFINED BROW STUDIO mark and does not affect a customer’s recollection of the source-identifying portion of the mark, DEFINED BROW STUDIO and DEFINED BROW are virtually identical in meaning and commercial impression. Under the intended “leeway or flexibility with respect to permissible change in a mark and the concomitant amendment of the drawing thereof,” the deletion of STUDIO, a ubiquitous term for a location where beauty services are rendered, is inconsequential to the trademark significance of the applied-for mark and, therefore, the amendment of DEFINED BROW STUDIO to DEFINED BROW is a permitted change that would not require republication of the application.


CONCLUSION
