NOTICE OF OPPOSITION

Opposer, Coulter Ventures, LLC, an Ohio limited liability company whose address is 545 E. 5th Avenue, Columbus, Ohio 43201, believes it will be damaged by registration of the above-identified mark (hereinafter “Applicant’s Mark”) applied for on the Principal Register by Asustek Computer Incorporation, a corporation of Taiwan, whose address is 1F., No. 15, Lide Rd., Beitou Dist., Taipei City 112 Taiwan, and opposes the same in this Notice of Opposition filed pursuant to 37 CFR § 2.104(b).

The grounds for the opposition are as follows:

1. Opposer is a leading supplier of strength and conditioning equipment, apparel, lifestyle goods, and services associated with physical fitness and training.

2. Opposer is the owner of at least the following U.S. Trademark Registrations that include the mark ROGUE:

4. Opposer also has common law rights in the mark ROGUE, alone and in combination with other words, for use in connection with the sale of, *inter alia*, apparel and related retail store services that predate Applicant's filing date.

5. Opposer has made and continues to make extensive use of the word ROGUE, alone and in combination with other words, as a trademark for its goods and services.

6. Opposer's registered and common law rights in the mark ROGUE, alone and in combination with other words, are collectively referred to as the "ROGUE Marks."

7. Opposer has made substantial sales of goods and services under the ROGUE Marks.

8. Opposer previously successfully opposed applications for ROGUE WOMEN in

Classes 9, 14, 16, 18, 21, 25, 27, 28, 35, 41, and 45, Application Nos. 87866398, 87866427, 87866454, 87866503, 87866547, 87866574, 87866641, 87866658, 87866674, 88145205, and 87866712, Consolidated Opposition No. 91249769, an application for ROGUE in Classes 6 and 20, Application No. 88046108, Opposition No. 91247035, an application for ROGUE CULTURE in Class 41, Application No. 87857776, Opposition No. 91245401, an application for EPIC ROGUE in Class 18, Application No. 87822220, Opposition No. 91244904, an application for ROGUE GRIT ACADEMY in Classes 25 and 41, Application No. 87250888, Opposition No. 91234993, an application for ROGUE INTIMATES and Design in Classes 25 and 42, Application No. 88869241, Opposition No. 91266378, an application for ROGUE in Class 25, Application No. 77706222, Opposition No. 91200670, an application for ROGUE STYLE in Class 25, Application No. 90241181, Opposition No. 91268733, an application for ROGUE in Class 28, Application No. 88/901267, Opposition No. 91266781, an application for ROGUE COMBAT CLUB in Class 41, Opposition No. 91269581, an application for ROGUE IRON in Class 18, Opposition No. 91271431, and an application for COWBOY ROGUE in Class 25, Opposition No. 91271773, which resulted in decisions sustaining the oppositions. Opposer also previously petitioned to cancel a registration for ROGUE NUTRITIONIST in Classes 9, 16, 41, and 44, Registration No. 4289539, Cancellation No. 92067899, a registration for ROGUE in Class 25, Registration No. 3260143, Cancellation No. 92055912, a registration for ROGUE STATE in Class 25, Registration No. 3945523, Cancellation No. 92056316, which resulted in decisions granting cancellation of the registrations.

9. As a result of Opposer's long use and registration of the ROGUE Marks, Opposer has developed substantial goodwill in the ROGUE Marks, and the public has come to associate the ROGUE Marks with the goods and services of Opposer.

10. Applicant filed its Application No. 90597261 for Applicant's Mark ROG on March

23, 2021, based on an intent to use in commerce pursuant to Sections 1(b) and 44(e) of the Trademark Act and “Clothing, namely, coats, jackets, shirts, underpants, sports shirts, t-shirts, trousers, underwear, underclothing, vests, aprons, hooded sweatshirts; Hats; Hosiery; Neck scarves; Headbands; Gloves as clothing; Fingerless gloves as clothing; Belts; Raincoats; Shoes; Boots; Ear muffs; Leather belts” in International Class 25.

11. If Applicant is permitted to register its ROG trademark, registration is likely to cause confusion with Opposer’s ROGUE Marks, and such registration would damage and injure Opposer.

COUNT I

LIKELIHOOD OF CONFUSION

12. Opposer repeats and realleges paragraphs 1-11 as paragraph 12 of this Count I.

13. Opposer’s use and registration of its ROGUE Marks is prior to the filing date of the opposed Application.

14. On information and belief, Applicant was aware of Opposer’s ROGUE Marks at the time that it filed its application.

15. Applicant’s Mark is confusingly similar to Opposer’s ROGUE Marks such that use and registration of Applicant’s Mark for the applied for goods is likely to cause confusion, mistake, or deception of the public and lead the public and prospective purchasers to believe that Applicant’s goods are those of Opposer or are endorsed, sponsored, or otherwise affiliated or connected with Opposer, or that Opposer’s goods and services are associated with Applicant, all to the damage and injury of the purchasing public and to the damage and injury of Opposer.

16. Applicant’s use and registration of Applicant’s Mark will inevitably lead to confusion, to mistake, or to deception of the public within the meaning of Section 2(d) of the Lanham Act, 15 USC § 1052(d), all to Opposer’s grave and irreparable damage.

17. Registration of Applicant's Mark should be denied based on a likelihood of confusion with Opposer's prior ROGUE Marks, in violation of Section 2(d) of the Lanham Act, 15 USC § 1052(d).

CLAIM FOR RELIEF/DAMAGE

18. By reason of the foregoing, Applicant's registration of the mark herein opposed will cause injury and damage to Opposer's rights to its registered ROGUE Marks and to its use thereof described above.

WHEREFORE, Opposer respectfully prays that the present opposition be sustained and that the registration sought by the Applicant be refused.

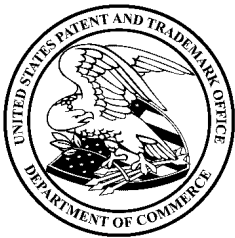

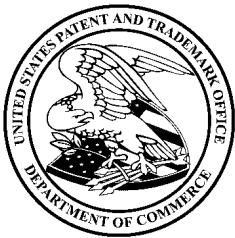
