OPPOSER’S RESPONSE TO APPLICANT’S MOTION TO SUSPEND

Applicant Blue Falcon Six, LLC has brought a motion to suspend this Opposition pending the outcome of Cancellation Nos. 92070142 and 92075016 (consolidated into Opposition No. 91231416) (collectively, the “FICO v. CrowdStrike Proceedings”). Opposer Fair Isaac Corporation (“FICO”) responds as follows:

1. Blue Falcon Six did not meet and confer or ask FICO whether it would consent to the present motion.
2. FICO notes that the grounds for CrowdStrike’s claims for cancellation of FICO’s registrations of its long-standing FALCON mark—in response to FICO’s filing of an opposition and cancellation against CrowdStrike’s marks—are baseless and without merit, as they will be if Blue Falcon Six asserts such a counterclaim in the instant proceeding.
3. Nevertheless, FICO agrees that the determination of the similarity of FICO’s and CrowdStrike’s services, customers and trade channels and other likelihood of confusion-related issues may have a bearing on or impact the Board’s view of issues in the instant proceeding.

If Blue Falcon Six had simply asked FICO for consent to this motion, FICO would have provided it. Therefore, FICO consents to the instant motion and respectfully requests that the Board suspend this Opposition pending the outcome of the FICO v. CrowdStrike proceedings.
