

**NOTICE OF OPPOSITION**

Opposer, Lenovo (Beijing) Limited, believes that it would be damaged by registration of the mark “LENOVSONIC” (“**Applicant’s Mark**”), depicted in U.S. Application Serial No. 97/076,295 (the “**Application**”), filed October 15, 2021, by Xiangwei Wang. Accordingly, Lenovo (Beijing) Limited hereby opposes registration of Applicant’s Mark, and as grounds for opposition alleges as follows:

1.       Opposer, Lenovo (Beijing) Limited, is a Chinese company located at Room 201-H2-6, Floor 2, No. 6 Shangdi West Road, Haidian District, Beijing 100 085, P.R. China.
  
2.       Opposer is a multinational technology company that designs, develops, manufactures and sells, among other things, computers, tablet computers, laptops, computer memories, video monitors, computer displays and other peripheral equipment, servers and data storage equipment, augmented reality and virtual reality systems, gaming equipment, smart home devices, mobile telephones, smartphones, wearable smart devices, accessories for use with mobile phones and smartphones, computer software, and other related goods and services.

3. Opposer was formed in China in 1984. At least as early as May 2005, Opposer adopted and began using the trademark LENOVO in the United States in connection with computers and related computer peripherals and software. Opposer has used its LENOVO mark in the United States continuously since that date, and, through extensive sales, advertising, and promotion, Opposer's LENOVO mark has come to represent enormous goodwill now owned by Opposer.

4. Opposer owns U.S. trademark registration no. 3,149,377 for the mark **lenovo**. The application for registration no. 3,149,377 was filed February 20, 2003, and the registration issued September 26, 2006. Registration No. 3,149,377 covers many goods in International Class 9, including computers, computer peripheral equipment, mobile telephones, consumer electronics, and software for interfacing computers with other electronic devices.

5. Registration no. 3,149,377 is valid, subsisting, and in full force and effect and has become incontestable within the meaning of 15 U.S.C. §§ 1065 and 1115(b).

6. Opposer owns U.S. trademark registration no. 5,388,737 for the mark LENOVO in standard characters. The application for registration no. 5,388,737 was filed September 29, 2015, and the registration issued January 30, 2018. Registration No. 5,388,737 covers many good and services in multiple international classes, including a variety of computer and A/V goods in International Class 9.

7. Registration no. 5,388,737 is valid, subsisting, and in full force and effect.

8. A true and correct copy of a printout from the TSDR database of the United States Patent and Trademark Office showing the current status and title of the registrations identified in paragraphs 4–7 is attached hereto as **Exhibit A**.

9. Through extensive use, Opposer has also acquired significant common-law rights in its LENOVO mark and has used the mark in connection with a variety of goods and services in the U.S.

10. On information and belief, Applicant is an individual with an address at No. 9, Dawang Village, Banquiao Village Committee, Caimiao Town, Taihe County, Anhui, China 236600.

11. On October 15, 2021, Applicant filed the Application to register Applicant's Mark (LENOVSONIC) in the USPTO for the following goods in Class 9 (the "**Opposed Goods**"):

Earphones; Headphones; Loudspeakers; Blank USB flash drives; Cabinets for loudspeakers; Cases for smartphones; Cell phone battery chargers; Computer cursor control devices, namely, computer mouse; Computer keyboards; Data cables; LCD projectors; Rechargeable electric batteries; USB hubs; Wireless chargers; Wireless headsets for smartphones.

12. On information and belief, Opposer's rights in the LENOVO mark arose prior to any rights that Applicant may have in Applicant's Mark.

13. Applicant's Mark is similar to Opposer's LENOVO mark in sight, sound, and commercial impression.

14. Applicant seeks to register Applicant's Mark in connection with goods that are identical or closely related to the goods and services that Opposer offers under Opposer's LENOVO mark or that are within Opposer's reasonable zone of expansion.

**COUNT I**  
**(Priority and Likelihood of Confusion)**

15. Opposer realleges and incorporates herein by reference the matters alleged in Paragraphs 1 through 14.

16. Applicant's Mark (LENOVSONIC) so resembles Opposer's prior LENOVO mark in sound, sight, and commercial impression as to be likely, when applied to the Opposed Goods, to cause confusion, mistake, or deception by causing the public to believe that Applicant's goods originate from, or are otherwise sponsored or endorsed by, Opposer in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d), with consequent damage to Opposer and the public within the meaning of 15 U.S.C. § 1063(a).

**REQUEST FOR RELIEF**

17. For the foregoing reasons, among others, Opposer believes it would be damaged by the registration of Applicant's Mark and respectfully requests that this Opposition be sustained and that registration of Applicant's Mark be denied.
