**NOTICE OF OPPOSITION**

Opposer, Wolf Appliance, Inc. (“**Wolf**”), a Wisconsin corporation, having a business address at 2866 Bud’s Drive, Fitchburg, Wisconsin, believes that it will be damaged by, and hereby partially opposes, registration of the mark BAMBOO WOLF (the “**BAMBOO WOLF Mark**”) that is the subject of Application Serial No. 90/627,389 (the “**Application**”) published in the *Official Gazette* on January 11, 2022, and requests that registration of the Application be partially refused with respect to the goods specified herein.

As grounds in support of this opposition, Opposer asserts as follows:

1. By the Application herein opposed, Applicant seeks to register the BAMBOO WOLF Mark in Class 7 for the goods “dishwashers; electric food blenders; electricity generators.” The Application was filed on April 6, 2021, and claims first-use in commerce as of March 2, 2021.

2. Opposer herein specifically opposes registration of the BAMBOO WOLF Mark for the goods “dishwashers” and “electric food blenders” in Class 7 (hereinafter, the “**Opposed Goods**”).

3. Opposer is a wholly owned subsidiary of Sub-Zero Group, Inc., a Wisconsin corporation having an address at 4717 Hammersley Road, Madison, Wisconsin 53711 (hereinafter “**Sub-Zero Group**”).

4. Opposer owns Registration No. 2698313 for the mark WOLF for “Domestic gas and electric cooking appliances, namely, ranges, cooktops, wall oven, microwave ovens, ventilation hoods for ranges, barbeque grills, and warming ovens” in Class 11. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.

5. Opposer owns Registration No. 2716174 for the mark WOLF for “Servicing of domestic gas and electric cooking appliances” in Class 37. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.

6. Opposer owns Registration No. 3578568 for the mark WOLF & Design (the “**WOLF Logo**”) for “Domestic gas and electric cooking appliances, namely, ranges, cooktops, wall ovens, microwave ovens, ventilation hoods for ranges, barbeque grills and warming ovens” in Class 11 and “Servicing, repair and maintenance of domestic gas and electric cooking appliances” in Class 37. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.

7. Opposer owns Registration No. 3655912 for the mark WOLF GOURMET for “Knives, namely, chef, kitchen, paring, bread” in Class 8. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.



8. Opposer owns Registration No. 5054848 for the mark WOLF GOURMET for “Domestic electric kitchen machines, namely, blenders” in Class 7, “Domestic electric kitchen machines, namely, toasters and toaster ovens” in Class 11, and “Cookware, namely, pots, pans; knife blocks” in Class 21. This registration is valid, subsisting, unrevoked, and uncanceled.

9. Opposer owns US Reg. No. 6216923 for the mark WOLF GOURMET for “Knives, namely, butcher, cheese, steak, boning, fillet, carving, utility and santoku knives; kitchen shears” in Class 8 and “Domestic electric kitchen machines, namely, coffee makers, slow cookers, multicookers, griddles, and countertop ovens” in Class 11. This registration was filed on October 5, 2016 and is valid, subsisting, unrevoked, and uncanceled.

10. Opposer owns US App. No. 90/001,352 for the mark WOLF GOURMET for “electric food processors” in Class 7 and “electric tea kettles” in Class 11. This application was filed on June 15, 2020, based on an intent-to-use in commerce and was issued a Notice of Allowance on December 22, 2020.

11. Opposer, including via its predecessors-in-interest and authorized agents, began using the mark WOLF at least as early as January 2001 in connection with gas and electric cooking appliances, including ranges, cooktops, wall ovens, microwaves, warming ovens, barbeque grills, and ventilation hoods, and the servicing of these products.

12. Opposer, including via its authorized agents, began using the WOLF Logo at least as early as February 2001 in connection with gas and electrical cooking appliances, including ranges, cooktops, wall ovens, microwaves, warming ovens, grills, and ventilation hoods, and the servicing, repair, and maintenance of these products.

13. Opposer, including via its authorized agents, began using the mark WOLF GOURMET at least as early as May 2009 in connection with knives.

14. Opposer, including via its authorized agents, began using the mark WOLF GOURMET at least as early as February 2015 in connection with domestic electric kitchen machines, namely, blenders, toasters, and toaster ovens, and cookware, namely, pots, pans, and knife blocks.

15. Opposer's parent company, Sub-Zero Group, owns U.S. Registration No. 5782012 for the word mark COVE for "dishwashers" in Class 7. This registration is valid, subsisting, unrevoked, and uncancelled.

16. Sub-Zero Group also owns U.S. Registration No. 5908871 for the COVE & Design mark for "dishwashers and replacement parts and accessories therefor, namely, handle kits, door panels, and utensil baskets for dishwashing machines" in Class 7 (the "**COVE Logo**"). This registration is valid, subsisting, unrevoked, and uncancelled.

17. Sub-Zero Group, including via its other related companies and/or its authorized agents, began using the COVE word and COVE Logo marks at least as early as March 2019 in connection with dishwashers and related parts and accessories.

18. Opposer submits that its WOLF, WOLF Logo, and WOLF GOURMET branded products and services are marketed, offered, and sold alongside, or are intended to be marketed, offered, and sold alongside, and as complementary to, Sub-Zero Group's COVE and COVE Logo branded products (among other kitchen and cooking appliances marketed and offered under Sub-Zero Group's portfolio of brands).

19. Opposer's WOLF and WOLF GOURMET word marks and WOLF Logo (collectively referred to herein as the "**WOLF Marks**") are of significant value to Opposer, including as an identification of source in connection with the sale and offering of Opposer's products and services covered by Opposer's registrations and application for the WOLF Marks as outlined in paragraphs 4 through 10 herein (collectively, the "**Opposer's Goods and Services**"). Printouts of the TESS records showing the current title and status for each of the **WOLF Marks** along with Sub-Zero Group's COVE and COVE Logo registrations are attached hereto as **Exhibit A**.

20. Opposer, prior to any filing date, priority date, or date of first use upon which Applicant can rely, applied for, adopted, and/or used its WOLF Marks in connection with Opposer's Goods and Services.

21. Opposer's WOLF Marks for Opposer's Goods and Services and Applicant's BAMBOO WOLF Mark sought to be registered for the Opposed Goods are highly similar given that the BAMBOO WOLF Mark prominently features the identical WOLF mark (i.e., BAMBOO **WOLF**). The addition of the word "BAMBOO" to the BAMBOO WOLF Mark is insufficient to distinguish the respective marks under the circumstances. This results in marks that are highly similar in spelling, sound, appearance, and overall commercial impression.

22. The Opposed Goods are the same as, or are overlapping, complementary, similar, or closely related to, or are within the natural zone of expansion of, Opposer's Goods and Services provided under the WOLF Marks. For example, and without limitation, Applicant, under the BAMBOO WOLF Mark, allegedly provides electric food blenders, which are identical or highly similar or related to Opposer's electric blenders and other countertop appliances offered under Opposer's WOLF Marks, and are also similar, related, and/or complementary to

the various other kitchen and cooking appliances and related products offered under and covered by Opposer's WOLF Marks. In short, the Opposed Goods allegedly provided under Applicant's BAMBOO WOLF Mark and Opposer's products sold under the WOLF Marks are legally identical, similar, related, complementary, or are all used in the kitchen or otherwise in relation to food or beverage preparation, preservation, or clean up. The Opposed Goods are also the types of products that are typically sold through the same or similar channels of trade to the same or similar class of consumers as the goods sold under the WOLF Marks.

23. Applicant's applied-for dishwashers are also identical to and directly competitive and overlapping with, or are otherwise similar, related, or complementary to, the dishwashers and related products and accessories offered by Opposer's parent company Sub-Zero Group under its COVE and COVE Logo marks. These dishwashers and related products and accessories (among other types of kitchen and cooking appliances) are typically sold alongside the goods and services offered by Opposer under its WOLF Marks and are sold through the same or similar channels of trade to the same or similar class of consumers.

24. Applicant's BAMBOO WOLF Mark so resembles Opposer's WOLF Marks that, when applied to the Opposed Goods, it is likely to, or will, cause confusion, mistake, or deception within the meaning of Section 2(d) of the Trademark Act, all to the damage of the Opposer.

25. Through Opposer's use of its WOLF Marks for Opposer's Goods and Services, purchasers and prospective purchasers of such products and services, and/or similar, related, overlapping, or complementary goods and services, associate such marks with a single source, namely, Opposer.

26. Purchasers and prospective purchasers are likely to be misled into believing, contrary to fact, that the Opposed Goods allegedly provided under the BAMBOO WOLF Mark emanate from, are connected, associated, or affiliated with, or are in some way approved or sponsored by, Opposer, all to Opposer's irreparable damage, including through impairment of its goodwill, as symbolized by Opposer's WOLF Marks.

27. For at least the above reasons, registration of the Application is partially opposed for the Opposed Goods on the ground that Applicant's BAMBOO WOLF Mark is likely to cause confusion, to cause mistake, or to deceive under Section 2(d) of the Trademark Act and under state statutory and common law.

WHEREFORE, Opposer requests that this opposition be sustained and the Application to register the BAMBOO WOLF Mark be partially refused registration with respect to the Opposed Goods.
