JOINT NOTICE OF OPPOSITION

Each of PRL USA Holdings, Inc., a Delaware corporation having a principal place of business at 650 Madison Avenue, New York, New York 10022 (“PRL USA”), and L’Oréal USA, Inc., a Delaware corporation having a principal place of business at 10 Hudson Yards, New York, New York 10001 (“L’Oréal”; and together with PRL USA “PRL” or “Opposers”), believes it will be damaged by the issuance of a registration for the mark BILLIONAIRE POLO CLUB (“Applicant’s Mark”), as shown in Application Serial No. 88/770,513 (the “Application”), filed in the United States Patent and Trademark Office (“USPTO”) on January 23, 2020, based on an intent to use the mark, and published in the *Official Gazette* on October 19, 2021 for “Fragrances; Cologne; Perfume” in International Class 3, and therefore opposes the same. As grounds for their opposition, Opposers by their attorneys Fross Zelnick Lehrman & Zissu, P.C., allege as follows:

FACTS ABOUT OPPOSERS

1. PRL USA is the owner of the trademark POLO, both alone and in conjunction with various other terms such as POLO RALPH LAUREN, POLO SPORT, POLO BLUE, and POLO BLACK, for use in connection with fragrances and related goods.
2. L'Oréal is PRL USA's exclusive licensee in the United States for fragrances and toiletries bearing the POLO marks.
3. Both Opposers obtained extensions of time to oppose the Application and both Opposers have a real interest in the proceeding. Opposers file this Opposition as Joint Opposers pursuant to TBMP § 303.06.

OPPOSERS' RIGHTS IN THE POLO MARKS

4. For more than four decades, PRL has used the mark POLO - both alone and as part of such composite marks as POLO RALPH LAUREN, POLO SPORT, POLO RED, POLO BLACK, POLO BLUE (collectively, the "POLO Marks") - throughout the United States in connection with fragrances and aftershave lotion. Starting with an aftershave lotion in 1974 and colognes as early as 1978, today the POLO Marks are used on or in connection with more than 75 different fragrance and aftershave products offered for sale, among other goods and services.
5. Opposers use the POLO mark consistently in connection with their POLO branded fragrances and have created a family of POLO marks that use the POLO element to identify and distinguish goods coming from Opposers.
6. Fragrances offered under the POLO mark and the family of POLO Marks are sold in the United States in Ralph Lauren retail stores, as well as major department and fine retail stores, including Bergdorf Goodman, Saks Fifth Avenue, Neiman Marcus, Bloomingdale's, Nordstrom's, Macy's, Lord & Taylor, Dillard's and Belk. PRL also markets and sells fragrances bearing the POLO Marks online at *RalphLauren.com* and through *other* online retailers, such as



Macys.com, Sephora.com, Bloomingdales.com and Nordstrom.com. The products offered under the family of POLO Marks are advertised and promoted together and goods bearing the POLO Marks highlight the POLO mark.

7. Over the years, PRL has expended significant time, effort, and money in advertising and promoting the POLO mark and their POLO-branded fragrances, including in trade publications, magazines of general circulation, television, billboards, internet, and social media, as well as through sports event sponsorships.

8. POLO branded fragrance products have been for decades and remain among the top-selling fragrance products in the United States, with tens of millions of dollars in yearly sales and with thousands of sales locations in the United States.

9. POLO branded fragrances have received recognition from consumers and the fragrance industry. POLO branded fragrances are often found on Top-10 lists of reviewers. The Fragrance Foundation has honored PRL's POLO brand on several occasions. In 2004, the POLO RALPH LAUREN cologne was inducted into the Perfume Hall of Fame by The Fragrance Foundation, joining such iconic fragrances as CHANEL NO. 5, SHALIMAR, and JOY.

10. In addition to its common law rights in the POLO mark and the family of POLO Marks created by virtue of PRL's extensive use of the marks to identify and distinguish their goods in the marketplace, Opposer PRL USA is the owner of numerous valid and subsisting trademark registrations for the POLO Marks on the Principal Register of the United States Patent and Trademark Office ("USPTO"), including, without limitation, the following registrations in International Class 3 (the "POLO Registrations"):

11. These registrations, maintained on the Principal Register by the USPTO, are valid, subsisting and in full force and effect, and constitute evidence of the validity of the identified marks and of Opposers' exclusive right to use the identified marks for the goods identified in the registrations. In addition, those registrations marked with an asterisk have become incontestable and serve as conclusive evidence of Opposers' exclusive right to use the mark in commerce on or in connection with the goods identified in the registrations as provided by Section 33(b) of the Lanham Act, 15 U.S.C. § 1115(b). Pursuant to 37 C.F.R. § 2.122(d), printouts from the USPTO's electronic TSDR database showing the current status and title for each of the POLO Registrations are attached hereto as **Exhibit A**.

12. The POLO mark, the POLO family element and the family of POLO Marks have become synonymous with PRL in the marketplace.

13. PRL's fragrances marketed under the POLO Marks have enjoyed widespread unsolicited media coverage in print, on television, and on the internet, which has heightened consumer awareness of PRL's goods.

14. In the course of developing one of the most recognized brands in the United States, PRL has expended significant resources to protect the strength, goodwill, and value of the POLO Marks.

15. As a result of PRL's expenditures, the POLO mark and family element and the family of POLO Mark are famous and widely recognized among the general consuming public of the United States as denoting the source of the goods bearing the POLO Marks.

16. By virtue of PRL's extensive and continuous use of the POLO Marks for over four decades, and the sale and promotion of POLO branded goods by PRL and its authorized retailers, the POLO Marks and POLO brand have become associated exclusively with PRL, signify goods coming exclusively from PRL, have acquired enormous goodwill and consumer recognition, and represent a substantial asset of Opposers.

APPLICANT ZURICH LLOYDS CORPORATION

17. Upon information and belief, and based on the records of the USPTO, Applicant Zurich Lloyds Corporation ("Applicant") is a Florida corporation located at 851 Broken Sound Pkwy Suite 207, Boca Raton, Florida 33487.

18. Upon information and belief, Applicant has a new address of 225 Glades Rd., Ste. 324A, Boca Raton, Florida 33431, which address is not reflected in the USPTO's database. Further, upon information and belief neither Applicant nor its prior counsel has advised the USPTO of any update to Applicant's address.

19. On January 23, 2020, after Opposer PRL USA had obtained over a dozen registrations for its POLO Marks for fragrances including for POLO, after 11 of the POLO Registrations had become incontestable, after POLO branded fragrance products had garnered significant awards and attention and generated millions of dollars in sales, Applicant filed an intent-to-use application under Section 1(b), 15 U.S.C. § 1051(b), to register BILLIONAIRE POLO CLUB for use in connection with “Fragrances; Cologne; Perfume” in International Class 3 (collectively, “Applicant’s Goods”).

20. The Application filing date, and upon information and belief, the only date on which Applicant can rely, is long after PRL commenced use of and acquired rights in the POLO Marks, and long after the POLO Marks had acquired fame and goodwill in the United States.

21. Upon information and belief, as a result of the widespread use of the POLO Marks by Opposers and the extensive sales and advertising of POLO branded fragrance and related products, Applicant was on notice of Opposers’ rights in and to the POLO Marks before adopting and applying to register the BILLIONAIRE POLO CLUB mark for fragrances. As a matter of law, by virtue of PRL USA’s POLO Registrations identified above, Applicant was deemed to be on constructive notice of PRL USA’s prior rights in the POLO Marks prior to Applicant’s adoption and filing of its Application for BILLIONAIRE POLO CLUB.

15 U.S.C. § 1072.

22. Applicant is not affiliated with Opposers and has not obtained any permission or authorization from Opposers to register or use the BILLIONAIRE POLO CLUB mark for fragrances.

23. Issuance of a registration to Applicant for the BILLIONAIRE POLO CLUB mark is inconsistent with PRL’s prior rights in its POLO Marks and the statutory grant of exclusivity

flowing from PRL USA's trademark registrations for the POLO Marks and would substantially damage PRL's investment and goodwill in its POLO Marks.

24. Opposers have each stated a statutory cause of action and each is entitled to bring the claims asserted herein.

**FIRST CLAIM FOR RELIEF BY BOTH OPPOSERS:
PRIORITY AND LIKELIHOOD OF CONFUSION UNDER SECTION 2(d)**

25. Opposers repeat and re-allege each and every allegation contained in paragraphs 1 through 24 as if fully set forth herein.

26. Upon information and belief, Applicant has made no use of Applicant's Mark. As such, the filing date is the only date on which Applicant may rely.

27. The filing date of the Application is long after PRL's first use of the POLO Marks, long after PRL acquired rights in the POLO Marks, and long after the POLO Registrations issued. As such, PRL's rights in the POLO Marks are prior and superior to any rights Applicant may claim in Applicant's Mark.

28. Applicant's Mark incorporates in its entirety PRL's well-known POLO mark. Further, Applicant's Mark incorporates the POLO element that is consistently used in all of the POLO Marks. As a result, Applicant's Mark creates a similar commercial impression and is similar in sight, sound and meaning to the POLO mark and the family of POLO Marks.

29. Applicant seeks to register Applicant's Mark for "fragrances; cologne; perfume" in International Class 3. These are the very goods long provided by PRL under its POLO Marks and long associated with PRL and its POLO mark and family of POLO Marks. Given that the products identified in the Application are identical to goods that PRL has long been offering under the POLO Marks and that are the subject of the POLO Registrations, less similarity in the marks is required as a matter of law to find a likelihood of confusion.

30. The Application is unrestricted as to consumers and the channels of trade through which the applied-for goods are or will be provided. Given that Applicant's goods are identical to the goods offered by PRL under the POLO Marks, it is presumed as a matter of law that the consumers for Applicant's goods under Applicant's Mark overlap with the consumers for PRL's goods under the POLO Marks and that the Parties' products will be sold and promoted through the same channels of trade to the same consumers.

31. In view of the strength of the POLO mark and the POLO Marks, the identical nature of the Parties' goods, the incorporation in Applicant's Mark of PRL's POLO trademark, the presumed overlap in trade channels and consumers, registration of Applicant's Mark for the goods identified in the Application is likely to confuse consumers into believing, falsely, that Applicant's goods provided under Applicant's Mark originate with, are sponsored or approved by, or are otherwise connected with PRL or with the goods PRL offers under its POLO Marks. As such, registration of Applicant's Mark is likely to cause confusion, cause mistake or to deceive the public in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

32. As a result of the foregoing, registration to Applicant of Applicant's Mark would be inconsistent with PRL's rights in the POLO Marks and would threaten the investment and goodwill of PRL in the POLO Marks. Opposers therefore would be injured by registration of Applicant's Mark.

**SECOND CLAIM FOR RELIEF BY PRL USA:
DILUTION UNDER SECTION 2(f)**

33. Opposer PRL USA repeats and re-alleges each and every allegation contained in paragraphs 1 through 24 as if fully set forth herein.

34. Opposer PRL USA's POLO mark is inherently distinctive or has acquired distinctiveness, becoming one of the best-known fragrance marks and brands in the United States

through use over four decades, millions of dollars of sales annually, and advertising and promotion to hundreds of millions of consumers.

35. Opposer PRL USA is the owner of numerous federal trademark registrations for POLO or for marks that use the family element POLO as shown in the list of the POLO Registrations, including several incontestable registrations, all of which issued prior to any date on which Applicant can rely.

36. Opposer PRL USA, through its licensee, has been using the POLO mark nationally for decades, has engaged in nationwide promotion which features the mark, and has otherwise publicized the POLO mark including as part of the POLO Marks and as a family of marks throughout the United States. POLO-branded goods are used by hundreds of millions of consumers in the United States. As a result of the foregoing, the POLO mark is a famous mark and the POLO brand has acquired extensive actual recognition and fame as a designation of goods coming exclusively from or licensed by PRL USA.

37. Applicant's Mark shown in the Application was adopted long after Opposer PRL USA's POLO mark became famous; the Application was filed by Applicant long after Opposer's POLO mark became famous; and Applicant's filing date is long after Opposer's POLO mark became famous.

38. By virtue of the similarity between Applicant's Mark and the POLO mark, the fame of the POLO mark, and the exclusive association between the POLO mark and Opposer PRL USA, registration of Applicant's Mark is likely to call to mind and would dilute and/or is likely to dilute Opposer PRL USA's famous POLO mark by impairing the distinctiveness of Opposer's POLO mark to identify exclusively goods from Opposer or its authorized licensees in violation of Section 2(f) of the Lanham Act, 15 U.S.C. § 1052(f).

39. Opposer PRL USA therefore would be injured by registration of Applicant's Mark.

WHEREFORE, each of L'Oréal USA, Inc. and PRL USA Holdings, Inc. respectfully requests that this opposition be sustained and that the registration sought by Applicant in Application Serial No. 88/770,513 be denied.
