### **NOTICE OF OPPOSITION**

BBC Ice Cream, LLC ("**Opposer**"), a Delaware Limited Liability Company located at 3850 Bird Road, Suite 801, Miami, Florida 33146, believes it will be damaged by registration of the mark claimed in Application Serial No. 88/770,513 (the "**Contested Application**") and accordingly hereby opposes the Contested Application pursuant to Trademark Act Section 13, 15 U.S.C. §1063, and alleges:

### **Introduction**

1. Because of Opposer's prior rights in the mark ICECREAM, the Contested Application should be refused.

### THE CONTESTED APPLICATION

- 2. Upon information and belief, Applicant, Zurich Lloyds Corporation ("Applicant") is an inactive Florida Corporation, having been administratively dissolved on September 24, 2021, with its principal place of business located at 851 Broken Sound Pkwy, Suite 207, Boca Raton, Florida.
- 3. Through the Contested Application, Applicant is seeking registration of the mark BILLIONAIRE POLO CLUB (the "Contested Mark") for "Fragrances; Cologne; Perfume" in Class 3 (filed on an intent-to-use basis).

- 4. The Contested Application was filed on January 23, 2021 under Section 1(b) and was published for opposition on October 19, 2021.
- 5. Opposer timely filed a Request to Extend Time to Oppose on November 18, 2021, which was granted by the Board the same day. Opposer then requested a second extension on December 17, 2021, which was also granted by the Board the same day.

### **OPPOSER'S PRIOR RIGHTS**

- 6. In or about June 2005, Opposer began using the mark BILLIONAIRE BOYS CLUB (the "BILLIONAIRE BOYS CLUB Mark") to identify clothing, headwear and footwear, and subsequently expanded its product line to a variety of other products including, but not limited to, bags, rugs, towels, and related items.
- 7. Opposer's line of BILLIONAIRE BOYS CLUB products was launched by the iconic singer, rapper, and record producer Pharrell Williams, and has received a substantial amount of media coverage.
- 8. As a result of the foregoing use of the BILLIONAIRE BOYS CLUB Mark, Opposer has established significant goodwill in the mark, and it has come to be exclusively associated with Opposer.

## OPPOSER'S FEDERAL TRADEMARK REGISTRATIONS FOR ITS BILLIONAIRE BOYS CLUB MARK

- 9. Applicant's rights are inferior to those of Opposer due to Opposer's actual prior use of the BILLIONAIRE BOYS CLUB Mark for clothing and related goods.
- 10. Opposer also has priority over Applicant based upon constructive use dating back as far as February 2003 in connection with the following registrations (collectively, "Opposer's BILLIONAIRE BOYS CLUB Registrations"):
  - U.S. Reg. No. 3,216,201 for the mark BILLIONAIRE BOYS CLUB covering "Clothing, namely, jackets, coats, raincoats, [ blazers, ] shirts, t-shirts, [ skirts, dresses, ] trousers, jeans, shorts, sweaters, cardigans [, scarves and belts ]; footwear; headwear" in Class 25 (Filed February 14, 2003).

- U.S. Reg. No. 5,086,483 for the mark covering "Clothing, namely, tops, bottoms, jackets, hooded pullovers, sweaters, footwear, headwear, socks and undergarments" in Class 25 (Filed April 15, 2016).
- U.S. Reg. No. 5,242,580 for the mark covering "Stickers" in Class 16; "Rubber key chains" in Class 20; "Towels" in Class 24; and "Skateboard decks in Class 28 (Filed April 15, 2016).
- U.S. Reg. No. 5,723,816 for the mark BILLIONAIRE BOYS CLUB covering "All-purpose sports and athletic bags; beach, book, carry-on, duffel, gym, shoulder, tote and travel bags; fanny packs and waist packs; backpacks; knapsacks; luggage; luggage tags; business cases; business card cases; calling and credit card cases; wallets; banknote holders; billfolds; umbrellas" in Class 18 (Filed December 28, 2017).
- U.S. Reg. No. 3,778,773 for the mark BILLIONAIRE BOYS CLUB covering "[Jewelry;] ornamental lapel pins [; pins being jewelry; jewelry chains]" in Class 14 (Filed May 29, 2008).

U.S. Reg. No. 4,846,345 for the mark covering "Clothing, namely, shirts, hooded sweatshirts" in Class 25 (Filed August 15, 2012)

#### OPPOSITION BASED ON OPPOSER'S PRIOR RIGHTS

- 11. The Contested Mark is virtually identical and therefore confusingly similar to Opposer's BILLIONAIRE BOYS CLUB Mark and is likely to cause confusion, mistake, or to deceive as to the source, sponsorship, or affiliation between Opposer and Applicant and their respective goods.
- 12. The Contested Mark only substitutes the term BOYS in Opposer's BILLIONAIRE BOYS CLUB Mark for the term POLO. Thus, the marks share distinct similarities in sight, sound, meaning, and overall commercial impression. The use of the Opposer's BILLIONAIRE \_\_\_\_\_

CLUB construction bookending the term POLO will no doubt confuse consumers as to the source, origin, sponsorship, or affiliation of Applicant's fragrance products.

- 13. The first term BILLIONAIRE is the dominant portion of both parties' marks.
- 14. The Contested Mark also covers highly related goods, including, for example, perfumes and cologne. Fragrance products such as these commonly emanate from the same source goods such as Opposer's apparel, accessory, and home goods products.
- 15. These products are squarely within Opposer's zone of probable or natural expansion. Apparel companies such as Opposer frequently launch fragrance lines and consumers seeking such products expect this.
- 16. When used on or in connection with the goods of the Applicant, the Contested Mark is likely to cause confusion, or to cause mistake, or to deceive.
- 17. Applicant filed the Contested Application on a 1(b) (intent-to-use) basis and, on information and belief, has not begun use of the Contested Mark in U.S. commerce.
- 18. Opposer has priority over Applicant based upon (1) Opposer's use of its BILLIONAIRE BOYS CLUB Mark in commerce dating back to 2005; and (2) the constructive use priority dates of Opposer's BILLIONAIRE BOYS CLUB Registrations—dating back to 2003.
- 19. Opposer thus has prior and superior rights in the BILLIONAIRE BOYS CLUB Mark.
- 20. Since Opposer's rights are superior to those of Applicant, the Contested Applications should not have been approved for publication.
- 21. If Applicant is granted registration for BILLIONAIRE POLO CLUB, Applicant would thereby obtain a prima facie exclusive right to use the BILLIONAIRE POLO CLUB Mark, which would be a source of damage to Opposer's trademark rights as a result of the potential likelihood of confusion between the respective marks.

**WHEREFORE**, Opposer, BBC Ice Cream, LLC, respectfully requests that registration of the mark in the Contested Application (Serial No. 88/770,513) be refused and that this Opposition be sustained in favor of Opposer.
