**CONSENTED REQUEST TO AMEND APPLICATION AND
STIPULATED CONTINGENT WITHDRAWAL OF OPPOSITION “WITHOUT
PREJUDICE”**

Pursuant to 37 C.F.R. § 2.133(a) and T.B.M.P. § 514.02, Applicant AMPHENOL LTW TECHNOLOGY CO., LTD. (“Applicant”), by and through its undersigned counsel, and with the consent of Opposer Leviton Manufacturing Co., Inc. (“Opposer”), hereby requests that the recitation of goods identified in its application Serial No. 90/200,139 be amended by adding the following limitation in **bold** letters as follows:

*-- Electrical power extension cords; Computer cable; Cell phone straps; Wires, electric; Cables, electric; Optical signaling cable; Radio receivers; Aerials; Antennas; Satellite signal receiver; Coaxial cable connector; Materials for electricity mains, namely, electric wires and cables; Distribution boxes for electrical power; Electric plugs; Electrical inductors; Electrical terminators; Switches, electric; Electric sockets; Electrical connectors; Wiring board, namely, printed circuit boards (PCBs); **all of the foregoing for use in harsh and rugged environments and outdoor applications** [International Class 09] --*

Applicant submits that the amended identification of goods is a narrowing of the original scope and is therefore appropriate under the Rules and requests that the amendment be accepted accordingly.

Furthermore, contingent on the Board's acceptance and entry of the foregoing consented amendment, Opposer, with the consent of Applicant, hereby withdraws the subject opposition "without prejudice" pursuant to T.B.M.P. § 601.01.
