**NOTICE OF OPPOSITION**

1 Opposer IBKUL UBHOT LTD., a New York corporation (“Opposer” or  
2 “IBKUL”) believes that it, the United States Patent and Trademark Office  
3 (“USPTO”) and other competitors would be damaged by the above referenced  
4 application by ALFWEAR INC., a Utah Corporation (“Applicant” or  
5 “ALFWEAR”) of the above-identified mark (KÜHL) and hereby opposes the  
6 same.

### 7 BACKGROUND

8 1. Opposer IBKUL owns the following federal trademark applications in  
9 Class 25 for the following composite marks (collectively IBKUL marks):

17 2. Applicant ALFWEAR filed Opposition proceeding Nos. 91233985  
18 and 91270271 with respect to the IBKUL marks above based, in part, upon  
19 Applicant ALFWEAR’s claimed ownership of the mark KÜHL in Class 25 and a  
20 claimed likelihood of confusion between the marks.

21 3. Registration of the mark “KÜHL” will provide statutory  
22 presumptions inconsistent with the rights of Opposer and others to use the word  
23 “kühl” in the United States, thus damaging Opposer.

24 4. Applicant claims use in its application (SN97022893) of the mark  
25 KÜHL on the following goods in Class 25: “Hats; Pants; Shirts; Shorts; Belts;  
26 Bottoms as clothing; Jackets; Tops as clothing.”

27 5. Applicant ALFWEAR’s application for the mark KÜHL (SN

1 97022893) states, in part: “TRANSLATION: The English translation of KÜHL in  
2 the mark is cool.”

3 6. Under the doctrine of foreign equivalents, the German word “kühl”  
4 means “cool” in English, and German speakers in the U.S. translate “kühl” from  
5 German to English as “cool.”

6 7. The letter “Ü” in KÜHL is one of the standard characters acceptable  
7 to include in standard character marks. *See* TMEP §807.03(b).

8 8. Applicant ALFWEAR’s clothing products are currently offered to  
9 hikers and skiers with an emphasis on cool to cold temperature outdoor mountain  
10 activities. Applicant’s website states and/or has stated:

11 a. **“Hit the slopes** in men’s insulated jackets like the SPYFIRE  
12 and FIREFLY Series, and add a down vest or fleece vest like the  
13 INTERCEPTR as a mid-layer for core warmth and comfort. Look for  
14 features like KÜHL’s articulated sleeves for freedom of movement,  
15 reinforced shoulders for durability and Metaluxe zippers for  
16 performance.”

17 b. **“Hit the slopes** in women’s insulated jackets like the SPYFIRE  
18 and FIREFLY SERIES, and add a down vest or fleece vest like the  
19 FLIGHT VEST as a mid-layer for core warmth and comfort.  
20 Transition from trail to town to tarmac in women’s travel jackets and  
21 casual jackets designed with flattering lines and stylish details. Look  
22 for features like KÜHL’s signature hoods for added coverage,  
23 reinforced shoulders for durability and reflective ribbon for extra  
24 visibility.”

25 9. Applicant ALFWEAR’s clothing products for cool and cold  
26 temperature outdoor mountain activities is further supported by its registered  
27 marks: (1) Mountain Grown®; (2) Born in the Mountains®; and (3) Mountain  
28

1 Culture®.

2 10. Applicant ALFWEAR’s pending application (SN 97022893) for  
3 “KÜHL” is part of Alfwear’s improper and ongoing effort to monopolize a  
4 common and descriptive German word, “kühl,” which Applicant ALFWEAR,  
5 through its own admission, agrees means “cool” in English. As such, anti-  
6 competitive and/or antitrust concerns support denial of registration of “KÜHL.”

7 11. Hundreds of third party trademark registrations in Class 25 begin  
8 with or contain “kul” or “kuhl” or “kuul” or “cool” or “kool,” including marks set  
9 forth in Attachment 1 and Attachment 2 hereto.

10 12. Outside of Class 25, the word “Kühl” (or some form of it) has been  
11 registered or approved for use by other companies in various industries, including:

- 12 a. “Kühl” (Reg. No. 3854714) for air conditioners and related  
13 parts;  
14 b. “Kühl+” (Reg. No. 3854715) for air conditioners and related  
15 parts.  
16 c. “KUHL” (Reg. No. 806672) for egg washing machinery and  
17 related parts;  
18 d. “KUHL” (Serial No. 88975921) for mattress covers, mattress  
19 pads, and bedding.

20  
21 **FIRST CAUSE OF ACTION**  
22 (Failure to Function As A Mark)

23 13. Opposer IBKUL incorporates paragraphs 1 through 12 above.

24 14. Applicant’s use of the word cool (or its translation) fails to function  
25 as a mark in connection with clothing – especially cool weather clothing sold by  
26 Opposer.

27 15. Applicant ALFWEAR’s use of the word cool (or its translation)

1 conveys a well-recognized and widely used concept or sentiment.

2 16. The word “cool” (or its translation) is a commonplace term, message  
3 or expression widely used by a variety of sources.

4 17. The word cool (or its translation “KÜHL”) is a widely used word that  
5 fails to function as a trademark for clothing – especially cool weather clothing sold  
6 by Applicant ALFWEAR.

7 **SECOND CAUSE OF ACTION**  
8 (Descriptiveness of mark in Commerce)

9 18. Opposer IBKUL incorporates paragraphs 1 through 17 above.

10 19. Applicant’s applied-for mark “KÜHL” when “used on or in  
11 connection with the [clothing] goods of the applicant is merely descriptive . . . of  
12 them” within the meaning of 15 U.S.C. 1052(e). Accordingly, registration of  
13 “KÜHL” by Applicant for clothing should be denied.

14 **THIRD CAUSE OF ACTION**  
15 (Misdescriptiveness of mark in Commerce)

16 20. Opposer IBKUL incorporates paragraphs 1 through 19 above.

17 21. As alleged above, Applicant ALFWEAR descriptively uses “KÜHL”  
18 (which means cool) with respect to its cool and cold weather clothing.

19 22. To the extent that Applicant ALFWEAR uses “KÜHL” (which  
20 means cool) with respect to its warm and hot weather clothing, registration should  
21 be denied based upon misdescriptiveness.

22 23. The word “KÜHL”(which means cool) conveys an immediate idea of  
23 an ingredient, quality, characteristic, function, or feature of Applicant  
24 ALFWEAR’s cool and cold weather clothing with which it is used descriptively.

25 24. The word “KÜHL” (which means cool) misdescribes any clothing of  
26 Applicant ALFWEAR that is warm and hot weather clothing.

27 25. On information and belief, persons looking for Applicant

1 ALFWEAR’s “KÜHL”(which means cool) clothing are likely to believe Applicant  
2 ALFWEAR’s clothing is for cool and cold temperatures, and such misdescription  
3 would materially affect the decision to purchase the clothing.  
4

5 **FOURTH CAUSE OF ACTION**  
6 (Modification of Applicant’s Application)  
7 15 U.S.C. §1068

8 26. Applicant incorporates paragraphs 1 through 25 above.

9 27. With respect to Applicant’s application, Section 18 [15 U.S.C. §1068]  
10 provides that the TTAB “may modify the application . . . by limiting the goods or  
11 services specified therein. . . . as the rights of the parties hereunder may be  
12 established in the proceedings.”

13 28. In the event the TTAB determines that there is a likelihood of  
14 confusion, Opposer IBKUL requests that Applicant ALFWEAR’s application be  
15 modified based upon the actual use of marks in commerce and channels of trade to  
16 avoid a likelihood of confusion.

17 29. If necessary, Opposer IBKUL requests that the TTAB restrict  
18 Applicant ALFWEAR’s application to avoid any likelihood of confusion with  
19 Opposer’s IBKUL marks.

20 a. For instance, Applicant ALFWEAR’s application could be  
21 modified to state “*Cool and cold weather clothing*, namely, . . .”  
(Emphasis added).

22 b. Opposer’s marks (SN 90352188 and 90375694) identify goods  
23 as “Resortwear clothing and specialty activewear with cooling,  
24 wicking or sun protection technology for *warm to hot conditions* for  
25 golf, tennis or English equestrian riding, namely, vests, coverups,  
26 shirts, tops, and bottoms.” (Emphasis added).  
27



**FIFTH CAUSE OF ACTION**  
(False marking)

30. Applicant incorporates paragraphs 1 through 29 above.

31. It is an available ground for opposition that Applicant has misused the federal registration symbol with intent to deceive the purchasing public or others in the trade into believing that the mark is registered.

32. The owner of a trademark registered in the United States may display with the mark a notice of that registration, such as the registration symbol consisting of “the letter R enclosed within a circle.” 15 U.S.C. §1111.

33. On information and belief, Applicant ALFWEAR has misused the federal registration symbol ® with intent to deceive the purchasing public or others in the trade into believing that “KÜHL” is currently registered.

34. Opposer has hereby appointed Darren J. Quinn, Law Offices of Darren J. Quinn, 12702 Via Cortina, Suite 105, Del Mar, CA 92014, member of the bar of the State of California, as attorney in the matter of the opposition above-identified, to prosecute said opposition, to transact all business in the United States Patent & Trademark Office and in the United States courts in connection with this opposition, to sign his name to all papers which may hereinafter be filed in connection therewith, and to receive all communications relating to the same.
