NOTICE OF OPPOSITION

Opposer, ADM WILD Europe GmbH & Co. KG (“ADM WILD”), a limited liability partnership existing under the laws of Germany, located at Rudolf-Wild-Straße 107-115 D-69214 Eppelheim, Germany, and Opposer, WILD Flavors, Inc. (“WILD Flavors”), a licensee of ADM WILD’s WILD Marks, defined below, in the United States (collectively, the “Opposers”) believe they will be damaged by the proposed registration of Kerry Luxembourg S.à.r.l.’s (“Applicant”) application for the mark EVERWILD in International Classes 001, 029, and 030, Application Ser. No. 90266084 (“Application”) and hereby opposes registration of the same.

As grounds for opposition, Opposers allege:

1. Since long prior to the Application filing date of November 9, 2020, Opposers, including their predecessors-in-interest, related companies, and licensees, adopted, began using, and have continuously used the distinctive WILD Marks, as defined below, in interstate commerce within the United States, as well as in international commerce with the United States in connection with natural ingredients and flavors, including concentrates, manufacturing of flavorings, and consulting in the food and beverage industry.

2. Opposers are one of the largest producers of natural ingredients and flavors. Opposers produce a wide variety of fruit juice concentrates and blends, flavor and ingredient solutions, as well as other food and beverage ingredients, including natural flavors and extracts, mint oils and flavors, colors from natural sources, sweetening systems, seasonings, specialty ingredients, taste modifiers, and fermentation technologies. Furthermore, Opposers provide services such as manufacturing and consulting in the field of flavorings for the food and beverage industry. Opposers have a wide array of goods and services in the food and beverage industry, including concentrates, leading Applicant's goods to be within Opposers' registered goods and services.

3. Opposer, ADM WILD, is the owner of the trademarks WILD, WILD & Design, WILD WE CREATE GREAT TASTE & Design, and WILD WE CREATE GREAT TASTE & Design, including all of the common law rights of its known and continuous use and including U.S. Registration Nos. 1296602, 1586995, 3639953, and 2577208, respectively (the "WILD Marks"). Opposer, WILD Flavors, is the licensee of the above-mentioned marks.

4. U.S. Registration Nos. 1296602, 1586995, 3639953, and 2577208 are valid, subsisting, and incontestable pursuant to 15 U.S.C. §§ 1065 and 1115(b), and constitute *prima facie* evidence of the validity of the WILD Marks and of Opposer, ADM WILD's ownership of and exclusive right to use and to license others to use the WILD Marks in connection with the goods and services set forth in the registrations.

5. ADM WILD is the owner of the mark, WILD, including U.S. Registration No. 1296602 for "*fruit based liquid ingredient for use in the preparation of other foods*" in Class 029, which was first used at least as early as October 8, 1982. A registration certificate was issued on

September 18, 1984. A copy of the TSDR record for Registration No. 1296602 is annexed hereto as Exhibit 1.

6. ADM WILD is the owner of the mark, WILD & Design, including U.S. Registration No. 1586995 for “*food flavoring, namely, flavors [, aromas, essences and distillates,] not in the nature of essential oils*” Class 030 and for “*flavors, [aromas, essences and distillates,] not in the nature of essential oils for the preparation of soft drinks*” in Class 032, which was first used at least as early as May 29, 1984. A registration certificate was issued on March 13, 1990. A copy of the TSDR record for Registration No. 1586995 is annexed hereto as Exhibit 2.

7. ADM WILD is the owner of the mark, WILD WE CREATE GREAT TASTE & Design, including U.S. Registration No. 3639953 for “*non-alcoholic beverages, namely fruit drinks, fruit juices, fruit nectars, concentrates, syrups and powders use in the preparation of fruit drinks, fruit juices and fruit nectars*” in Class 032, which was first used at least as early as February 29, 2000. A registration certificate was issued on June 16, 2009. A copy of the TSDR record for Registration No. 3639953 is annexed hereto as Exhibit 3.

8. ADM WILD is the owner of the mark, WILD WE CREATE GREAT TASTE & Design, including U.S. Registration No. 2577208 for the “*manufacture of flavorings for foods and beverages to the order and specification of others*” in Class 040 and “*consulting in the field of flavorings for food and beverages an the development and design of flavorings for foods and beverages*” in Class 042, which was first used at least as early as May 1999. A registration certificate was issued on June 11, 2002. A copy of the TSDR record for Registration No. 2577208 is annexed hereto as Exhibit 4.

9. Collectively, the goods and services as outlined above in Paragraphs 5-8 are referred to herein as the “Opposers’ Goods and Services.”

10. Since long prior to the EVERWILD Application filing date of November 9, 2020, or any other date on which Applicant can rely, Opposers, including through their predecessors-in-interest, related companies, and licensees, have sold substantial volumes of products and services under or in connection with the WILD Marks and have spent a substantial amount of money advertising and promoting the products and services under or in connection with the WILD Marks.

11. In addition to the inherent distinctiveness of Opposers' WILD Marks, as a result of Opposers' extensive manufacturing, purchasing, transporting, storing, processing, merchandising, marketing, promoting, and sale of its goods and services in the food and beverage industry under or in connection with the WILD Marks, the WILD Marks have become extremely well known to consumers and have acquired secondary meaning identifying Opposers and their goods and services long prior to the November 9, 2020 application filing date of Application Serial No. 90306847, as well as any other date on which Applicant can rely.

12. ADM WILD owns all right, title, and interest in and to the WILD Marks, as well as the goodwill associated therewith.

13. Upon information and belief, Applicant is a limited liability company organized in the country, Luxembourg, located and doing business at 17 Rue Antoine Jans, Luxembourg, Luxembourg L-1820.

14. On November 9, 2020, Applicant filed a 1(b) intent-to-use application for EVERWILD, Application Serial No. 90306847, for "*Chemical preparations for preserving foodstuffs; chemicals for use in agriculture and horticulture, except fungicides, herbicides, insecticides and parasiticides; food preservatives; antioxidants, preservatives and mould inhibiting chemicals, all for use in the manufacture of human, animal and poultry foodstuffs; antioxidant and micro-organism cultures for use in the manufacture of foodstuffs; mould inhibiting*

chemical control agents, for food or foodstuffs; antioxidants for use in manufacture of food for humans; plant extracts for use in the manufacture of food; bacterial cultures for addition to food products for the food industry; milk ferments for the food industry; milk ferments being bacteria preparations for use in making foodstuffs; plant extracts, namely, liquid and powder citrus extract preparations used in food, beverages; starter micro-organism cultures for the manufacture and treatment of food products; lactic acid seed culture for use in food processing” in Class 001; “Fermented vegetables; fermented celery; fermented milk; fermented dairy products, namely, cultured buttermilk, sour cream, yogurt, and cheeses” in Class 029; and “Vinegar” in Class 030 (“Applicant’s Goods”).

15. Applicant’s use of and its application to register the EVERWILD Mark for the Applicant’s Goods, specifically the Class 001 Goods, are without Opposers’ consent, authorization, or permission.

16. Applicant’s use and/or registration of the EVERWILD Mark for the Applicant’s Class 001 Goods is likely to cause confusion, mistake, or deception with Opposers, Opposers’ Goods and Services, and/or the WILD Marks, in that consumers are likely to believe that Applicant’s Goods are sponsored, authorized, licensed, or in some other way legitimately connected with Opposers or Opposers’ Goods and Services.

17. Additionally, on information and belief, Applicant has intentionally adopted and applied for the EVERWILD Mark in bad faith and with full knowledge of Opposers’ prior rights in the WILD Marks in a manner intended to trade on Opposers’ goodwill, and create an association with Opposers and the WILD Marks and goods.

18. Opposers are and will be damaged by the registration of the EVERWILD Mark for Applicant’s Goods.

PRAYER FOR RELIEF

WHEREFORE, registration by Applicant of the mark EVERWILD for “*Chemical preparations for preserving foodstuffs; chemicals for use in agriculture and horticulture, except fungicides, herbicides, insecticides and parasiticides; food preservatives; antioxidants, preservatives and mould inhibiting chemicals, all for use in the manufacture of human, animal and poultry foodstuffs; antioxidant and micro-organism cultures for use in the manufacture of foodstuffs; mould inhibiting chemical control agents, for food or foodstuffs; antioxidants for use in manufacture of food for humans; plant extracts for use in the manufacture of food; bacterial cultures for addition to food products for the food industry; milk ferments for the food industry; milk ferments being bacteria preparations for use in making foodstuffs; plant extracts, namely, liquid and powder citrus extract preparations used in food, beverages; starter micro-organism cultures for the manufacture and treatment of food products; lactic acid seed culture for use in food processing*” in Class 001, Serial No. 90306847, would be damaging to Opposers. Opposers respectfully request that the opposition be sustained and registration to Applicant be refused.
