

**NOTICE OF OPPOSITION**

Opposer, Jean Patou ("Opposer"), a société par actions simplifiée of France with its principal place of business at 24/32 rue Jean Goujon, Paris, France 75008 believes it will be damaged by registration of the mark ENJOY BETTER for the Class 3 goods in Serial No. 90/458,528 and hereby opposes the same, in accordance with Section 13 of The Trademark (Lanham) Act of 1946, 15 U.S.C. § 1063.

As grounds for the opposition, Opposer alleges as follows:

1. Upon information and belief, Enjou LLC ("Applicant") is a limited liability company of Ohio with its principal place of business at 38580 Gaelic Glen, Solon, Ohio 44139.

2. As evidenced by the publication of Serial No. 90/458,528 in the Official Gazette of December 7, 2021, Applicant seeks to register ENJOY BETTER (the "Opposed Mark") in connection with the following goods:

Class 3: Cosmetic creams; Cosmetic oils; Cosmetic preparations; Cosmetic preparations for body care; Cosmetic soaps; Cosmetics in the form of milks, lotions and emulsions; Eye cream; Pet fragrances; Skin and body topical lotions, creams and oils for cosmetic use; Skin conditioning creams for cosmetic purposes; Skin masks; Skin moisturizing gel; Skin softeners; Toothpastes; Body and beauty care cosmetics; Deodorizers for pets; Non-medicated diaper rash ointments and lotions; Non-medicated eye-washes; Non-medicated mouth washes; Non-medicated dental preparations for pets, namely, toothpaste, mouth washes, and preparations for removing plaque; Non-medicated grooming preparations for pets, namely, shampoos, deodorizers, creams, oils, and lotions; Non-medicated mouth washes for pets; Non-medicated, non-veterinary grooming preparations in the nature of pet shampoo and conditioner; Wrinkle removing skin care preparations

Class 5: Anti-itch ointment; Bandages for skin wounds; Dermatologicals; Eye compresses; Eye drops; Medicated diaper rash ointments and lotions; Medicated eye washes; Muscle-rub preparations for the relief of pain; Vitamin preparations; Vitamins; Dietary food supplements; Dietary supplements for pets; Flea and tick treatment preparations for pets; Food supplements; Herbal anti-itch and sore skin ointment for pets; Homeopathic supplements; Medicated brush-on oral care gels; Medicated shampoos for pets; Mineral food supplements; Nutritional supplements for pets; Pharmaceutical preparations for the treatment of worms in pets; Powdered nutritional supplement drink mix and concentrate; Preparation for the relief of pain; Sore skin ointment for pets; Sports cream for relief of pain; Vitamin supplements

Class 30: Coffee; Tea; Coffee and coffee substitutes;  
Coffee based beverages; Hot chocolate

This opposition pertains to the Class 3 goods only.

3. Upon information and belief, Applicant filed Serial No. 90/458,528 on January 11, 2021 based on both use of and an intent to use the Opposed Mark in commerce in connection with the goods. The applicant subsequently amended the filing basis to only an intent to use the Opposed Mark.

4. For over 89 years prior to the filing date of the Opposed Mark, Opposer adopted and continuously has used the mark JOY in connection with its goods sold in the United States.

5. Opposer is the owner of the following U.S. Trademark Registrations for its JOY and JOY-formative marks (the "JOY Marks"). Printouts from the USPTO's TESS database showing the current status and title of these registrations are attached.

Registration No. 0529337 for JOY for "perfumes and toilet water" in Class 3, an incontestable registration (see Exhibit A);

Registration No. 4516831 for JOY FOREVER for "perfumes, perfumery, cosmetics" in Class 3, which has a priority date of December 19, 2012 (see Exhibit B);

Registration No. 5043389 for JOYFUL MOMENTS for "perfumes; perfumed cosmetics excluding skin care products for professional use, namely, aftershave, bath gel, shower gel, bath foams and deodorants for personal use; perfumed toilet soap" in Class 3 (see Exhibit C);

Registration No. 5255628 for JOY for "bar soap; body cream" in Class 3 (see Exhibit D);

Registration No. 5320536 for MADE WITH JOY for "clothing, namely, headwear, neckwear, swimwear, beachwear, footwear, nightwear, underwear, lingerie; sportswear, namely, polo shirts, rugby shirts, golf shirts, golf shorts, golf pants, golf caps, tennis wear, ski wear, athletic tops and bottoms for rowing; rainwear, gowns, skirts, dresses, shirts; bridal gowns, veils and garters; t-shirts; knitwear, namely, jumpers, cardigans; leggings, jeans, trousers, coats, jackets; menswear, namely, suits, waistcoats; footwear, shoes, boots, sneakers, gloves, capes, mittens, scarves, hats, caps, hosiery socks, shawls, ponchos, bandanas and belts for wear" in Class 25, which has a priority date of February 25, 2016 (see Exhibit E);

Registration No. 5907017 for JOY DIOR Stylized for "Perfumery; make-up; cosmetics" in Class 3, which has a priority date of August 3, 2018 (see Exhibit F);

Registration No. 5941498 for JOY and Design for "perfume; eau de parfum; toilet water; cologne; cosmetic creams; body gels; oils for cosmetic purposes; beauty milk; beauty lotions; personal deodorants; cosmetic masks; cosmetics; hair lotion; make-up preparations; cleansing milks and make-up removing lotions; shaving soap; aftershave lotions and balms" in Class 3, which has a priority date of May 4, 2018 (see Exhibit G); and

Registration No. 6533605 for JOY TO THE WORLD for "Perfumery, make-up preparations, cosmetics" in Class 3, which has a priority date of January 22, 2020 (see Exhibit H).

6. The above-identified registrations are valid, subsisting, uncancelled and are evidence of Opposer's exclusive right to use the JOY Marks in commerce in connection with the goods specified in the registrations.

7. Opposer's use of the JOY Marks has not been abandoned. Opposer has sold its goods through online and brick and mortar retailers throughout the United States, and Opposer's goods are

associated with the JOY Marks among customers and the relevant trade.

8. In addition to its registered trademark rights, Opposer owns non-registered statutory and common law rights in and to the JOY Marks in the United States.

9. Applicant has no license, consent or permission from Opposer to use or register the Opposed Mark.

10. The Opposed Mark so resembles the JOY Marks that it is likely to cause confusion, or to cause mistake or to deceive within the meaning of Section 2(d) of The Trademark (Lanham) Act of 1946, 15 U.S.C. § 1052(d), when used on or in connection with the Applicant's Class 3 goods covered by Serial No. 90/458,528; furthermore, the Opposed Mark and use thereof will cause the trade and purchasing public to believe that the Applicant's Class 3 goods covered by Serial No. 90/458,528 are authorized, licensed or sponsored by Opposer.

11. By reason of all the foregoing, Opposer will be gravely damaged by the registration of the Opposed Mark for the Class 3 goods identified in Serial No. 90/458,528, because registration of that mark would be in violation of Opposer's trademark rights.

WHEREFORE, Opposer prays that this Notice of Opposition be sustained in favor of Opposer and that the Class 3 goods in Serial No. 90/458,528 be denied registration. Opposer submits

herewith its payment of the \$600 filing fee, as required by 37  
C.F.R. §2.6(a)(17).
