NOTICE OF OPPOSITION


Valentino S.p.A., an Italian corporation, (hereinafter “Valentino”) with an address at Via Turati 16/18, I-20121, Milano, Italy, believes that it will be damaged by registration of the mark valentine ideal (hereinafter the “Applicant’s Mark”) for “Hair piece bonding glue” in International Class 3 as set forth in Application Serial No. 90/810,015, filed on July 3, 2021, and published on May 3, 2022 (hereinafter the “Application”), owned by Valentino Ideal, a Florida Limited Liability Company, with an address at 525 71st unit 414815, Miami Beach, FL 33141 (hereinafter the “Applicant”), and hereby opposes the same. As grounds for this opposition, it is alleged that:

1. Since long prior to the filing date and date of first use in commerce claimed in the Application, Valentino has extensively used, advertised and promoted the mark "VALENTINO" amongst others for cosmetics, perfume, clothing, accessories and other goods (the "VALENTINO Marks").

2. Valentino is the owner and user (by assignment or otherwise) of the following U.S. registrations, among others:

- Registration No. 899,841, registered on September 29, 1970 for VALENTINO for "perfume" in Class 3 (Exhibit A-1);
- Registration No. 901,896, registered on November 3, 1970 for VALENTINO for "eau de cologne" in Class 3 (Exhibit A-2); and



- Registration No. 4,232,022, registered on October 30, 2012 for  ,
for "fragrances, namely, perfumes, eau de cologne" in Class 3 (Exhibit A-3).

3. Each of the above-mentioned registrations is valid and subsisting and all are incontestable. Print outs from the electronic database provided by the U.S. Patent and Trademark Office showing current status and title of the registrations listed above are attached as Exhibit A-1 to A-3 and are incorporated herein by reference and for purpose of reliance.

4. Since at least as early as 1959, Valentino has been synonymous with high fashion apparel and merchandise. Over time, Valentino has earned extensive critical review and acclaim for its VALENTINO Marks.

5. Valentino has prominently and extensively used, advertised and promoted its marks in commerce. The VALENTINO Marks are regularly advertised in leading fashion magazines such as *Vogue*, *Elle*, *Marie Claire*, *Cosmopolitan*, and *GQ*. Valentino also makes consistent use of its VALENTINO Marks on promotional items.

6. Valentino has spent millions of dollars on advertising, promoting and marketing its products under its VALENTINO Marks in the United States.

7. By virtue of the uncompromising and prestigious quality of the goods sold, advertised, and promoted under the VALENTINO Marks and by virtue of the extensive sales, promotion and advertising of such high quality goods for more than sixty years, the VALENTINO Marks have become well-known and have acquired extensive fame, recognition and strength throughout the United States.

8. Valentino's use of the VALENTINO Marks in commerce long predates the filing date and date of first use in commerce claimed in the Application. Therefore, Valentino has priority.

9. Applicant has no connection with Valentino and no permission or license was given by Valentino to Applicant to use Applicant's Mark.

10. Valentino's use of the VALENTINO Marks in connection with cosmetics, perfumes, clothing, accessories and other goods is such that members of the public will perceive Applicant's Mark in close proximity with the VALENTINO Marks and mistakenly assume that Applicant's Mark emanates from Valentino and is one of the famous VALENTINO Marks.

11. Applicant's Mark so closely resembles Valentino's previously used and registered marks that its use, in connection with the goods aforementioned, is likely to cause confusion, or to cause mistake or deceive, in violation of Section 2(d) of the Trademark Act of 1946, 15 U.S.C. § 1052(d). Purchasers likely will assume that Valentino is somehow affiliated with, licenses, or endorses, Applicant's use of Applicant's Mark when Valentino is not connected in any way with Applicant or the use of Applicant's Mark.

12. Applicant's Mark so resembles the VALENTINO Marks that the use and registration thereof is likely to cause confusion, mistake and deception as to the source or origin of Applicant's goods and will injure and damage Valentino and the goodwill and reputation symbolized by the VALENTINO Marks.

13. The goods in the Application are so related to the goods of Valentino that the public is likely to be confused, to be deceived, and to assume erroneously that Applicant's goods are those of Valentino or that Applicant is in some way connected with or sponsored by or affiliated with Valentino.

14. Likelihood of confusion in this case is enhanced by the extraordinary fame of Valentino's VALENTINO Marks and, by the fact that consumers associate these marks with the goods sold, approved or endorsed by Valentino.

15. The VALENTINO Marks are famous and became famous before the filing date of the Application.

16. On information and belief, Applicant will use Applicant's Mark in commerce with the willful intent to trade on Valentino's reputation or to cause dilution of Valentino's famous VALENTINO Marks.

17. Use and registration of Applicant's Mark will lessen the capacity of Valentino's famous VALENTINO Marks to identify and distinguish Valentino's goods.

18. Use and registration of Applicant's Mark will deprive Valentino of the ability to protect its reputation and goodwill.

19. The use of Applicant's Mark is likely to cause dilution by blurring of Valentino's famous VALENTINO Marks in violation of Section 43(c) of the Trademark Act, 15 U.S.C. §1125(c), and is likely to prejudice the distinctiveness and/or harm the reputation of Valentino's famous VALENTINO Marks.

20. The registration of Applicant's Mark will therefore be inconsistent with Valentino's rights in the VALENTINO Marks, the registrations pleaded above and Valentino's rights at common law and will be damaging to Valentino.

WHEREFORE, Valentino prays that this opposition be sustained and registration on the Application be refused.
