NOTICE OF OPPOSITION

Opposer Ate My Heart Inc. ("Opposer" or "AMH"), a corporation organized under the laws of the State of California, with its principal place of business at c/o Pryor Cashman LLP, 7 Times Square, New York, NY 10036, believes that it will be damaged by registration of the mark shown in Application Serial No. 97/016,246 and hereby opposes the same. The grounds for opposition are as follows:

- 1. AMH is a corporation owned by the internationally-renowned recording artist, actress, performer, and fashion and beauty icon Stefani Germanotta p/k/a Lady Gaga. Her albums have been certified Diamond and Multi-Platinum around the world, and she has won several prestigious awards, including multiple Grammy Awards, Golden Globe Awards, and an Academy Award.
- 2. In 2008, Lady Gaga instantly became a household name with the debut of her single, *Just Dance*, which sold 14.8 million copies worldwide, followed by the full-length album *The Fame*. The single *Just Dance* was a massive club hit by the time it debuted on the *Billboard*

Hot 100, reaching number one by January 2009. Lady Gaga's follow-up single, Poker Face, topped singles charts across the board, and two additional tracks, LoveGame and Paparazzi, also broke the Billboard Top Ten. Lady Gaga released an EP album, The Fame Monster, in November 2009 that the Recording Industry Association of America (RIAA) certified as Platinum. Three singles from that album, Bad Romance, Telephone and Alejandro, all hit the Top Ten. Lady Gaga's album Born This Way, released in 2011, has sold over 6 million copies worldwide. The single Born This Way debuted at number one on the Billboard Hot 100, and at the time of its debut, it was the fastest selling single in iTunes history. Lady Gaga subsequently released the albums Artpop (2013) and Cheek to Cheek (with Tony Bennett) (2014), which both sold over 1 million records worldwide and received widespread critical acclaim.

- 3. In 2016, Lady Gaga released her fifth studio album, *Joanne*, which reached No. 1 in the United States. In reaching this achievement, Lady Gaga became the first female to have four No. 1 albums in the nation during the 2010s.
- 4. In 2018, Lady Gaga released the soundtrack to *A Star Is Born*, a critically-acclaimed film in which she co-starred along with Academy Award nominated actor Bradley Cooper. The soundtrack to *A Star Is Born* debuted at No. 1 on the *Billboard 200* chart. Lady Gaga was awarded an Oscar award for Best Original Song at the Academy Awards in connection with her song *Shallow* from the film *A Star Is Born*. In addition, Lady Gaga won an award for Best Actress at the Critics' Choice Awards and has been nominated for several industry awards for her performance including a Golden Globe nomination for Best Actress.
- 5. At the Grammy Awards in 2020, Lady Gaga won awards for the Best Song Written For Visual Media for her song *I'll Never Love Again* from the film *A Star Is Born*, and Best Compilation Soundtrack For Visual Media for the soundtrack for *A Star Is Born*.

- 6. In 2020, Lady Gaga released her sixth studio album, *Chromatica*, which reached No. 1 on the *Billboard 200* chart. At the Grammy Awards in 2021, *Chromatica* garnered a Grammy Award nomination for "Best Pop Vocal Album," and Lady Gaga won her second Grammy Award for Best Pop Duo/Group Performance, making history as being part of the first female collaboration to win the award.
- 7. Lady Gaga has sold more than 36 million albums and over 140 million singles worldwide. *Time* magazine has included Lady Gaga in its annual list of the "Most Influential People in the World," and *Forbes* has identified her as one of the "100 Most Powerful and Influential" celebrities in the world. On more than one occasion, *Forbes* has placed Lady Gaga on its annual list of the "World's 100 Most Powerful Women." In 2013, Lady Gaga topped *Forbes*' list of the "Top-Earning Celebrities Under 30." In 2015, *Billboard* named Lady Gaga as the 2015 Woman of the Year.
- 8. In 2018, Lady Gaga announced her Las Vegas residency at the new Park MGM Resort. Lady Gaga performed dozens of shows at the Park Theater over the course of 2019 and 2020. The residency comprised two different shows, the majority of which was "Lady Gaga Enigma," which was billed as "a brand-new odyssey of her pop hits built as an experience unlike any other." In August 2021, she announced her return to residency in Las Vegas at the Park MGM Resort for the "Lady Gaga Jazz & Piano" residency.
- 9. Lady Gaga has also earned many additional music industry awards and accolades, including Grammy Awards for Best Female Pop Vocal Performance in 2010 for *Bad Romance*, Best Pop Vocal Album in 2010 for *The Fame Monster*, Best Electronic/Dance Album in 2009 for *The Fame*, and Best Dance Recording in 2009 for *Poker Face*. She received three Grammy nominations, including nominations for Album of the Year and Best Pop Vocal for *Born This Way*

and Best Pop Solo Performance for the single *You and I*. Lady Gaga is also the first female to receive the Digital Diamond Award from the RIAA. To date, Lady Gaga has earned 13 Grammy Awards and 34 nominations. In 2020, Lady Gaga was also awarded the first-ever Tricon Award at the MTV Video Music Awards for her contributions to fashion, music, and activism. In total, she has won 18 MTV Video Music Awards, three People's Choice Awards, and the Songwriters Hall of Fame's Contemporary Icon Award for "attaining an iconic status in pop culture," just to name a few.

- 10. In 2022, Lady Gaga was awarded Best Actress at the New York Film Critics Circle Awards and nominated for Best Actress in a Motion Picture-Drama at the Golden Globe Awards and the Critics' Choice Movie Awards for her role in the film *House of Gucci*.
- 11. Lady Gaga offers for sale clothing, headwear, and hair accessories, under the LADY GAGA mark, including through her website located at <ladygaga.com> and/or through her licensees.
- 12. Lady Gaga has garnered tremendous amounts of unsolicited publicity for her cutting-edge, fashion-forward attire and her unique design sensibilities. Lady Gaga has been featured on the covers of several prominent magazines, many of which several times, including but not limited to *Vogue*, *Elle*, *Vanity Fair*, *Glamour*, *GQ*, *Rolling Stone* and *Esquire*.
- 13. Lady Gaga promotes herself throughout the United States via the Internet, including, but not limited on Facebook, Instagram, Twitter, as well as other social media.
- 14. AMH has continuously and substantially used the mark LADY GAGA in interstate commerce since at least as early as 2006.

15. AMH is the owner of the following federal trademark registrations for marks that include the term GAGA (hereinafter referred to as the "LADY GAGA Marks" and the "LADY GAGA Registrations"):

- 16. True and correct copies of the LADY GAGA Registrations, which are valid and subsisting, and the TSDR reports for the LADY GAGA Registrations are attached hereto as Exhibit A. AMH hereby gives notice in accordance with Trademark Rules of Practice 2.122(d)(2) that it will rely upon the LADY GAGA Registrations and TSDR reports as evidence in this proceeding, and a status copy showing present title will be introduced into evidence on its behalf during AMH's testimony period. Furthermore, these registrations are valid, subsisting, and in full force and effect and serve as evidence of AMH's exclusive right to use the marks in commerce on or in connection with the goods and services identified in the LADY GAGA Registrations, as provided by 15 U.S.C. § 1115(a).
- 17. AMH uses the LADY GAGA Marks for a wide variety of goods and services, and through its exclusive use of the LADY GAGA Marks throughout the United States, AMH has developed extensive common law rights in the LADY GAGA Marks.
- 18. As a result of Lady Gaga's dominance of the music industry, including her soldout musical performances and concert tours, platinum selling albums, her national and
 international public and media appearances, her recognition as an award-winning actress, her
 status as an entrepreneur and fashion icon, and the solicited and unsolicited publicity she has
 received, the LADY GAGA Marks have become well-known by the general public and in the
 relevant industries, are recognized and relied upon as identifying AMH's goods and services and
 as distinguishing them from the goods and services of others, and have come to represent and
 symbolize extremely valuable goodwill belonging exclusively to AMH.
- 19. AMH has spent substantial time, effort and money promoting its goods and services under the LADY GAGA Marks. Through these efforts, the LADY GAGA Marks have become famous within the meaning of Section 43(c) of the Lanham Act, as amended 15 U.S.C. § 1125(c).

- 20. Upon information and belief, Applicant SHENZHEN QIANHAI BAYMAY CROSS BORDER ECOMMERCE LIMITED is limited company (ltd.) of China with an address of ROOM 201, BLDG A, NO.1, QIANWAN 1ST RD QIANHAI SHENZHEN-HONG KONG CO-OP ZONE SHENZHEN CHINA 518000.
- 21. On September 8, 2021, Applicant filed a Section 1(b) application for the mark GAGAFIT covering Class 25 "boots; dresses; gloves; headwear; hosiery; neckties; pants; scarfs; shirts; shoes; shorts; singlets; swimwear; t-shirts; trousers; underwear; baby bodysuits; baby bottoms; baby tops; belts for clothing; bottoms as clothing; clothing layettes; denim pants; evening dresses; girdles; masquerade costumes; maternity clothing, namely, shirts, pants, shorts; outerwear, namely, coats, hats, gloves; tops as clothing; wedding gowns; women's clothing, namely, shirts, dresses, skirts, blouses; yoga pants; yoga socks; yoga tops" (the "Application" or the "GAGAFIT Mark").
- 22. Despite AMH's long prior statutory and common law rights in the LADY GAGA Marks, Applicant, with both constructive and actual notice of the LADY GAGA Registrations, and long after AMH established rights in and to the LADY GAGA Marks, adopted and filed Application Serial No. 97/016,246 for registration of Applicant's GAGAFIT Mark.
- 23. AMH has continuously and exclusively used the LADY GAGA Marks in connection with its goods and services prior to Applicant's filing date. As such, AMH has priority.

FIRST CAUSE OF ACTION Registration Should Be Refused Further to 15 U.S.C. § 1052(d)

24. Applicant's GAGAFIT Mark is similar to the LADY GAGA Marks in sight, sound, meaning, and overall commercial impression.

- 25. The Application identifies goods that are identical and/or closely related to the goods identified in the LADY GAGA Registrations and the goods on which Opposer uses its famous LADY GAGA Marks.
- 26. The LADY GAGA Registrations and the Application are not limited with respect to channels of trade.
- 27. AMH and Applicant market and promote their respective goods to the general consuming public without regard to sophistication.
- 28. Applicant's use of the GAGAFIT Mark is likely to cause confusion, mistake or deception with consequent injury to AMH and the public. Such use and registration of the GAGAFIT Mark in connection with the goods identified in the Application is likely to cause consumers to mistakenly believe that Applicant's goods emanate from AMH or Lady Gaga, or that Applicant is in some way associated with or connected with AMH or Lady Gaga, when, in fact, no such relationship exists.
- 29. If Applicant is granted registration for the GAGAFIT Mark, it would obtain, thereby, at least a prima facie exclusive right to use the mark in connection with the goods identified in the Application. Such a registration would be a source of damage and injury to AMH.
- 30. Registration of the mark reflected in the Application should be refused pursuant to Section 2(d) of the Trademark Act of 1946, as amended, 15 U.S.C. § 1052(d), on the grounds that Applicant's GAGAFIT Mark so resembles the LADY GAGA Marks as to cause confusion, mistake and/or deception, all to the damage of AMH.

WHEREFORE, Opposer, by its undersigned attorneys, requests that its opposition to Application Serial No. 97/016,246 be sustained and that the Trademark Trial and Appeal Board

grant any and all further relief to Opposer that the Board finds necessary and just in the circumstances.


