Lulu’s Fashion Lounge, LLC (“Opposer”), a Delaware limited liability company having its principal place of business at 195 Humboldt Avenue, Chico, California 95928, believes that it will be damaged by the use and registration of the UNLILULU mark in Application Serial No. 97/014,428, filed by Shenzhen Undilulu Garment Co., Ltd. (“Applicant”), for “Bras; Bustiers; Sleepwear; Swimwear; Underwear; Baselayer bottoms; Clothing, namely, maternity bands; Gym pants; Maternity bras; Maternity clothing, namely, shirts, pants, shorts; Panties, shorts and briefs; Parts of clothing, namely, underarm gussets; Perspiration absorbent underwear clothing; Shapewear, namely, girdles, bras; Sports bra” in Class 25.

As grounds for the opposition, it is alleged as follows:

1. Opposer operates an e-commerce site that offers apparel, shoes, jewelry, and other accessories at the highest quality and value.

2. Since at least as early as August 31, 1996, and well prior to Applicant's filing date, Opposer has continuously promoted its LULU'S, LULUS, LULUS (stylized), LOVELULUS, and LULU'S (stylized) trademarks in commerce in the United States, in connection with clothing, fashion accessories, and related retail services. Through such continuous and widespread use and promotion of the LULU'S, LULUS, LULUS (stylized), LOVELULUS, and LULU'S (stylized) mark, Opposer has acquired common law rights in the LULU'S, LULUS, LULUS (stylized), LOVELULUS, and LULU'S (stylized) marks.

3. Opposer owns U.S. Registration No. 3,743,618 for the LULUS word mark for "Computerized on-line ordering featuring general merchandise and general consumer goods; computerized on-line ordering services in the field of clothing, shoes, jewelry and accessories; Computerized on-line retail store services in the field of clothing, shoes, jewelry and accessories" in Class 35. The application that matured to Registration No. 3,743,618 was filed on February 8, 2008, with a claimed first use and first use-in-commerce date of October 15, 2007, well prior to Applicant's filing date for Application Serial No. 97/014,428. On February 20, 2015, Opposer filed a Section 15 Affidavit for Registration No. 3,743,618, which was acknowledged by the United States Patent and Trademark Office on March 6, 2015. As a result, this registration is considered incontestable, and is conclusive evidence of the validity, the ownership, and of Opposer's exclusive right to use the LULUS mark in connection with the services specified in the registration. Attached hereto as Exhibit A is a true and correct copy of the registration certificate and a current print-out of the TSDR page for Registration No. 3,743,618.

4. Opposer owns U.S. Registration No. 4,719,183 for the LULUS word mark for "Clothing, namely dresses, tops, sweaters, vests, jackets, skirts, pants, jeans, shorts, leggings,

tights, socks, overalls, swimwear, rompers, jumpsuits, lingerie, and bodysuits; headwear, namely, hats; footwear, namely, shoes, boots, flip flops, and sandals” in Class 25. The application that matured to Registration No. 4,719,183 was filed on April 8, 2014, with a claimed first use and first use-in-commerce date of August 31, 1996, well prior to Applicant’s filing date for Application Serial No. 97/014,428. On January 11, 2021, Opposer filed a Section 15 Affidavit for Registration No. 4,719,183. As a result, this registration is considered incontestable, and is conclusive evidence of the validity, the ownership, and of Opposer’s exclusive right to use the LULUS mark in connection with the goods specified in the registration. Attached hereto as Exhibit B is a true and correct copy of the registration certificate and a current print-out of the TSDR page for Registration No. 4,719,183.

5. Opposer owns U.S. Registration No. 5,168,140 for the LULUS (stylized) mark for “Clothing, namely, dresses, tops, sweaters, vests, jackets, skirts, pants, jeans, shorts, leggings, tights, socks, overalls, swimwear, rompers, jumpsuits, lingerie, and bodysuits; headwear, namely, hats; footwear, namely, shoes, boots, flip flops, and sandals” in Class 25, and “Computerized on-line ordering featuring general merchandise and general consumer goods; Computerized on-line ordering services in the field of clothing, shoes, jewelry and hair, clothing, handbag, and eyewear accessories; Computerized on-line retail store services in the field of clothing, shoes, jewelry and hair, clothing, handbag, and eyewear accessories” in Class 35. The application that matured to Registration No. 5,168,140 was filed on March 30, 2016, with a claimed first use and first use-in-commerce date of June 1, 2016, well prior to Applicant’s filing date for Application Serial No. 97/014,428. On March 25, 2022, Opposer filed a Section 15 Affidavit for Registration No. 5,168,140. As a result, this registration is considered incontestable, and is conclusive evidence of the validity, the ownership, and of Opposer’s

exclusive right to use the LULUS (stylized) mark in connection with the goods specified in the registration. Attached hereto as Exhibit C is a true and correct copy of the registration certificate and a current print-out of the TSDR page for Registration No. 5,168,140.

6. Opposer owns U.S. Registration No. 5,690,666 for the LOVELULUS mark for “Clothing, namely, dresses, tops, sweaters, vests, jackets, skirts, pants, jeans, shorts, leggings, tights, socks, overalls, swimwear, rompers, jumpsuits, lingerie, and bodysuits; headwear, namely, hats; footwear, namely, shoes, boots, flip flops, and sandals” in Class 25, and “Computerized on-line ordering featuring general merchandise and general consumer goods; Computerized on-line ordering services in the field of clothing, shoes, jewelry and hair, clothing, handbag, and eyewear accessories; Computerized on-line retail store services in the field of clothing, shoes, jewelry and hair, clothing, handbag, and eyewear accessories” in Class 35. The application that matured to Registration No. 5,690,666 was filed on July 18, 2018, with a claimed first use and first use-in-commerce date of November 1, 2013 for Class 25, and September 17, 2013 for Class 35, both well prior to Applicant’s filing date for Application Serial No. 97/014,428. Attached hereto as Exhibit D is a current print-out of the TSDR page for Registration No. 5,690,666.

7. Opposer owns U.S. Registration No. 3,743,619 for the LULU’S (stylized) mark for “Computerized on-line ordering featuring general merchandise and general consumer goods; Computerized on-line ordering services in the field of clothing, shoes, jewelry and accessories; Computerized on-line retail store services in the field of clothing, shoes, jewelry and accessories” in Class 35. The application that matured to Registration No. 3,743,619 was filed on February 8, 2008, with a claimed first use date of August 31, 1996 and a first use-in-commerce date of November 1, 2005, both well prior to Applicant’s filing date for Application

Serial No. 97/014,428. On February 20, 2015, Opposer filed a Section 15 Affidavit for Registration No. 3,743,619, which was acknowledged by the United States Patent and Trademark Office on March 6, 2015. As a result, this registration is considered incontestable, and is conclusive evidence of the validity, the ownership, and of Opposer's exclusive right to use the LULU'S (stylized) mark in connection with the services specified in the registration. Attached hereto as Exhibit E is a current print-out of the TSDR page for Registration No. 3,743,619.

8. Opposer owns the goodwill and reputation of the goods and services connected with and symbolized by the above-referenced LULU'S, LULUS, LULUS (stylized), LOVELULUS, and LULU'S (stylized) marks (together, "the LULUS Mark"). As a result of extensive marketing, promotion, and sales of Opposer's clothing, accessories, and retail services offered under the LULUS Mark since at least as early as August 31, 1996, Opposer has built up highly valuable goodwill in the LULUS Mark, and said goodwill has become closely and uniquely identified and associated with Opposer and Opposer's goods and services.

9. Applicant filed Application Serial No. 97/014,428 for the UNLILULU mark on September 7, 2021, claiming first use and first use in commerce dates of April 1, 2021. The application was published in the *Trademark Official Gazette* on January 25, 2022.

10. By the application herein opposed, Applicant seeks to register the UNLILULU mark for "Bras; Bustiers; Sleepwear; Swimwear; Underwear; Baselayer bottoms; Clothing, namely, maternity bands; Gym pants; Maternity bras; Maternity clothing, namely, shirts, pants, shorts; Panties, shorts and briefs; Parts of clothing, namely, underarm gussets; Perspiration absorbent underwear clothing; Shapewear, namely, girdles, bras; Sports bra" in Class 25.

LIKELIHOOD OF CONFUSION

11. Since at least as early as August 31, 1996, substantially prior to Applicant's filing date and claimed first use and first use-in-commerce dates for the opposed UNDILULU application, Opposer has continuously offered and promoted in commerce its goods and services under the LULUS Mark.

12. Applicant's claimed first use and first use in commerce of the UNDILULU mark does not predate Opposer's common law rights in the LULUS Mark or the priority dates for the registrations for the LULUS Mark owned by Opposer.

13. Applicant's UNDILULU mark is highly similar to Opposer's LULUS Mark. "LULU" is the most distinctive element of Applicant's mark, and LULUS is the most distinctive element of each of Opposer's asserted marks. Each mark contains the LULU / LULUS element. The fact that the "LULU" element of Applicant's mark does not include the letter "S" is immaterial because the dominant term is "LULU," and the use of the letter "S" does not serve to differentiate the marks. In fact, LULU and LULUS are legally identical. The addition of "UNDI" is not sufficient to differentiate the marks because it is a descriptive phrase, particularly when Applicant intends to sell undergarments under the mark, and terms related to "undies" are commonly used in relation to undergarments. Thus, "UNDI" does not serve to differentiate the marks. Further, Applicant's UNDILULU mark may lead consumers to believe that Opposer has a division focused on undergarments, thereby increasing the likelihood of confusion. Applicant's Class 25 goods are also identical, complementary, or otherwise closely related to the clothing, accessories, and retail services offered by Opposer under its LULUS Mark.

14. Opposer is informed, believes, and on that basis alleges that Applicant's consumers for the goods identified in the opposed application likely consist of many of the same

consumers of Opposer's goods and services, who are already familiar with Opposer's LULUS Mark and the goods and services offered under that mark.

15. Opposer is informed, believes, and on that basis alleges that Applicant offers and distributes its goods through channels of trade that overlap with those used by Opposer to offer and distribute Opposer's LULUS goods and services, and that Applicant targets consumers of Opposer's LULUS goods and services for its own goods.

16. In view of the fact that Applicant's UNDILULU mark is confusingly similar to Opposer's LULUS Mark, that Applicant's and Opposer's respective goods and services are identical, complementary and/or closely related, that the consumers for Applicant's and Opposer's respective goods and services are the same or overlapping, and that Applicant and Opposer offer their respective goods and services through the same channels of trade, Applicant's UNDILULU mark is likely to cause confusion with Opposer's LULUS Mark, or to cause mistake or to deceive as to the origin, sponsorship, or approval of Applicant's goods. Opposer would thereby be injured by Applicant's registration of the UNDILULU mark in Application Serial No. 97/014,428.

17. WHEREFORE, Opposer prays that Application Serial No. 97/014,428 be rejected, and that this opposition be sustained in favor of Opposer.

18. Filing Fee: The USPTO is authorized to charge \$600.00 for the Notice of Opposition to Application Serial No. 97/014,428 to Morrison & Foerster LLP's Deposit Account 03-1952 (Reference No. 64861-6003.509).


