AFFIDAVIT OF RUZ SAFAI

I, Ruz Safai, declare as follows:

1. I am the Founder and Chief Executive Officer of OWN Your Hunger Inc., the company that markets products under the WONDERSPREAD mark.
2. I have personal knowledge of the facts set forth herein and provide this testimony in support of the registration of OWN Your Hunger Inc.’s (“OWN”) application for WONDERSPREAD.
3. I am involved in all aspects of the design, development, manufacturing, marketing, and sales for all products that bear the mark WONDERSPREAD.
4. I am involved in virtually all communications and interactions with OWN’s customers, affiliates, retailers, partner companies, and nearly all aspects of OWN’s operations.

5. The WONDERSPREAD mark is used in spreads and nut butters primarily derived and consisting of nuts, mixed with other ingredients such as chocolate and fruit-derived sweeteners, formulated to provide minimal calories by way of a novel method of fat replacement technology.

6. Spreads and nut butters bearing the WONDERSPREAD mark are sold through OWN's website, and advertised through marketing campaigns ran by the company's numerous ambassadors, and through the Amazon.com e-commerce platform.

7. Spreads and nut butters bearing the WONDERSPREAD mark spreads have been sold since April 2021 (for over two years), generating over \$1 million in retail sales.

8. On Amazon.com, an-e-commerce platform with over 310 million users where OWN generates the majority of its revenue, the WONDERSPREAD Peanut Butter Spread is the #1 Overall Pick for various search terms, including "low calorie peanut butter", with over 585 anonymous customer reviews, indicated in the attached EXHIBIT A.

9. The customers of WONDERSPREAD spreads are generally highly sophisticated in the areas of nutrition and caloric management and have a general understanding of reasons behind the brand's premium \$15 price tag for a 12 oz jar that bears the mark WONDERSPREAD.

11. Based on informal interviews with a random selection of customers I interact with on a nearly daily basis, most were aware of Opposer's trademarks, products, and their channels of sales, but were unaware of any instance of confusion between the WONDERSPREAD mark and the Opposer's WONDER mark, and any likelihood of confusion was essentially non-existent.

12. I consider myself an expert in the food manufacturing industry, and aware that ingredients frequently undergo significant transformations from their raw material form to become different finished products. For instance, raw ingredients consisting of sugars and fats that are sold under one set of trademarks, go through transformations to produce new dessert products such as cakes, cupcakes, and candy bars to be sold (without any likelihood of confusion) under an entirely different set of trademarks. Even in the case of nut butters that do use nuts as a raw material ingredient, the transformation processes involved does not make the raw ingredient the same as the transformed product.

11. OWN exports nut butters from Canada into the United States and is required to use tariff codes and categories that create significant distinctions between various types of nuts, to various types of preparations that include nuts, ranging from pastes to chocolates containing specific nuts.

12. Shown in the attached EXHIBIT B lists a significant set of registered marks, that clearly specify nuts, nut butters, and processed nuts as different and distinct product categories, as often as those registrations also list goods for equally distinct categories for “Fruit purees” (CALI ACAI, Registration No. 6982794), “Dried Beef” (CHESCRU, Registration No. 90496259), and “Facial Beauty Masks” (I LOVE ME ATTITUDE I ME ATTITUDE, Registration No. 6915499) that exist in the same registration and same set of listed goods under Goods and Services.

14. I am aware of a substantial number of registered trademarks, including trademarks in food-related categories sold in the same channels of trade as Opposer’s mark (such as grocery stores), all containing a variation of the word WONDER in the marks, that either co-exist without any

confusion, and/or were not opposed in their registrations by Opposer. Attached under EXHIBIT C is a substantial listing of third-party registered marks that contain the mark WONDER showing the significant prevalence and generic nature of the word WONDER that exists in the registered marks of numerous brands.

15. In the 2-year timespan and the tens of thousands of OWN's customers who have likely heard (or even purchased) Opposer's goods bearing the mark WONDER, I am not aware, through direct or indirect knowledge, any actual confusion between the WONDERSPREAD mark and any other third-party mark that contains the word WONDER.

I declare under the penalty of perjury under the laws of Canada and the United States of America that the foregoing is true and that this declaration was executed in Calgary, Canada on November 14, 2023.
