NOTICE OF OPPOSITION

Yard House USA, Inc. (“**Opposer**”), a corporation organized and existing under the laws of Delaware, with a business address at 1000 Darden Center Drive, Orlando, Florida 32837, United States, believes it will be damaged by and hereby opposes the registration of the stylized mark THE YARDERY (the “**Applied-For Mark**”), as shown in Application Serial No. 90/290,501 (the “**Application**”), filed on October 30, 2020, under Section 1(a) of the Trademark Act, and owned by The Yardery LLC (the “**Applicant**”), a limited liability company organized and existing under the laws of Florida, with an address at 9300 Conroy Windermere Rd # 3041, Windermere, Florida 34786 United States. The Application was published for opposition on May 10, 2022. Opposer timely filed a request for an extension of time to oppose, which expires on September 7, 2022.

As grounds for the Opposition, Opposer states:

Opposer’s Use and Registration of YARD HOUSE

1. Opposer owns the following trademark registrations for marks comprising or containing the inherently distinctive wording YARD HOUSE (the “**YARD HOUSE Marks**”) on the Principal Register:

2. Opposer’s registrations for the YARD HOUSE Marks are valid, subsisting, unrevoked, uncanceled, and in all instances, incontestable. Attached as **Exhibit A** to this Notice of Opposition are printouts of relevant sections from the USPTO database showing the current status and title of each of the registrations relied on in this Opposition. These registrations constitute *prima facie*, or in most instances, *conclusive*, evidence of Opposer’s exclusive right to use the marks in connection with the services specified in the registrations.

3. Based on its continuous and widespread use of its YARD HOUSE Marks in U.S. commerce for over twenty-five years, Opposer has established enormous goodwill in the YARD HOUSE Marks, and the YARD HOUSE Marks have become well and favorably recognized by

the public as identifying restaurants and related goods and services (the “**YARD HOUSE Services**”).

4. The YARD HOUSE Services have been offered and promoted throughout the United States by Opposer, having over eighty (80) locations in over twenty (20) states.

5. Opposer has developed a well-known business reputation throughout the United States and has dedicated time and effort throughout the years to advertise, market, and promote Opposer’s services in connection with the YARD HOUSE Marks.

6. The YARD HOUSE Marks are registered trademarks belonging to Opposer not only in the United States, but also in Canada, Cuba, India, the European Union, Saudi Arabia, Macao, the United Arab Emirates, Australia, New Zealand, Singapore, Malaysia, Panama, Taiwan, Peru, Brazil, the United Kingdom, China, Bahrain, and the Philippines, covering restaurant services and related services.

7. As a result of these efforts, Opposer’s YARD HOUSE Marks have become a distinctive and strong indicator of Opposer’s YARD HOUSE Services, and are therefore a valuable symbol of Opposer’s goodwill. The YARD HOUSE Marks are of significant value to Opposer.

8. Through use by Opposer of its YARD HOUSE Marks for the YARD HOUSE Services, consumers associate such marks with a single source, namely, the Opposer.

The Application

9. By the Application herein opposed, Applicant seeks to register the Applied-For Mark in connection with “restaurant services” in Class 43 (the “**Applied-For Services**”).

10. The Application was filed on October 30, 2020, based on a use basis in U.S. commerce.

11. Opposer herein opposes all of Applicant's Applied-For Services in Class 43 (the **Opposed Services**”).

LIKELIHOOD OF CONFUSION - 15 U.S.C. §1052(d)

12. Opposer repeats and realleges the allegations set forth in paragraphs 1 through 11 as if fully set forth herein.

13. Opposer's registrations for, adoption, and use of its YARD HOUSE Marks in connection with the YARD HOUSE Services predate the filing date of the Application. As a result, Opposer's rights to the YARD HOUSE Marks are superior to any rights Applicant may have in the Applied-For Mark.

14. Opposer's YARD HOUSE Marks and Applicant's Applied-For Mark are confusingly similar, with prominent use of "YARD" in both marks. For at least this reason, the respective marks look and sound similar and convey similar commercial impressions.

15. Applicant's Applied-For Mark covers services that are identical to Opposer's YARD HOUSE Services, namely, "restaurant services." It is conceivable that the Applicant's Applied-For Mark, used in connection with identical services, could be associated with Opposer's YARD HOUSE Marks, which are strongly associated with a casual and fun sports bar with over 100 drafts on tap. As a result, the Application covers services that consumers could reasonably expect to come from the same source as Opposer's services. In addition, the Applied-For Services may be offered to, or used by, at least similar or overlapping potential consumers through at least similar or overlapping trade channels and may utilize at least similar or overlapping marketing channels as Opposer's services.

16. Upon seeing Applicant's Applied-For Mark, consumers and prospective consumers may be likely to believe, erroneously, that Applicant's services offered under the Applied-For Mark emanate from, are connected, associated or affiliated with, or are in some way approved or sponsored by, Opposer, all to Opposer's irreparable damage, including through the impairment of its goodwill, as symbolized by Opposer's Prior Mark.

17. If the Applied-For Mark is allowed to register, consumers and prospective consumers may be likely to believe, erroneously, that the Opposed Services offered under THE YARDERY mark opposed herein emanate from, are connected, associated, or affiliated with, or are in some way approved or sponsored by Opposer, or that they emanate from the same source as Opposer's registered YARD HOUSE Marks, all to Opposer's damage.

18. Applicant's Applied-For Mark consists of a mark that is confusingly similar to Opposer's Prior Mark as to be likely, when used in connection with the Applied-For Services, to cause confusion, or to cause mistake, or to deceive consumers as to the source of the services. Accordingly, registration of Applicant's Applied-For Mark is prohibited under Section 2(d) of the Lanham Act.

WHEREFORE, for at least the above reasons, Opposer believes that it will be damaged by the registration of the Applied-For Mark, and requests that the Application be refused, and that this opposition be sustained.
