**REQUEST TO REVISIT CONSOLIDATION REQUEST
AS INDICATED BY THE BOARD**

Applicant Shanghai Zhenglang Technology Co., Ltd. (“Applicant”) respectfully requests that the Board revisit the consolidation request for the above-captioned proceeding and Opposition No. 91276251. In its November 20, 2024 order suspending these proceedings, the Board indicated it would revisit consolidation upon the final disposition of Opposition No. 91272143 and the motion to strike in Opposition No. 91276251. *See* 32 TTABVUE 1. Since that order, the Board has issued a decision in Opposition No. 91272143 and the motion to strike was resolved in Opposition No. 91276251. As such, the motion to consolidate is now ripe to revisit.

Further supporting consolidation, Applicant withdrew the Block Puzzle marks in Opposition No. 91276251, leaving only the following mark:



As a result, the remaining marks are visually similar, as shown in the chart below, and the Board's analysis of the three applications will likewise be substantially the same.
