**OPPOSER PARADISE INTERNATIONAL GENERAL TRADING LLC’S
MOTION FOR SUMMARY JUDGMENT**

I. INTRODUCTION

Opposer PARADISE INTERNATIONAL GENERAL TRADING LLC (“Opposer”) hereby moves for partial summary judgment and an order sustaining the Opposition and refusing registration of Applicant TEVEL BRANDS LTD’s (“Applicant”) applied for Mark, NEO HAIR LOTION (“NEO HAIR LOTION Mark”; or the “Mark”), pursuant to Federal Rule of Civil Procedure 56 and Trademark Rule 2.127(e).

Opposer initiated this proceeding by filing its Notice of Opposition on January 17, 2023 [TTABVUE 1] against Applicant’s application to register the Mark in Class 5 for “Hair root nutrient lotion, namely, medicated hair lotions for the treatment of hair loss and baldness” (“Serial No. 97/072,320, the “Application”). Opposer subsequently filed a First Amended Notice of Opposition on March 8, 2023 [TTABVUE 8] and a Second Amended Notice of Opposition on September 7, 2023 [TTABVUE 19].

Thereafter, Opposer conducted the following discovery, which it now submits to the Board, pursuant to Trademark Rule 2.127(e)(2) and TBMP § 528.05(c), as evidence in support of this motion:

III. ISSUE PRESENTED

Whether the Board should refuse Applicant's Application for the Mark NEO HAIR LOTION, *Serial No. 97/072,320*, on the ground that Applicant is not the rightful owner of the NEO HAIR LOTION Mark.

IV. STATEMENT OF FACTS

Mr. Paiboon Maraprygsavan founded and owns Green Wealth Healthcare Co., Ltd. ("GW Healthcare") and Paiboon Polymedical Co., Ltd. GW Healthcare retains direct control over the production, distribution, and quality assurance of products sold under the NEO HAIR LOTION and GREEN WEALTH trademarks.

GW Healthcare authorized Opposer to market, sell, and distribute the products associated with the NEO HAIR LOTION and GREEN WEALTH trademarks globally, including in the United States. *[Exhibit A]*. Mr. Paiboon Maraprygsavan also authorized Opposer to register intellectual property, including copyrights, designs, and trademarks, worldwide *[Exhibit B]*. Opposer has since registered the GREEN WEALTH NEO HAIR LOTION and GREEN WEALTH marks in multiple jurisdictions. *[Exhibit C]*.

In response to Opposer's Discovery requests, Applicant produced a Declaration signed by Mrs. Pawichaya Jinda of Green Wealth International Co., Ltd. on February 21, 2023- which states:

"... 2) I am the Director of the Company Green Wealth International Co., Ltd., which is an authorized distributor of Green Wealth Health Care Co., Ltd., Owner of the "Neo Brand. ... 5) The "Neo" Green Wealth Health Care Co., Ltd., products are manufactured by Green Wealth Health Care Co., Ltd., sold to Green Wealth International Co., Ltd., who in turn sells to SHOP – VIDEOAD Address – 1 Moses Dayyan Haifa 2629801 Israel." *[Exhibit I]*.

Additionally, in Applicant's Response to Opposer's Interrogatories, Applicant admitted that:

"Applicant has authorization from Greenwealth International Co., Ltd., ...who purchases the products from the manufacturer of Green Wealth Health Care Co., Ltd" *[Exhibit D. P.3. No. 7]*

"[Applicant] distributes and sells products manufactured by Green Wealth Health Care Co., Ltd. and sold by Green Wealth International Co., Ltd." *[Exhibit D., P.5. Nos. 16, 17]*

V. ARGUMENT

A. Opposer Has A Real Interest in This Proceeding

An Opposer must prove it has a real interest in the proceeding, and therefore standing to oppose a trademark application. *Ritchie v. Simpson*, 170 F.3d 1092, 50 USPQ2d 1023 (Fed. Cir. 1999). An Opposer may do so by showing, among other things, that it has previously had an application to apply for a trademark denied. *Lipton Industries, Inc. v. Ralston Purina Co.*, 670 F.2d 1024, 213 USPQ 185 (CCPA 1982).

Since at least February 2020, Opposer has continuously used the mark NEO HAIR LOTION, both as a standalone mark and in combination with the house mark GREEN WEALTH (e.g. GREEN WEALTH NEO HAIR LOTION), in U.S. commerce in connection with various medicated hair lotions, hair care lotions, hair care preparations, and hair lotion. In addition to its common law rights in the NEO HAIR LOTION mark, Opposer owns the following U.S. trademark applications for or that incorporate the NEO HAIR LOTION mark:

The USPTO rejected Opposer's above-listed applications in Office Actions dated June 1, 2022, citing Applicant's Mark. *Serial No. 97/072,320 APPLICATION*.

Opposer also owns U.S. Trademark Registration Nos. 6,764,102 and 6,748,454, and U.S. Trademark Serial No. 90/892,913, for the mark GREEN WEALTH.

Based on its common law rights, registered trademarks and pending applications, Opposer has a real interest in this proceeding and therefore has standing to bring this proceeding.

B. Applicant Is Not the Owner of the NEO HAIR LOTION Mark

Under 37 CFR § 2.271(d), “[a]n application filed in the name of an entity that did not own the mark as of the filing date of the application is void.” The Board cannot waive the statutory requirement that only the owner of a mark may file an application for registration thereof; further, the Board has not the power to excuse non-compliance with this rule. *See Huang*, 7 USPQ2d at 1336; *See also Great Seats, Ltd. v. Great Seats, Inc.*, 84 USPQ2d 1235 (TTAB 2007).

A trademark applicant must be the owner of the mark as of the application filing date. Ownership is determined by control over the nature and quality of the goods or services associated with the mark. *See TMEP* § 1201.03. *See Smith Int’l. Inc. v. Olin Corp.*, 209 USPQ 1033, 1044-45 (TTAB 1981).

In its Answer, Applicant admitted that it “obtain[s] products that they sell to consumers from the Green Wealth Suppliers.” [TTABVue 30 P4. No.50]. Further, in its Responses to Opposer’s First Set of Interrogatories, Applicant made the following admissions:

“The products are manufactured by Green Wealth Health Care Co., Ltd. [Exhibit C. No. 10].” “Applicant is provided products from Green Wealth International Co., Ltd., who purchases the products from the manufacturer of Green Wealth Health Care Co., Ltd. [id. No. 14].” “Applicant confirms that it distributes and sells products manufactured by Green Wealth Health Care Co., Ltd. and sold by Green Wealth International Co., Ltd.” “Application has authorization from Green Wealth

International Co., Ltd., who is the authorized and official sales manager responsible for distributions to customers outside of Thailand, who purchases the products from the manufacturer of Green Wealth Health Care Co., Ltd. *[id. Nos. 7, 16 and 17].*”

Applicant’s statements make clear that it acted solely as a sales agent for Green Wealth International Co., Ltd. However, as a mere distributor of the foreign manufacturer’s goods, Green Wealth International Co., Ltd. does not control the nature and quality of the goods and therefore is not the owner of the Mark *[Exhibit E]*. As such, Green Wealth International Co., Ltd. lacked the authority to grant trademark rights or authorize Applicant to file a trademark application in its own name. Consequently, Applicant did not own the *NEO HAIR LOTION* trademark at filing and has never been the rightful owner of the Mark.

As regards a United States distribution agent for a foreign manufacturer, the Board has only allowed such distribution agent to register the foreign manufacturer’s mark when presented evidence of one of the following, either: (a) written consent from the owner of the mark to registration in the applicant’s name; or (b) written agreement or acknowledgment between the [distribution agent and the manufacturer] that the importer distributor is the owner of the mark in the United States; or (c) an assignment to the applicant of the owner’s rights in the mark as to the United States together with the business and good will appurtenant thereto. *See In re Pharmacia Inc.*, 2 USPQ2d 1883 (TTAB 1987); *In re Geo. J. Ball, Inc.*, 153 USPQ 426 (TTAB 1967).

Here, Opposer, in its first Meet and Confer correspondence [*Exhibits F*] and second Meet and Confer correspondence [*Exhibits G*], requested that Applicant produce evidence of authorization or licensing for the NEO HAIR LOTION mark or documentation demonstrating Applicant's exercised quality control over NEO HAIR LOTION products. In response, Applicant provided two documents: a Declaration [*Exhibits I*]; and a Specimen submitted with the Application [*Exhibits J*]. These were the only responsive documents served by Applicant.

Notably, Applicant failed to provide any written consent, assignment, or agreement establishing its ownership of the mark in the United States. Thus, Applicant did not satisfy any of the three requirements under TTAB precedent for a U.S. distributor to claim ownership of a foreign manufacturer's mark.

Despite lacking ownership rights, on October 13, 2021, Applicant knowingly filed U.S. Trademark Application Serial No. 97/072,320 for the NEO HAIR LOTION mark in its own name. At the time of filing, Applicant was aware that it did not own the mark and nonetheless signed the application's declaration and certification falsely claiming ownership.

Because Applicant was not the rightful owner of the mark at the time of filing, its application is void *ab initio*. Accordingly, Applicant's application should be refused.

C. There is No Genuine Dispute of Material Fact Regarding Applicant's Lack of Ownership of the Mark

The Board has repeatedly held that ownership is a threshold issue that may be resolved on summary judgment where no factual dispute exists. See *Smith v. Olin Corp.*, 202 USPQ 370, 373 (TTAB 1979). Pursuant to *Fed. R. Civ. P. 56(a)* and *TBMP § 528.01*, Opposer hereby moves for partial summary judgment on the ground that there is **no genuine dispute of material fact regarding** Applicant's lack of ownership of the *NEO HAIR LOTION* trademark.

VI. CONCLUSION

There are no genuine issues of material fact that Applicant is not the rightful owner of the trademark NEO HAIR LOTION. While such ownership is a mandatory pre-requisite to receiving trademark registration, Opposer respectfully requests that the Board grant its motion for summary judgment and issue an order refusing registration of Applicant's Mark.

TESTIMONY DECLARATION OF [Abuzer Ghorl]

I, Abuzer Ghorl, residing at Dubai, United Arab Emirates, over twenty-one years of age and of sound mind and body, hereby declare under penalty of perjury under the laws of the United States of America that the following statements are true and correct to the best of my knowledge and belief:¹

1. Identity and Authority

I am the Chief Executive Officer (CEO) of Paradise International General Trading LLC ("Paradise"), a company duly registered and headquartered in United Arab Emirates. I am fully authorized to make this declaration on behalf of Paradise and to represent the company in matters concerning the trademark "Neo Hair Lotion" (the "Mark").

2. Authorization from GW Healthcare

Paradise has been authorized directly by Green Wealth Healthcare Co., Ltd. ("GW Healthcare"), the rightful owner of the Mark, to market, sell, and distribute the products associated with the Mark globally, including in the United States. This authorization is supported by a Worldwide Registration Allowance Affidavit signed by Mr. Paiboon Maraprygsavan, the legal representative of GW Healthcare, on April 24, 2023. A true and correct copy of this affidavit is attached as Exhibit A. The affidavit specifically states, "[I, Paiboon Maraprygsavan in my capacity as director at PAIBOON POLYMEDICAL CO., LTD. hereby confirm that we have an agreement with Paradise International General Trading LLC to use, sell and register the intellectual property including copyrights, designs and trademarks for the worldwide including the United Arab Emirates.]", explicitly granting Paradise the right to register the Mark in jurisdictions outside Thailand, including the United States.

3. GWT's Role as Distributor

To the best of my knowledge, Green Wealth International Co., Ltd. ("GWI") operates solely as a distributor of products bearing the Neo Hair Lotion mark and does not own the Mark. Paradise has

This declaration is made to support Paradise's opposition to Tevel Brands' trademark application and to affirm Paradise's exclusive authorization from GW Healthcare to use and register the Mark internationally. I respectfully submit that the Trademark Trial and Appeal Board (TTAB) should deny Tevel Brands' application and uphold Paradise's right to register the "Neo Hair Lotion" trademark.

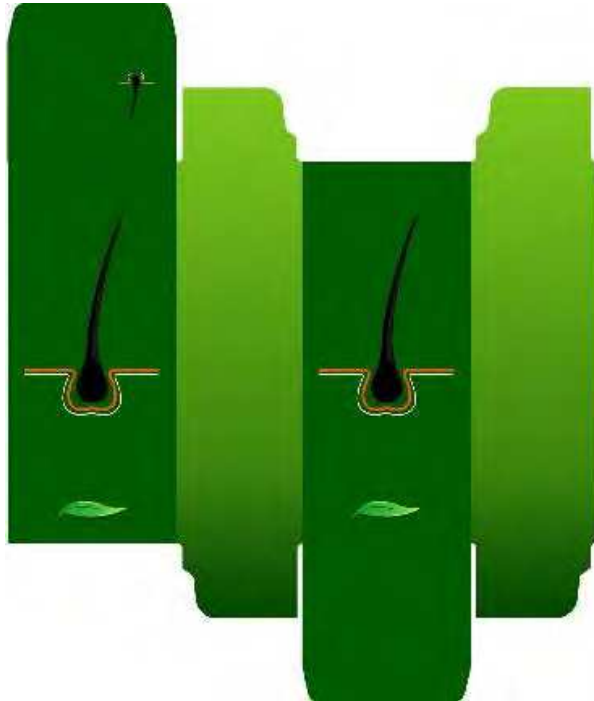

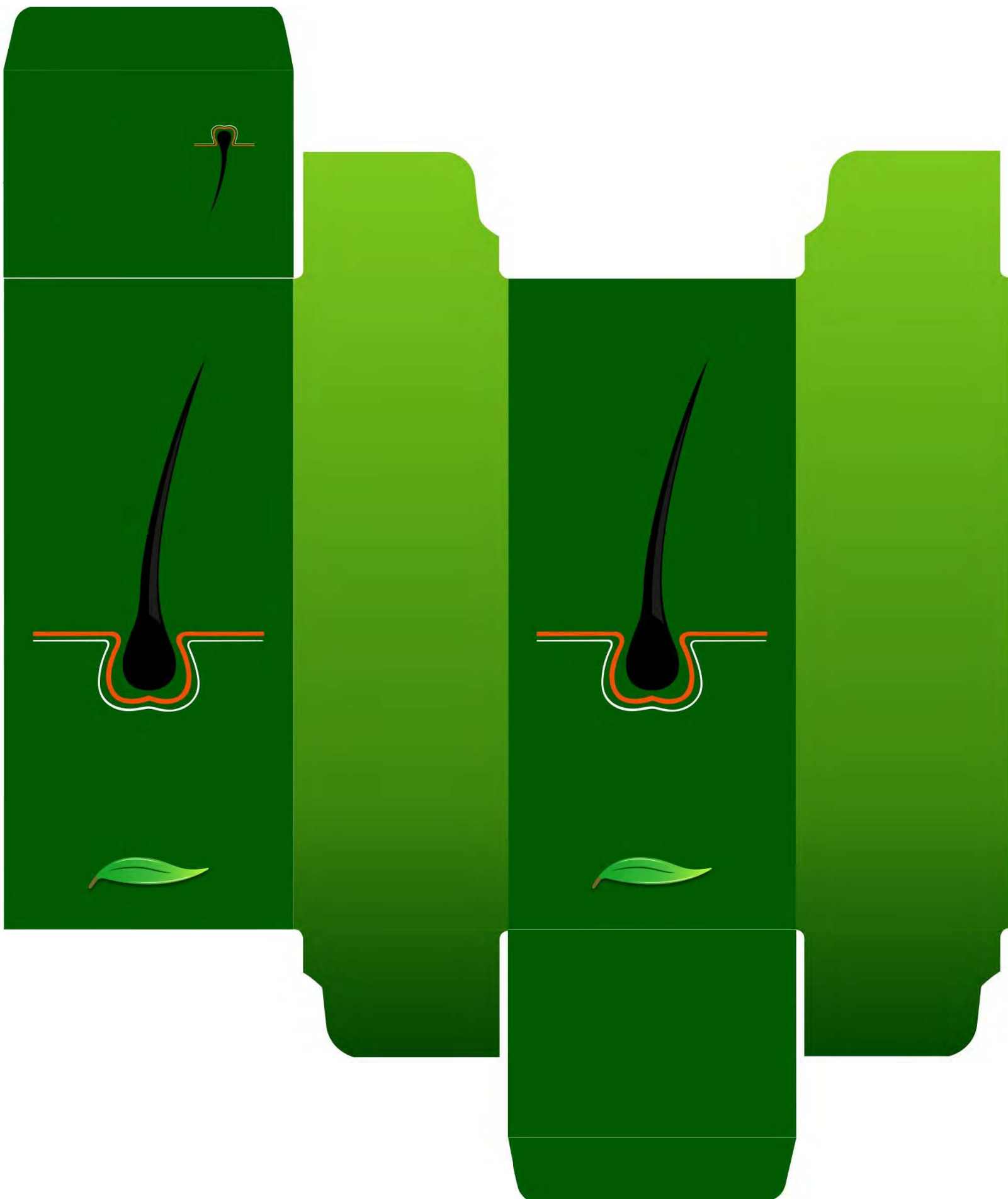

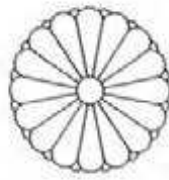

As a first example, paragraph 5 requests “[a]ll documents that support, refute, or otherwise relate to, in whole or in part, the factual basis for each and every denial, admission, and allegation set forth in Applicant’s Answer dated April 12, 2024, filed in the Proceeding.” In the cited Applicant’s Answer, Applicant made at least 48 denials, admissions, and other allegations. The fifth request first seeks documents that support the 48 denials, admissions, and allegations. Second, the fifth request seeks refuting documents for each of the 48 denials, admissions, and allegations. Third and finally, the fifth request ambiguously requests documents that “otherwise relate to, in whole or

in part” the 48 denials, admissions, and allegations. Request 5 therefore seeks production in at least 144 subparts.

As a second example, paragraph 8 requests “[a]ll documents concerning any study or opinion concerning the validity, enforceability, or infringement of “NEO HAIR LOTION” Mark.” This request thus seeks documents in at least six sub-parts: (1) validity studies; (2) validity opinions; (3) enforceability studies; (4) enforceability opinions; (5) infringement studies; and (6) infringement opinions.

As a third example, similar to paragraph 8, paragraph 9 similarly seeks documents in at least six sub-parts by requesting “[a]ll documents concerning any study or opinion concerning the validity, enforceability, or infringement of the Opposer’s GREEN WEALTH Marks.”

As a fourth example, paragraph 12 seeks “[a]ll documents referring or relating to the creation or submission of the Applicant’s Specimen, including drafts, approval, or consultations with third parties.” This request thus seeks documents in at least six sub-parts: (1) referring to the creation of Applicant’s Specimen; (2) referring to the submission of Applicant’s Specimen; (3) relating to the creation of Applicant’s Specimen; (4) relating to the submission of Applicant’s Specimen; (5) drafts of Applicant’s Specimen or the aforementioned; (6) relating to the approval of Applicant’s Specimen; (7) regarding approval of Applicant’s Specimen; (8) consultations with third parties for the aforementioned.

As a fifth example, paragraph 15 ambiguously seeks “[a]ll documents referring or relating to the Product and Packaging shown in the Applicant’s Specimen.” This request thus ambiguously seeks “all documents” in at least four subparts: (1) referring to the Product shown in the Applicant’s Specimen; (2) referring to the Packaging shown in the Applicant’s Specimen; (3) relating to the Product shown in the Applicant’s Specimen; and (4) relating to the Packaging shown in the Applicant’s Specimen.

As a sixth example, paragraph 16 seeks documents in at least three (3) subparts by requesting “[d]ocuments sufficient to show all contractual relationship Applicant has entered into relating to the manufacture, importation or sale of Applicant’s Goods bearing Applicant’s Mark into the United States.”

As a seventh example, paragraph 17 similarly seeks documents in at least three (3) subparts by requesting “[d]ocuments sufficient to show all contractual relationship Applicant has entered into relating to the manufacture, importation or sale of Applicant’s Goods bearing Opposer’s GREEN WEALTH Marks into the United States.”

As eighth and ninth examples, paragraphs 18 and 19 each seek documents in four (4) subparts relating or regarding “offering” or “potentially offering” certain goods.

I write on behalf of Opposer PARADISE INTERNATIONAL GENERAL TRADING LLC (“Opposer”) to address the primary deficiencies in Applicant TEVEL BRANDS LTD’s (“Applicant”) response to Opposer’s requests for production, requests for admission, and interrogatories.

This letter serves as a follow-up to Applicant’s inadequate responses to Opposer’s discovery requests, which were received responses on December 21, 2024, and a subsequent response on January 2, 2025, including a specimen and an authorization letter from Green Wealth International Co., Ltd. (“GWI”). these responses fail to address the fundamental deficiencies in Applicant’s responses. The deficiencies set forth below are not exhaustive, and our investigation is ongoing. Please let us know if, and by when, Applicant agrees to supplement its responses as requested below.

Discovery Response Issues

Opposer’s **Interrogatory Nos. 1 and 2** and **Request for Production No. 2** sought documents that Applicant’s creation, development, selection or approval of Applicant’s Mark. In response, Applicant states two individuals identified the market need, sources the product, and marketed the products with Applicant’s Mark. However, failed to state whether the two individuals created the Mark and failed to provide any evidence to support its creation, development, selection or approval of the Mark.

Opposer’s **Interrogatory No. 6** and **Request for Production No. 1** sought documents establishing Applicant’s first use in commerce of Applicant’s Mark in the United States. Applicant failed to provide any documents to its first use in commerce.

Opposer’s **Interrogatory No. 7** and **Request for Production No. 16** sought agreements or authorizations that allow Applicant to use or register the “NEO HAIR LOTION” mark. In response, Applicant merely provided a document showing that it had authorization from GWI to sell or



distribute but failed to provide any documentary evidence to support this claim. Critically, there is no evidence that GWI itself obtained any authorization from the trademark owner.

To substantiate Applicant's claim of ownership, please produce copies of any agreements, licenses, or authorizations between Applicant and GWI, as well as any agreements between trademark owner that purportedly grant GWI such authority. Additionally, please provide any documentation demonstrating that GWI holds actual trademark ownership rights over the "NEO HAIR LOTION" mark, including but not limited to trademark registration certificates, corporate records, or other official documents confirming GWI's legal claim to the mark.

Opposer's **Request for Production Nos. 12 and 15** sought information on the creation, submission, and verification of the specimen filed with the USPTO. Applicant did not provide documents showing how and when the Specimen webpages were created, specimen was prepared, or any communications verifying its authenticity. Please supplement with all drafts, communications, or documents related to the submission of the specimen.

Opposer's **Interrogatory No. 14 and Request for Production Nos. 16 and 17** sought agreements, contracts, or communications between Applicant and third parties regarding the production, distribution, or sale of goods bearing the mark. Applicant stated that it receives products from GWI, which purchases from the manufacturer Green Wealth Healthcare Co., Ltd., but provided no documentary support. Please produce agreements that detail these relationships and any quality control measures that demonstrate control over the mark.

Demand for Supplementation and Meet and Confer


Please supplement Applicant's responses to provide substantive answers to these interrogatories and confirm when Applicant will provide the supplemental responses, by no later than Monday, January 27. Additionally, please advise when you can be available for a meet and confer to attempt to resolve these issues.
