APPLICATION FOLLOWING SETTLEMENT**

Applicant HAF Loungewear, LLC. (“Applicant”) files this Request to Amend Application following settlement of this above-captioned Opposition Proceeding. Applicant sought registration of United States trademark application Serial No. 90862365 for the mark HAF LOUNGEWEAR in Class 25 for “Loungewear; Pajamas; Graphic T-shirts; Knit bottoms; Long-sleeved shirts; Night shirts; Pajama bottoms; Sleep shirts; Sleeping garments; Short-sleeved or long-sleeved t-shirts” (the “Marks”).
