NOTICE OF OPPOSITION

Opposer H-E-B, LP believes it will be damaged by registration of the mark shown in Ser. No. 97/325,111 (the “Application”). Opposer brings this opposition under 15 U.S.C. § 1063. Opposer asserts priority and likelihood of confusion, 15 U.S.C. § 1052(d), as its ground for opposition.

THE PARTIES

1. Opposer is a Texas limited partnership with an address of 646 South Flores, San Antonio, Texas 78204.

2. According to PTO records, Applicant Qi Wang (“Applicant”) is a Chinese individual with an address of Xinguang Wucun, 01-10-166, Hayebao Town, Kundulun District Baotou, Inner Mongolia CHINA 014010.

BACKGROUND

A. Opposer and its H-E-B Marks

3. Opposer owns and operates a well-known chain of retail grocery stores under the name H-E-B (or HEB).

4. Since at least as early as June 13, 2014, Opposer has used the mark KODI in standard character, stylized word, or word and design formats.

5. In addition to its use of the KODI mark, Opposer has used other KODI-formative marks, such as KODI AT30, KODI AT50, and KODI TRIP (collectively, the “KODI Marks”).

6. Opposer’s use of the KODI Marks has been continuous, exclusive, and widespread.

7. Opposer’s offerings under the KODI Marks include, but are not limited to: beverageware, tumblers, drinking cups, bottle openers, insulting sleeve holders for beverage cups, cold packs, trays, and other beverage-related accessories.

8. The KODI Marks are inherently distinctive of Opposer.

9. Opposer has invested extensively to advertise and promote the KODI Marks. Because of those efforts, the consuming public strongly identifies the KODI Marks with Opposer.

10. Opposer enjoys strong goodwill and common law rights in the KODI Marks. These common law rights include but are not limited to rights in the word mark KODI for a variety of beverageware and other beverage-related accessories.

11. Opposer sells cups and beverage-related accessories at many of its retail stores.

12. Opposer's broader business success amplifies the strength and goodwill of the KODI Marks. In January 2023, national data-science firm Dunnhumby ranked Opposer as the top grocery store in the entire U.S. See Progressive Grocer, *H-E-B Topples Amazon as Top U.S. Grocery Retailer*, <https://progressivegrocer.com/h-e-b-topples-amazon-top-us-grocery-retailer> (Jan. 31, 2023). And, in 2010, the National Retail Foundation (NRF), named Opposer the top retailer in the State of Texas and one of the top twenty retailers in the entire United States. According to NRF, Opposer generated higher revenue per store than any other U.S. retailer besides Apple, Inc.

13. In addition to its common law rights, Opposer owns numerous registrations for the KODI Marks covering goods in Class 21. Details of Opposer's registrations for the KODI Marks in Class 21 appear in the table below.

14. Opposer’s registrations are valid and subsisting. Further, U.S. Reg No. 4,589,366 has attained incontestable status under 15 U.S.C. § 1065.

15. **Exhibit A** contains copies of PTO records for the registrations cited above, showing that they are live and that Opposer owns them.

16. Opposer’s issued registrations cover goods closely related to the goods listed in the Application—e.g., beverageware, trays for domestic purposes, and coolers.

17. Opposer’s common law rights in its KODI Marks extend to goods identical and highly similar to the goods in the opposed Application, namely, beverageware and household/kitchen items.

B. The Opposed Application

18. The Application covers the mark KIODY in Class 21 for “Cups; Barbecue mitts; Bento boxes; Cheese board and knife set; Collapsible storage containers for domestic use; Containers for household or kitchen use not of precious metal; Cooking pans; Cooking pots for use in microwave ovens; Cooking utensils, namely, grills; Cotton gloves for household purposes; Cruet stands for oil and vinegar; Double wall

cups; Kitchen mitts; Portable pots and pans for camping; Non-electric cooking pot sets.”

19. Applicant filed the Application on March 22, 2022, on an in-use basis, claiming a first use and first use in commerce date of September 14, 2021.

20. Opposer’s use in commerce of the KODI Marks—including its use of the KODI Marks specifically in connection with beverageware and beverage-related accessories—predates the filing date of, and first-use date under, the Application.

21. Also, Opposer’s registrations cited above have filing dates predating the filing date of the Application and the first-use date claimed in the Application.

GROUND FOR OPPOSITION—LIKELIHOOD OF CONFUSION

22. Opposer repeats the allegations above as if set forth fully here.

23. Opposer has priority over Applicant.

24. The KIODY mark covered by the Application consists of a term that is virtually identical to Opposer’s KODI Marks. The Class 21 goods covered by the Application (*e.g.*, beverageware, containers for domestic use, and containers for household or kitchen use) are also highly similar to the goods offered by Opposer under the KODI Marks in Class 21.

25. Applicant’s KIODY mark is likely to cause confusion, to cause mistake, or to deceive with Opposer’s KODI Marks. Consumers are likely to believe that Opposer provides, sponsors, or endorses Applicant’s goods, or that Applicant’s goods are otherwise affiliated, connected, or associated with Opposer.

26. Opposer has not given Applicant permission to use or register the KIODY mark or any other marks confusingly similar to the KODI Marks.

27. The Application should be refused registration under 15 U.S.C. § 1052(d).

DAMAGE TO OPPOSER; ENTITLEMENT TO A STATUTORY CAUSE OF ACTION

28. Allowing the Application to proceed would damage Opposer because, as explained, consumers are likely to confuse Applicant's goods offered under the KIODY mark with Opposer.

29. Also, allowing the Application to proceed would damage Opposer because registration would give Applicant statutory presumptions and legal rights to which it is not entitled. Those statutory presumptions and legal rights would weaken and dilute Opposer's prior common law and registered rights in its KODI Marks.

30. Opposer is thus entitled to bring the statutory cause of action under 15 U.S.C. § 1052(d).

CONCLUSION

The Board should sustain this opposition, enter judgment for Opposer, and refuse registration of the Application, Ser. No. 97/325,111.

This Notice of Opposition is being filed electronically, along with the filing fee required by 37 C.F.R. § 2.6(a)(17).
