NOTICE OF OPPOSITION

Instagram, LLC (“Opposer” or “Instagram”) believes it will be damaged by the registration of the mark INSTAMINT covered by Application Serial No. 97112081 filed on November 6, 2021, by Instamint, LLC (“Applicant”), and hereby opposes such registration.

Introduction

1. Instagram is a Delaware limited liability company with its headquarters and principal place of business at 1601 Willow Road, Menlo Park, California 94025.
2. Applicant is, upon information and belief, a Delaware limited liability company located at 32-53 32nd Street, Astoria, New York 11106.
3. This Notice of Opposition has been timely filed. As grounds of opposition, Instagram alleges as follows.

Relevant Facts

4. As published in the *Official Gazette* dated December 6, 2022, Applicant seeks to register the mark INSTAMINT in:

- International Class 35 for “*Compiling indexes of information related to non-fungible tokens (NFTs) using blockchain technology; Provision of an online marketplace for buyers and sellers of downloadable digital assets in the nature of art images, music, video clips, and financial assets, authenticated by non-fungible tokens (NFTs), all of the foregoing for businesses*”
- International Class 36 for “*Blockchain-based payment verification services for businesses*”
- International Class 42 for “*Authentication of data in the field of financial transactions using blockchain technology to facilitate the issuance and transfer of non-fungible tokens (NFTs) for businesses*”

(“Applicant’s Mark”).

5. Instagram is the owner of Instagram, the world-famous photo/video sharing and editing service, software application, and social network launched in October 2010. Since its launch, Instagram has used the trademark INSTAGRAM continuously in interstate commerce in the United States in connection with its goods and services. Reflecting its trademark rights, Instagram owns U.S. registrations and applications for its INSTAGRAM mark, including without limitation the following:

These registrations and applications cover a variety of goods and services, including but not limited to the following:

- Computer software for the collection, editing, organizing, modifying, transmission, storage and sharing of data and information;
- Telecommunications services, namely electronic transmission of data, messages, graphics, images, videos and information;
- Marketing, advertising and promotion services; Market research services and provision of market research information; Providing online advertising services for others;
- Providing temporary use of non-downloadable software applications for social networking, creating a virtual community, and transmission of audio, video, photographic images, text, graphics and data;
- Shopping and payment services;
- Providing use of online temporary non-downloadable software for enabling transmission of images and audiovisual and video content;
- Downloadable and non-downloadable computer software for modifying the appearance and enabling transmission of images, audio-visual and video content;
- Providing computer, electronic and online databases in the field of entertainment;
- Social introduction, networking and dating services; and
- Computer services, namely providing an interactive website featuring technology that allows users to manage their online photograph and social networking accounts.

All of Instagram’s marks featuring the term INSTAGRAM are referred to herein as the “INSTAGRAM Mark.” Attached as **Exhibit A** are certificates of registration and current TSDR records for U.S. registrations of the INSTAGRAM Mark.

6. The INSTAGRAM Mark is highly distinctive with regard to all of Instagram’s goods and services in connection with which the mark is used.
7. Instagram’s INSTAGRAM Mark has priority over Applicant’s Application, which was filed on November 6, 2021 with a claimed date of first use in commerce of September 16, 2021 for Classes 35 and 42, and on an intent-to-use basis for Class 36.
8. Applicant’s Mark creates a similar commercial impression as the INSTAGRAM Mark.
9. Applicant seeks to register Applicant’s Mark for online marketplace, payment verification, and financial transaction services. These services are related and/or similar to the goods and services offered by Instagram in connection with its INSTAGRAM Mark.
10. In addition, Applicant has adopted and begun use of the trademark META for use with its software API for the management of online tokens and token transactions across multiple online blockchains. The adoption of a second mark that closely resembles the name of Instagram’s parent company, Meta Platforms, Inc., further evidences the Applicant’s intent to associate itself with Opposer. See, *e.g.*, <https://instamint.com/> and screenshot below:



Meta™

Meta is an API for B2B minting and managing tokens and token transactions across asset classes and counterparties. Meta works across a number of blockchains including Ethereum, Algorand and Polygon and maximizes value and scalability for the enterprise. Meta let's you roll out self-sovereign smart contracts and empower the issuer or publisher.

Claim 1 – Infringement and Likelihood of Confusion (15 U.S.C. § 1052(d))

11. Applicant’s Mark is deceptively similar to the INSTAGRAM Mark so as to cause confusion, or to cause mistake or to deceive the public as to the origin of Applicant’s goods and services offered under Applicant’s Mark.

12. Because Applicant’s Mark creates the same, or essentially the same, commercial impression as the INSTAGRAM Mark, registration of Applicant’s Mark is likely to cause confusion, or to cause mistake or to deceive the public as to the source of Applicant’s goods and services, to the harm and damage of Instagram and the public.

13. Registration of Applicant’s Mark will lead the public to conclude, incorrectly, that Applicant is or has been affiliated or connected with Instagram, and/or that Applicant’s goods and services provided under Applicant’s Mark are, or have been, authorized, sponsored, endorsed, or licensed by Instagram. Issuance of any registration to Applicant for the proposed mark will result in damage to Instagram and the public. Therefore, registration of Applicant’s Mark is prohibited by 15 U.S.C. §1052(d).

Claim 2 – Dilution (15 U.S.C. § 1125(c))

14. Through Instagram’s widespread use of the INSTAGRAM Mark, extensive and continuous media coverage, the high degree of consumer recognition of the INSTAGRAM Mark, Instagram’s enormous and loyal user base, its multiple trademark registrations and pending applications, and other factors, the INSTAGRAM Mark is strong, enjoys widespread recognition among consumers, and has become famous within the meaning of Section 43(a) of the United States Trademark Act, 15 U.S.C. § 1125(c).

15. Applicant's Mark has caused or is likely to cause dilution of the distinctive quality of the INSTAGRAM Mark in violation of 15 U.S.C. § 1125(c), to the harm and damage of Instagram and the public.

16. The INSTAGRAM Mark was famous before Applicant filed the Application at issue and before Applicant began use, if any, of Applicant's Mark.

17. Therefore, registration of Applicant's Mark should be refused under 15 U.S.C. §§ 1052 and 1063(a).

Conclusion

18. Registration of Applicant's Mark would constitute *prima facie* evidence of the validity of such registration, Applicant's ownership of Applicant's Mark, and Applicant's exclusive right to use the INSTAMINT mark pursuant to the provisions of 15 U.S.C. § 1057(b). Such registration would be a source of damage and injury to Instagram and the public, and would be contrary to the principles of registration set out in 15 U.S.C. §§ 1051 *et seq.*

WHEREFORE, Instagram prays that this Opposition be sustained, and that registration to Applicant for the mark covered by Application Serial No. 97112081 be refused.
