**NOTICE OF OPPOSITION**

Opposer, ALO, LLC, a California limited liability company having a place of business at 9830 Wilshire Boulevard, Beverly Hills, California 90212 (hereinafter “Opposer”) believes that it will be damaged by registration of the mark ALOISIO and design as shown in U.S. Application Serial No. 79/331,630 (the “Application”) filed by Gaetano Aloisio, an resident of Italy having a mailing address at Via di Porta Pinciana, 1 I-000187 Roma (RM), Italy (“Applicant”), and hereby opposes the same. As grounds for the Opposition, it is alleged that:

1. Opposer is the owner by assignment from Color Image Apparel, Inc. (“CIA”) of the marks cited herein, and that assignment was recorded in the United States Patent and Trademark Office on March 2, 2018, at Reel/Frame 6283/0350 of the assignment records.

2. Opposer and its assignor, CIA, are now and for many years past have been engaged in the manufacture, marketing and sale of apparel for men, women and children, bags, and sports equipment.

3. For many years and since at least as early as May 23, 2006, Opposer and its assignor, CIA, adopted and have used the trademark ALO on and in connection with their goods, including apparel.

4. For many years, Opposer and its assignor, CIA, have drawn upon the goodwill and public recognition of their ALO marks by adopting and using these marks to signify their

high quality goods.

5. Opposer's ALO marks have been conspicuously applied to and used in conjunction with Opposer's and its assignor's goods, and said goods so marked have been extensively distributed, advertised, promoted and sold in interstate commerce in the U.S.

6. Opposer and its assignor, CIA, have widely and extensively advertised and promoted their goods such that the public and trade recognize that these products emanate from one source, *i.e.*, ALO, LLC and, previously, its assignor CIA.

7. By virtue of Opposer's and its assignor's extensive advertising, promotion, and sales of its goods under its ALO marks, the public and trade have come to rely upon Opposer's ALO marks to identify Opposer's superior products and distinguish them from the products of others. The ALO marks have come to represent an extremely valuable goodwill belonging exclusively to Opposer.

8. Opposer and its assignor, CIA, have long maintained registrations incorporating the word ALO for apparel, bags, and sports equipment in the United States Patent and Trademark Office (the "USPTO"), including the following (collectively, the "ALO Marks"):

9. Said registrations are valid and subsisting, and are owned by Opposer together with the business and goodwill connected therewith. Further, one of these registrations is now incontestable under the provisions of 15 U.S.C. §1065. Copies of the TSDR records for these registrations showing the current status and title are attached hereto as Exhibit A.

**Applicant's Trademark Application**

10. Applicant seeks registration of the mark ALOISIO ("Applicant's Mark") on the basis of an application filed on November 5, 2021, ("Applicant's Filing Date") pursuant to Section

66(a) of the Lanham Act.

11. As published on February 28, 2023, the Application covers “Garment bags for travel made of leather; garment bags for storage of suits for men, shirts and dresses; traveling bags, athletic bags, courier bags, tote bags, carryall bags, weekend bags; holdalls; multi-purpose purses; all-purpose carrying bags; travel baggage; leather bags and wallets; luggage, wallets and carry-all bags; suitcases with wheels; imitation leather; animal skin, namely, moleskin; animal skins; leather briefcases; leather coin purses; leathercloth; document cases; business cases; pocket wallets; attaché cases; gentlemen's handbags; rucksacks; daypacks; traveling trunks; toiletry bags sold empty; umbrellas; walking sticks; umbrellas and parasols; tie cases” in International Class 18, “Silk cloth, cotton cloth, linen cloth, kente cloth; synthetic, mixed, semi-synthetic fibre fabrics for use in the manufacture of linings of bags; household textiles, namely, table mats of textiles, wall hangings, kitchen towels, tablecloths, napkins; household textiles, namely, table mats of textiles, wall hangings, kitchen towels, tablecloths, napkins made from non-woven materials; bed linen and bed blankets; lap blankets; lap rugs; traveling rugs; picnic blankets; linens for household purposes; bath linen; bed linen and table linen not of paper; textile used as lining for clothing, namely, hats; woollen fabrics for use in the manufacture of jackets; duvets filled with goose feathers; covers for eiderdown and duvets; kitchen and table linens; throws; textiles fabrics for home and commercial interiors; textiles fabrics for use in making household furnishings; woven fabrics for cushions; apparel fabrics” in International Class 24, “Clothing, namely, gowns, blouses, dresses, belts, jumpers, jeans, cloaks, parkas, shirts, pants, slacks, shorts, jackets, coats, t-shirts, sweaters, underwear, bathing costumes, swim suits, neckerchiefs, neckties, sweatshirts, polo shirts; waist belts; gloves including those made of animal skin, hide or fur; clothing made of fur, namely, shirts, bottoms, pants, dresses, jackets, sweatshirts, sweatpants, scarfs; clothing of leather, namely, shirts, bottoms, pants, dresses, jackets, sweatshirts, sweatpants, scarfs; clothing of imitations of leather, namely, shirts, bottoms, pants, dresses, jackets, sweatshirts, sweatpants, scarfs; leather jackets; pelisses; leather slippers; men's wear, namely, shirts, bottoms, pants, jackets, sweatshirts,

sweatpants, scarfs; men's socks; men's suits; footwear; scarves; pocket squares; pocket-handkerchiefs; silk scarves; headwear; berets; jackets; heavy jackets; underwear; casual jackets; coats; mantles; fur coats and jackets; down jackets; shirts; waistcoats; trousers; trousers shorts; sweaters; undershirts; hosiery; tank tops; vests; ties as clothing; bow ties; light overcoats; raincoat; evening gowns; women's ceremonial dresses; woven shirts for babies, adults, children, women, men” in International Class 25, “Custom tailoring; tailoring and dressmaking; providing information in the field of tailoring; working of leather and furs; cloth cutting; cutting of fabric; treatment of fur and leather; textile treatment in the nature of mothproofing, rainproofing, anti-creasing” in International Class 40, and “Dress designing; graphic art design; Clothing design services, namely, hats; providing information in the field of fashion design services; fashion design consulting services; clothing design services; footwear design services and clothing design services, namely, headgear; Interior design consultation” in International Class 42.

12. Opposer and its assignor, CIA, have been using their ALO Marks in connection with their goods since before Applicant’s Filing Date.

13. Opposer’s ALO Marks are visually similar to Applicant’s Mark.

14. Opposer’s ALO Marks are aurally similar to Applicant’s Mark.

15. Applicant’s Mark is confusingly similar in sight and sound to Opposer’s ALO Marks.

16. Applicant’s Mark is confusingly similar in commercial impression to Opposer’s ALO Marks.

17. The identifications of goods in the registrations for Opposer’s ALO Marks place no restrictions on the type of consumer to whom the products are sold or provided, or intended to be sold or provided.

18. The identification of goods in the Application places no restrictions on the type of consumers to whom the products are intended to be sold.

19. The identifications of goods in the registrations for Opposer’s ALO Marks place no

restrictions on the channels of trade through which the products are sold or provided, or intended to be sold or provided.

20. The Application places no restrictions on the channels of trade through which the products are sold.

21. Upon information and belief, Applicant markets Applicant's goods to the same consumers of Opposer's goods.

22. Upon information and belief, Applicant's goods travel in the same channels of trade as Opposer's goods.

23. Applicant's goods are highly related, if not identical, to the goods Opposer offers under its ALO Marks.

## **CLAIM FOR RELIEF**

### **Likelihood of Confusion**

#### **Section 2(d) of The Lanham Act; 15 U.S.C. §1052(d)**

24. Opposer hereby incorporates the foregoing paragraphs as fully set forth herein.

25. Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d), prohibits registration on the principal register of a mark that consists of or comprises a mark which so resembles a mark previously used in the United States by another and not abandoned, as to be likely, when used on or in connection with the goods of the applicant, to cause confusion, or to cause mistake, or to deceive.

26. Upon information and belief, the goods identified in the Application are identical, closely related and/or complementary to the goods offered under Opposer's ALO Marks.

27. Applicant's Mark so resembles Opposer's ALO Marks, as to be likely, when used in connection with Applicant's goods, to cause confusion, to cause mistake, or to deceive.

28. With several years of prior use of the ALO Marks, Opposer is entitled to the exclusive use of its marks in connection with those goods.

29. The Trademark Trial and Appeal Board has authority under 15 U.S.C. § 1068 to



refuse to register the Application.

WHEREFORE, Opposer believes and avers that it will be damaged by registration of the Application and prays that the Application be rejected, that no registration be issued to Applicant, and that this Opposition be sustained in favor of Opposer.
