### **NOTICE OF OPPOSITION**

To the Commissioner for Trademarks:

Dept Holding B.V. ("**Opposer**") believes that it is or will be damaged by the issuance of a registration for the alleged mark shown in Application Serial No. 97/181,452 and owned by Gallery Department, LLC ("**Applicant**"). Opposer hereby opposes same pursuant to Section 13(a) of the Lanham Trademark Act of 1946 ("**Lanham Act**"), 15 U.S.C. § 1063(a).

As grounds for opposition, Opposer alleges as follows:

1. On December 12, 2017, Opposer was issued Reg. No. 5352713 ("Opposer's Registration" or the "DEPT Mark") by the United States Patent and Trademark Office ("USPTO") based on Opposer's use of "DEPT" in connection with a broad range of services identified in Opposer's Registration of DEPT in International Classes 35 and 42. Attached

as Exhibit 1 is a true and correct printout from the USPTO electronic database showing the current status and title of the registration as of June 13, 2023.

- 2. Opposer has used the DEPT Mark in interstate commerce in the United States continuously since at least February 2018 in connection with its digital agency business for the provision, sale, marketing, advertising, and promotion of numerous services relating to digital marketing and technology. Attached hereto as Exhibit 2 are screenshots of representative samples of Opposer's website showing Opposer's use of the DEPT Mark in connection with these services. As example, Opposer's Registration identifies services Opposer provides to third parties relating to advertising, brand design, marketing, promotion, developing brand identities, designing advertising materials, product design consulting, research and custom design of computer software, computer programming, graphic arts designed.
- 3. Opposer has used the term "DEPT" as a trademark in interstate commerce in the United States continuously since at least October 2020 in connection with its the provision, sale, marketing, advertising, and promotion of apparel, including sweatshirts, socks, t-shirts, bags, scarves, hats and water bottles. Attached hereto as Exhibit 3 are screenshots of representative samples of Opposer's website showing Opposer's use of the term "DEPT" in connection with the sale of such goods, and attached as Exhibit 4 are a sample of the Opposer's goods marketed in connection with the term "DEPT".
- 4. As a result of its widespread, continuous, and exclusive use of the DEPT Mark to identify its services and goods and Opposer as their source, Opposer owns valid and subsisting federal statutory and common law rights to DEPT Mark.
- 5. Opposer's DEPT Mark is distinctive to both the consuming public and Opposer's trade.
- 6. Opposer has expended substantial time, money, and resources marketing, advertising, and promoting the services and goods sold under the DEPT Mark.
- 7. The services and goods Opposer offers under the DEPT Mark are of high quality.
- 8. Upon information and belief, Applicant, Gallery Department, LLC, on December 20, 2021, filed trademark Application Serial No. 97/181,452 to register the proposed mark "DEPT." for clothing, namely, men's, women's, missy's, juniors', children's and infants' jeans, pants, trousers, capris, leggings, shorts, skorts, overalls, shortalls, skirts, dresses, tops, t-shirts, sweatshirts, blouses, shirts, jackets, coats, sweaters, vests, cardigans, scarves, socks, bandanas, neckties, belts, boots, sandals, footwear, hats, caps being headwear, headwear, underwear, swimwear, gloves and ties in International Class 025.
- 9. Applicant allegedly began using the proposed mark on October 30, 2020, approximately 3 years after Opposer began using Opposer's DEPT Mark.

- 10. Opposer's DEPT Mark has priority over the proposed mark because Opposer's use and registration date predates the Applicant's alleged date of first use or any other date on which the Applicant may rely for purposes of priority.
- 11. Applicant's proposed mark is nearly identical and confusingly similar to Opposer's DEPT Mark. Both are comprised of a single identical term, "DEPT", and the only difference is the addition of a silent "." following "DEPT" in Applicant's proposed mark.
- 12. The goods covered by the Applicant's Application Serial No. 97/181,452 are similar to the goods Opposer offers under its common law DEPT Mark and within the zone of expansion of Opposer's rights under its federal registration for the DEPT Mark.
- 13. The proposed mark is barred from registration because it consists of or comprises a mark which so resembles Opposer's previously used and registered DEPT Mark, as to be likely, when used in connection with the alleged goods of Applicant, to cause confusion, mistake, or deception within the meaning of 15 U.S.C. § 1052(d).

WHEREFORE, Opposer respectfully prays that its opposition be sustained and that registration to Applicant be refused.
