**NOTICE OF OPPOSITION**

Code Black Indy, Inc. (“Opposer” or “CBI”) believes that it will be damaged by registration of the mark CODE BLACK INDY shown in Application Serial No. 97644765 (the “765 Application”) identified for use in association with “Education services, namely, training educators in the field of technology and providing curricula in connection therewith; Computer education training; Information on education; Providing information about education via a website; Providing information relating to education services for children” (the “Services”) filed under Section 1(b) of the Trademark Act by Jones, Kalvin (“Applicant” or “Jones”) and published in the Official Gazette on September 19, 2023. Opposer accordingly hereby opposes registration.

As grounds for opposition, Opposer alleges as follows:

1. Opposer is a nonprofit corporation organized and existing under the laws of the State of Indiana with its principal office address at 125 W South Street, P.O. Box 927, Indianapolis, Indiana.

2. Opposer's mission is to act as a pipeline to high paying tech careers and crowd-sourced technological advancements by forming an environment for under-served communities to elevate themselves.

3. Opposer's webpage attached as Exhibit 1 obtained from Opposer's Internet website located at <codeblackindy.org> provides further details respecting Opposer's mission.

4. Opposer has used CODE BLACK INDY as a common law service mark since at least as early as June 28, 2019.

5. A copy of the TSDR summary for Opposer's federal trademark application for the mark CODE BLACK INDY (Ser. No. 97683396 (the "396 Application")), filed with the United States Patent and Trademark Office ("USPTO") for use in association with "computer and technology education training services, education services, namely, providing classes in the field of technology used in the workforce, providing career re-training classes in the field of technology used in the workforce" (the "Offerings"), is attached as Exhibit 2.

6. Opposer's Certificate of Incorporation under the business name CODE BLACK INDY, INC. issued by the Office of the Secretary of State of the State of Indiana, effective June 28, 2019, is attached as Exhibit 3.

7. Opposer currently is using CODE BLACK INDY, INC. as its business name.

8. Opposer currently is using CODE BLACK INDY as a common law service mark in association with the Offerings.

9. Opposer's 2023/2024 Business Entity Report filed with the Indiana Secretary of State reflecting Opposer's business name as CODE BLACK INDY, INC. is attached as Exhibit 4.

10. An Application for Reinstatement and Certificate of Reinstatement Dated February 5, 2021, related to an entity named UNIVERSE CONSPIRED LLC (collectively, the “COR”) is attached as Exhibit 5.

11. The COR reflects that UNIVERSE CONSPIRED LLC is a limited liability company organized and existing under the laws of the State of Indiana.

12. The COR reflects that the principal office address for UNIVERSE CONSPIRED LLC is 3249 Ruckle Street, Indianapolis, Indiana.

13. The principal office address for UNIVERSE CONSPIRED LLC is the same address identified by Applicant in the ‘765 Application, namely, 3249 Ruckle Street Indianapolis, Indiana.

14. The COR reflects that Applicant holds the title of “CEO” for UNIVERSE CONSPIRED LLC.

15. The COR reflects that UNIVERSE CONSPIRED LLC was administratively dissolved on February 5, 2021.

16. The COR reflects that the assumed business name CODE BLACK INDY related to UNIVERSE CONSPIRED LLC remains administratively cancelled.

17. Opposer has not authorized Applicant to file the ‘765 Application.

18. Opposer has not authorized Applicant to use the mark CODE BLACK INDY.

19. Opposer has not authorized the Applicant to use CODE BLACK INDY as a business name.

20. Applicant holds no rights in the mark CODE BLACK INDY for use in association with the Services.

21. Applicant is not the owner of the mark CODE BLACK INDY for use in association with the Services.

22. Opposer has expended substantial sums of money in advertising and promoting its Offerings under the CODE BLACK INDY mark such that the public recognizes Opposer as the source, sponsor, and otherwise affiliated with the Offerings offered under the CODE BLACK INDY mark.

23. By virtue of these efforts, the use of the CODE BLACK INDY mark, and the quality of Opposer's Offerings, the CODE BLACK INDY mark has acquired valuable goodwill in the marketplace.

24. Based on these and other efforts, the public has come to know the CODE BLACK INDY mark, and recognizes that Offerings offered under the CODE BLACK INDY mark have a source, sponsorship, or other affiliation with Opposer.

25. The CODE BLACK INDY mark is an asset of substantial value to Opposer as a symbol of Opposer, its high quality Offerings, and the valuable goodwill associated therewith.

26. Opposer has prior use of the CODE BLACK INDY mark in the United States in connection with the Offerings vis-à-vis the Applicant, which therefore qualifies Opposer as the senior rights holder in and to the CODE BLACK INDY mark.

27. Notwithstanding Opposer's senior rights to the CODE BLACK INDY mark, Applicant filed the '765 Application with the USPTO to register the CODE BLACK INDY mark for the Services.

28. Applicant in the '765 Application has not alleged a date of first use of the CODE BLACK INDY mark in the United States but rather has claimed an intent to use the CODE BLACK INDY mark with the Services.

29. Opposer's first use of the CODE BLACK INDY mark is earlier than Applicant's first use of the CODE BLACK INDY mark and is earlier than the filing date of the '765 Application.

30. Applicant's CODE BLACK INDY mark includes the same literal elements as in Opposer's CODE BLACK INDY mark.

31. Applicant's Services are identical or similar to the Offerings for which Opposer uses the CODE BLACK INDY mark in United States commerce.

32. Registration of Applicant's CODE BLACK INDY mark will damage the goodwill and consumer recognition that Opposer has built up in its CODE BLACK INDY mark.

33. For the above reasons, Opposer will be damaged by the registration of the CODE BLACK INDY mark by Applicant.

**WHEREFORE**, Opposer believes that it will be damaged by registration of Applicant's mark and requests that registration be denied.

Opposer authorizes the Commissioner for Trademarks to charge the fee for filing this Notice of Opposition, or any additional fees that may be due, to Deposit Account No. DA500410.


