NOTICE OF OPPOSITION

Opposer Coop Home Goods LLC (“Opposer”), a limited liability company organized and existing under the laws of the State of Delaware, having an address at 150 Paularino Ave., Suite D-170, Costa Mesa, California 92626, believes that it would be damaged by registration of the mark COMFY LIVING (“Applicant’s Mark”), as applied for in U.S. Application Serial No. 97/319,381 (the “Application”) by Comfy Living LLC (the “Applicant”).

Accordingly, Opposer hereby alleges as follows:

1. Opposer is a leading designer, manufacturer and retailer of a wide range of bedding products and accessories. For nearly twenty years, Opposer (itself and through its predecessor-in-interest) has advertised, promoted and sold a comprehensive range of bedding products and accessories in interstate commerce under its widely-recognized COMPHY name and mark, which is the subject of several U.S. registration and use-based trademark applications owned by Opposer (collectively, the “COMPHY Marks”):

2. A true and correct copy of the Certificate of Registration issued for Registration No. 3479190 is attached as Exhibit 1. True and correct printouts from the U.S. Patent and Trademark Office’s Trademark Status & Document Retrieval database showing the current status and title for Opposer’s COMPHY registration and applications are attached hereto as Exhibit 2. Opposer has also developed substantial common law rights in and to the COMPHY Marks in connection with bedding products and related accessories.

3. Opposer’s bedding and accessories products, all of which bear Opposer’s COMPHY Marks, are distributed domestically and internationally through various distribution channels.

4. Since the initial use of the COMPHY Marks in 2003, Opposer (itself and through its predecessor-in-interest) has continuously used, advertised, promoted and offered for sale Opposer’s products bearing the COMPHY Marks to the public, with the result that members of the relevant consuming public have come to know and recognize the COMPHY Marks and associate them with Opposer and the products offered by Opposer. Opposer has acquired substantial goodwill and secondary meaning in the COMPHY Marks.

5. On March 18, 2022, long after Opposer adopted and began using the COMPHY Marks in commerce, Applicant filed the Application on an intent-to-use basis seeking registration of Applicant’s Mark in connection with, among other things, the following: “Comforters; Towels;

Bath sheets; Blanket throws; Blankets for outdoor use; Coverlets; Duvet covers; Duvets; Pillow cases; Pillow covers; Pillow shams; Quilt covers; Quilts; Sheet sets; Shower curtain liners; Shower curtains; Shower curtains of textile or plastic; Throws; Bath towels; Beach towels; Bed blankets; Bed sheets; Children's blankets; Children's bed sheets, pillow cases, and blankets; Crib sheets; Dish towels; Face towels of textiles; Fleece blankets; Hand towels of textile; Kitchen towels; Pet blankets; Picnic blankets; Receiving blankets; Swaddling blankets; Travelling blankets" in International Class 024 ("Applicant's Goods").

6. Opposer's rights in the COMPHY Marks arose prior to the filing date of the Application or any other date on which Applicant may rely for purposes of priority.

7. Applicant's Goods are identical and/or substantially related to the products offered and sold by Opposer under the COMPHY Marks.

8. Applicant's Mark depicted in the Application looks and sounds similar to, and creates a similar commercial impression to, Opposer's COMPHY Marks, especially where both parties' marks are used in connection with bedding and related products.

9. Where, as here, the goods in the Application are broadly described and there is no limitation as to their nature, type, channels of trade, or class of purchasers, it is presumed that the Application encompasses all goods of the type described, that they move in all normal channels of trade, and that they are available to all classes of purchasers. Therefore, the parties' channels of trade and prospective purchasers are the same.

10. Upon information and belief, Applicant intends to promote and offer Applicant's Goods to the same and/or substantially related classes of consumers to which Opposer promotes and sells its products.

11. Applicant's Mark depicted in the Application so resembles Opposer's COMPHY Marks in sight, sound, meaning and commercial impression as to be likely to cause confusion, mistake or deception by causing the public to believe that Applicant's Goods originate from, or are otherwise sponsored or endorsed by Opposer in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d), with consequent damage to Opposer and the public within the meaning of 15 U.S.C. § 1063(a).

WHEREFORE, Opposer believes that it will be damaged by registration of Applicant's Mark, and it respectfully requests that this opposition be sustained and registration of Applicant's Mark be denied.

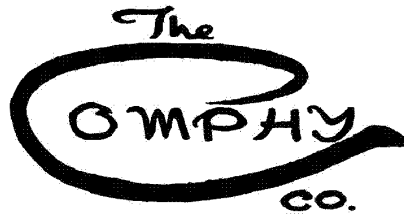
