STIPULATED MOTION TO AMEND IDENTIFICATION

Pursuant to a Settlement and Mutual Release Agreement entered into by the parties, Revel Brand Group LLC, d/b/a Revel Media (“Applicant”), and On The Revel Inc. (“Opposer”) hereby request that the Trademark Trial and Appeal Board (the “Board”) amend the identification of services included in Application Serial No. 97897522, for the mark “REVEL” [and Design], so that it reads as follows:

“Entertainment and media services, namely, providing non-downloadable content in the nature of pre-recorded videos, audio, podcasts, reality shows and vlogs featuring educational talks and events, documentary programs, ad campaigns, educational performances, comedic performances, political commentary, social commentary, music, spiritual commentary and other multimedia materials featuring reality, comedic, educational, enlightened and inspirational content, all online by means of the internet; Entertainment services, namely, providing a website in the nature of non-downloadable pre-recorded audio and video recordings featuring podcasts, educational content, events, performances, reality shows and vlogs, documentary programs, ad campaigns, educational performances, comedy performances, political commentary, social commentary, music, spiritual commentary and other multimedia materials featuring reality, educational, enlightened, inspirational and comedic content, all online by means of the internet; Production of audio and video recordings; Audiovisual production services, namely, recording and production of events, educational performances, comedy

performances, social causes, pop culture, news and entertainment; Television production services, namely, show development, treatment creation, executive production services, audiovisual recording, editing; Entertainment services, namely, media production services for motion pictures, television and internet; Event production services, namely, event hosting, conducting, organizing and arranging performances featuring cultural and educational entertainment, social commentary, and community building to be recorded into audio and visual recordings; Providing a website featuring commentary and information in the fields of reality television, social commentary, comedy, education and entertainment; Digital video, audio, and multimedia publishing services”, in Class 041.

For the Board’s convenience, the proposed amendment is shown here with deleted language presented in ~~bold strikethrough~~ and added language presented in **bold double underline**:

“Entertainment and media services, namely, providing non-downloadable content in the nature of pre-recorded videos, audio, podcasts, reality shows and vlogs featuring educational talks and events, documentary programs, ad campaigns, educational performances, comedic performances, political commentary, social commentary, ~~cannabis legalization commentary~~, music, spiritual commentary and other multimedia materials featuring reality, comedic, educational, enlightened and inspirational content, all online by means of the internet; Entertainment services, namely, providing a website in the nature of non-downloadable pre-recorded audio and video recordings featuring podcasts, educational content, events, performances, reality shows and vlogs, documentary programs, ad campaigns, educational performances, comedy performances, political commentary, social commentary, ~~cannabis legalization commentary~~, music, spiritual commentary and other multimedia materials featuring reality, educational, enlightened, inspirational and comedic content, all online by means of the internet; Production of audio and video recordings; Audiovisual production services, namely, recording and production of events, educational performances, comedy performances, social causes, pop culture, news and entertainment; Television production services, namely, show development, treatment creation, executive production services, audiovisual recording, editing; Entertainment services, namely, media production services for motion pictures, television and internet; Event production services, namely, event hosting, conducting, organizing and arranging **performances** featuring cultural and educational entertainment, social commentary, **and** community building, ~~and performances~~ to be recorded into audio and visual recordings; Providing a website featuring commentary and information in the fields of reality television, social commentary, comedy, education and entertainment; Digital video, audio, and multimedia publishing services”, in Class 041.

The parties respectfully submit that such amendment narrows, rather than broadens, the scope of the identification of services included in this application and, as such, neither republication nor further examination is required as a result of such amendment.
