**CONSOLIDATED NOTICE OF OPPOSITION**

Opposer, Jaguar Land Rover Limited, a United Kingdom private company limited by shares, having a principal place of business at Abbey Road, Whitley, Coventry CV3 4LF, United Kingdom (“Opposer”), believes that it is and will continue to be damaged by registration of the marks DEFENDER TARP SYSTEM and DEFENDER TARP SYSTEM and Design (“Applicant’s Marks”) in the name of Superior Tarp Systems, LLC (“Applicant”) shown in U.S. Trademark Application Serial Nos. 97504651 and 97504659, and hereby opposes the same.

Requests for extensions of time to oppose were filed on February 7, 2024 and were granted, extending the time to file to May 8, 2024.

As grounds of opposition, Opposer alleges that:

1. Opposer and its predecessors have manufactured and sold vehicles, vehicle parts and accessories, and a wide variety of related automotive and non-automotive goods and services worldwide for over 70 years.

2. Since at least as early as 1992, Opposer and/or its authorized licensees have used the trademark DEFENDER in connection with motor vehicles, vehicle parts and accessories, and related automotive and non-automotive goods and services in the United States and throughout the world.

3. In the United States, Opposer is the owner of the following registrations for DEFENDER, among others: Reg. Nos. 1803707, 6480929, and 6493772 for DEFENDER covering vehicles and vehicle-related goods in Class 12. These registrations are valid and subsisting, uncanceled, and unrevoked.

4. Printouts of these registrations from the Trademark Status & Document Retrieval system showing the current status and title of each of these registrations are attached hereto as Exhibit A, in accordance with 37 C.F.R. §2.122(d)(1).

5. Opposer and/or its licensees have expended considerable time, effort, and expense in advertising and promoting the DEFENDER mark and the goods and services associated with it throughout the United States, with the result that the purchasing public has come to know and recognize products of Opposer by the DEFENDER mark. Opposer has exceedingly valuable goodwill established in its DEFENDER mark.

6. On July 15, 2022, Applicant filed an intent-to-use application to register the mark DEFENDER TARP SYSTEM for “Cargo and carrier equipment for vehicles comprised of synthetic textile materials, excluding artificial leather, namely, tow ropes, tow straps, ratchet tie-down straps, quick release tie down straps, lashing straps, and tarp straps” in Class 22, which has been assigned Serial No. 97504651.

7. On July 15, 2022, Applicant filed an intent-to-use application to register the mark



DEFENDER TARP SYSTEM and Design for “Cargo and carrier equipment for vehicles comprised of synthetic textile materials, excluding artificial leather, namely, tow ropes, tow straps, ratchet tie-down straps, quick release tie down straps, lashing straps, and tarp straps” in Class 22, which has been assigned Serial No. 97504659.

8. There is no issue as to priority. Opposer used, filed, and/or registered Opposer’s Mark in connection with its goods prior to Applicant’s July 15, 2022 filing date.

9. Upon information and belief, Applicant did not use its DEFENDER TARP SYSTEM or DEFENDER TARP SYSTEM and Design marks prior to Opposer’s first use of Opposer’s Mark.

10. The DEFENDER component of Applicant’s DEFENDER TARP SYSTEM and DEFENDER TARP SYSTEM and Design marks is identical to Opposer’s DEFENDER Mark.

11. Applicant’s DEFENDER TARP SYSTEM and DEFENDER TARP SYSTEM and Design marks are confusingly similar to Opposer’s senior DEFENDER Mark.

12. The goods sold or intended to be sold by Applicant under its marks are the same or closely related to the goods sold by Opposer under Opposer's Mark.

13. Opposer is not connected with the goods sold or intended to be sold by Applicant under its marks.

14. Because the purchasing public has come to recognize and associate the goods of Opposer by Opposer's Mark, Applicant's proposed marks are likely to be confused with Opposer's Mark.

15. Applicant's Marks in Application Nos. 97504651 and 97504659 so resemble Opposer's DEFENDER Mark and the goods identified are so closely related to the goods of Opposer as to be likely, when used in connection with Applicant's goods, to cause confusion, or to cause mistake, or to deceive in violation of Section 2(d) of the Lanham Act, 15 USC §1052(d).

16. If Applicant were granted the registrations herein opposed, it would obtain at least a *prima facie* exclusive right to use of the DEFENDER TARP SYSTEM and DEFENDER TARP SYSTEM and Design marks in connection with the designated goods. Such registrations would be a source of injury and damage to Opposer's prior and established rights in its DEFENDER Mark.

WHEREFORE, Opposer respectfully requests that registration of the DEFENDER TARP SYSTEM and DEFENDER TARP SYSTEM and Design marks, Application Serial Nos. 97504651 and 97504659, be refused and this consolidated opposition be sustained.

The fee required under 37 C.F.R. § 2.6(a)(17) is being paid electronically concurrently with the filing of this Consolidated Notice of Opposition. If the filing fee is found to be insufficient for any reason, please charge such deficiency to the deposit account.
