New AHC Holdings, LLC (“Applicant”), a Delaware limited liability company, responds to American Health Companies, LLC’s (“Opposer”) Notice of Opposition to registration of the mark AHC (“Applicant’s Mark”) having Application Serial No. 97522798 (the “Application”). Applicant answers as follows:


In regard to the first unnumbered paragraph, Applicant lacks sufficient knowledge or information to confirm or deny the allegations concerning Opposer’s principal place of business, entity type, and state of incorporation and therefore denies the allegations. Applicant denies the remaining allegations in the first unnumbered paragraph.

In regard to the second unnumbered paragraph, the allegations state a legal conclusion to which no response is required, and therefore Applicant denies the same.

1. In regard to the allegations of Paragraph 1, Applicant admits only that the Application was filed on July 27, 2022, on behalf of Applicant, a Delaware LLC, the Applicant address and correspondence address, that the Application was filed intent-to-use, and Applicant is seeking registration for the recited services. Applicant lacks sufficient knowledge or information to confirm or deny the remaining allegations and therefore denies the same.

2. In regard to the allegations of Paragraph 2, admitted.

3. In regard to the allegations of Paragraph 3, Applicant lacks sufficient knowledge or information to confirm or deny the allegations regarding Opposer's activities and therefore denies the same. Applicant denies that Opposer has common law rights in the mark AHC and . Applicant denies the remaining allegations in Paragraph 3.

4. In regard to the allegations of Paragraph 4, Applicant admits only that the USPTO TSDR records list Opposer as the owner of Trademark Registration No. 6248709 for the trademark  for "Nursing services; physical rehabilitation services for patients who have undergone surgery, suffered an injury, or need post-acute care after a medical emergency, such as a stroke or heart attack" in International Class 044 and identify the register as the Principal Register and that Exhibit A contains a printout of the Registration Certificate and the USPTO TSDR record for U.S. Trademark Registration No. 6248709. Applicant denies that Opposer's alleged U.S. Trademark Registration No. 6248709 is valid. Applicant lacks sufficient knowledge or information to confirm or deny the remaining allegations and therefore denies the same.

5. In regard to the allegations of Paragraph 5, denied.

6. In regard to the allegations of Paragraph 6, Applicant lacks sufficient knowledge or information to confirm or deny the allegations regarding Opposer's activities and therefore denies the same. Applicant denies the remaining allegations in Paragraph 6.

7. In regard to the allegations of Paragraph 7, Applicant admits only that the Application was filed on July 27, 2022. Applicant denies the remaining allegations in Paragraph 7.

8. In regard to the allegations of Paragraph 8, Applicant admits only that Applicant's Mark AHC is identical in appearance and sound to Opposer's alleged common law AHC mark. The remainder of the allegations in Paragraph 8 are denied.

9. In regard to the allegations of Paragraph 9, denied.

#### **AFFIRMATIVE DEFENSES**



1. Opposer fails to state a claim upon which relief can be granted.

2. Applicant reserves the right to assert additional affirmative defenses at such time and to the extent warranted by discovery and the factual development of this case.


WHEREFORE, Applicant denies that Opposer is entitled to any relief, and respectfully requests that the Notice of Opposition be dismissed in its entirety.


## COUNTERCLAIM

New AHC Holdings, LLC (“Counterclaimant”), a Delaware limited liability company with a principal address at 140 N. Union Ave., Ste. 230, Farmington, Utah 84025, counterclaims to cancel Registration No. 6248709 pursuant to 15 U.S.C. § 1064 as follows:

1. American Health Companies, LLC (“Counterclaim Defendant”) is a Tennessee limited liability company, with a principal address of 201 Jordan Rd., Suite 200, Franklin, Tennessee 37067.
2. Counterclaimant filed Application No. 97522798 (“Application”) for the mark AHC (“Counterclaimant’s Mark”) for “providing short-term care facilities; rehabilitation patient care services which includes inpatient and outpatient care; physical rehabilitation; occupational therapy; speech therapy” in International Class 044 on July 27, 2022. The Application was filed intent-to-use. A USPTO TSDR extract of the Application is attached herein as Exhibit A.
3. Counterclaimant has used its AHC Mark with the applied-for services since at least as early as October 2007. Counterclaimant has acquired significant common law trademark rights and goodwill in its AHC mark through its continuous use of its AHC Mark since at least as early as October 2007.
4. Counterclaim Defendant has asserted Registration No. 6248709 for the mark  for “Nursing services; physical rehabilitation services for patients who have undergone surgery, suffered an injury, or need post-acute care after a medical emergency, such as a stroke or heart attack” in International Class 044 as a basis to oppose Application No. 97522798. Registration No. 6248709 claims  was first used anywhere and in commerce on August 1, 2019. A USPTO TSDR extract of Registration No. 6248709 is attached herein as Exhibit B.


5. Counterclaimant's use of AHC since October 2007 is earlier than Counterclaim

Defendant's claimed August 1, 2019 date of first use for .

6. Counterclaim Defendant's continued use of  when used in connection with the registered services, so resembles Counterclaimant's AHC Mark as to be likely to cause confusion, to cause mistake, or to deceive. Such confusion is likely to falsely suggest a connection between Counterclaimant and Counterclaim Defendant.

7. If Registration No. 6248709 remains registered, Counterclaimant's Application may be denied registration, harming Counterclaimant.

8. Counterclaimant has been damaged and will continue to be damaged by the continued registration of Registration No. 6248709.

WHEREFORE, Counterclaimant New AHC Holdings, LLC respectfully requests that U.S. Trademark Registration No. 6248709 for the mark  be cancelled. The statutory cancellation filing fee of \$600.00 is included herewith. Please charge any additional fees and credit any overpayment to Deposit Account No. 20-0100.
