**MOTION FOR EXTENSION OF TIME TO SEEK COUNSEL**

I am the attorney for Applicant Philip Thornton for the purpose of a resolution with Petitioner in this matter. I have not been retained to appear on his behalf in these proceedings.

On Applicant's behalf, I respectfully request an extension of time for him to retain new counsel to file an appearance on his behalf, as ordered on July 2, 2024. Under the order, Applicant must retain counsel by August 1, 2024.

I have communicated with Petitioner's counsel and we have been discussing a settlement which will, ideally, relieve the parties of the discovery and motion practice necessary to maintain this opposition proceeding. On Friday, July 26, 2024, I was notified by Petitioner's counsel that they are taking our proposal for resolution under consideration, but they will not consent to an extension of time for Applicant to find new counsel.

Mr. Thornton should be granted a 30-day extension of time to retain new counsel because: 1) he is, through counsel, engaging in meaningful discussions to resolve this matter with Petitioner; 2) he has, through counsel, made a good faith offer for settlement; 3) the undersigned counsel has not been retained to make an appearance at the TTAB, and his schedule might not

permit him to do so; and 4) Petitioner, who has not responded to the Applicant's last proposal, will not be prejudiced by an extension of time.

This is Applicant's first request for an extension of time.
