**STIPULATED AMENDMENT AND
CONDITIONAL WITHDRAWAL OF OPPOSITION**

Pursuant to Rule 2.133 of the U.S. Trademark Office’s Trademark Rules of Practice, Apex Tactical Specialties, Inc. (“Opposer”) and Polar Apex Oy (“Applicant”) stipulate to the following amendment of Application Serial No. 79377986 (the “Application”) as shown here:

Amendment of the identification of goods as follows (changes in red):

- Class 13: ~~Weapons, namely, firearms, guns and shotguns and ammunition;~~ component parts for guns, namely, heat insulating covers for firearm suppressors silencers and handguards

The amended goods identification should therefore read in its entirety:

- Class 13: Component parts for guns, namely, heat insulating covers for firearm suppressors and handguards

The Parties respectfully submit that this amendment does not broaden the scope of the description of goods listed in the Application, but rather narrows it, such that republication of the Registration is not required. 37 CFR § 2.71(a) and § 2.72(a).

Therefore, conditioned upon the Trademark Trial and Appeal Board’s approval of this stipulated amendment, Opposer withdraws its opposition to the subject Application, with prejudice, and with the consent of Applicant.
