**NOTICE OF OPPOSITION**

Pursuant to 15 U.S.C. § 1063(a) and 37 C.F.R. § 2.101, Eveden Inc., a corporation organized and existing under the laws of Massachusetts located and doing business at 65 Sprague Street, Boston, Massachusetts 02136 (“Opposer”), by its undersigned counsel, respectfully submits the following Notice of Opposition. Opposer believes that it is being, and will continue to be, damaged by the registration of the mark shown in Application Serial No. 98/297,629 in Class 25, filed by FantasyHubs LLC, a limited liability company having an address of 9758 105<sup>th</sup> St., Ozone Park, NY 11416 (hereinafter “Applicant”), on December 4, 2023, and which was published on August 6, 2024. Opposer opposes Application Serial No. 98/297,629 and requests that the registration be refused.

The grounds for this opposition are as follows:

1. Upon information and belief, Applicant, FantasyHubs LLC, is a limited liability company having an address of 9758 105<sup>th</sup> St., Ozone Park, NY 11416.

2. Upon information and belief, Applicant seeks to register the mark Fantasy Hubs (Applicant's Mark) for the goods "Lingerie" in International Class 025.
3. Upon information and belief, Applicant's application was filed on December 4, 2023, based upon an intent-to-use claim under Section 1(b); 15 U.S.C. § 1051(b).
4. Upon information and belief, Applicant's Application Serial Number is 98/297,629 (the "629 Application").
5. Upon information and belief, Applicant's '629 Application was published on August 6, 2024.
6. Opposer is a corporation organized and existing under the laws of Massachusetts located and doing business at 65 Sprague Street, Boston, Massachusetts 02136.
7. Opposer, through its parent company, predecessors-in-interest and affiliates, is now and has been involved in the business of, *inter alia*, designing, manufacturing and providing high quality women's clothing products, including, but not limited to, women's lingerie, underwear, brassieres, corsets, corselets, girdles, bra slips, bras, sports bras, maternity bras, knickers, swimwear, beachwear, bikinis, and bathing suits.
8. Opposer has become widely known nationally and worldwide as a provider of its women's clothing products, including, but not limited to, women's lingerie, underwear, brassieres, corsets, corselets, girdles, bra slips, bras, sports bras, maternity bras, knickers, swimwear, beachwear, bikinis, and bathing suits.
9. Opposer has acquired a favorable reputation throughout large segments of the relevant industry for its goods sold and provided under, and in association with its trademarks, including, but not limited to, FANTASIE, and any services related thereto.

10. Opposer is the owner of valid and subsisting U.S. Trademark Registration No. 2,447,377 (“the ‘377 Registration”), registered on May 1, 2001 on the Principal Register for the mark FANTASIE in International Class 25 as used in association with the following goods: “Women’s Clothing; namely Lingerie.”

11. Opposer is the owner of valid and subsisting U.S. Trademark Registration No. 3,133,514 (“the ‘514 Registration”), registered on August 22, 2006 on the Principal Register for the mark FANTASIE in International Class 25 as used in association with the following goods: “Swimwear, beachwear, bikinis, bathing suits.”

12. Both the ‘377 Registration and the ‘514 Registration are conclusive evidence of the validity of the registrations, of Opposer’s ownership thereof, and of Opposer’s exclusive right to use the registered marks in commerce in connection with the goods specified in the respective registrations. Pursuant to Rule 2.122(d), Opposer attaches hereto, as Exhibit A and Exhibit B, a printout from the Trademark Status and Document Retrieval (TSDR) electronic database showing the current status and title of each of the above registrations.

13. Both Opposer’s ‘377 Registration and ‘514 Registrations were granted incontestable status under Section 15 of the Trademark Act. These trademarks and registrations therefor are valid and subsisting, and Opposer owns the FANTASIE trademarks, the registrations, and the goodwill of the business associated with such marks.

14. From a date long prior to Applicant’s filing date, Opposer has used its marks FANTASIE in connection with clothing goods, including but not necessarily limited to, women’s clothing; namely lingerie, beachwear and swimwear.

15. The goods set forth in Applicant’s ‘629 Application are identical to and/or closely related to the goods in International Class 025 in connection with which Opposer has

used and is using its marks FANTASIE. In addition, upon information and belief, Applicant's goods would be offered to the same classes of customers who purchase Opposer's goods offered under its marks FANTASIE.

16. The applied-for mark in Applicant's '629 Application is substantially similar to Opposer's Mark FANTASIE, and is likely to cause confusion, mistake and deception as to the source of Applicant's goods, all to Opposer's damage and in violation of 15 U.S.C. § 1052(d). Consumers are likely to believe that Applicant's goods offered in connection with the mark that is the subject of Applicant's '629 Application emanate from, or are licensed by, approved by, or otherwise associated with Opposer, when they are not. Any dissatisfaction with Applicant's goods will adversely reflect upon and irreparably damage Opposer's reputation and goodwill as embodied in its marks FANTASIE.

17. Applicant's Mark is confusingly similar in appearance, sound, connotation and commercial impression to Opposer's registered trademarks.

18. Applicant's filing of the '629 Application was without license, authorization or permission of Opposer.

19. By reason of the foregoing, Applicant's registration of the mark herein opposed would cause significant damage and injury to Opposer, to Opposer's rights in its marks, and to the use thereof as described herein.

20. Accordingly, registration of Applicant's Mark would damage Opposer and registrations; therefore, Applicant's Mark in International Class 025 should be refused pursuant to Section 2(d) of the Trademark Act.

## CONCLUSION

21. If Applicant is granted the registration herein opposed, Applicant would thereby obtain a prima facie exclusive right to use of the applied-for mark, which would be a further source of damage to Opposer.

**WHEREFORE**, Opposer believes that it will be damaged by registration of the mark in International Class 025 which is the subject of the U.S. Trademark Application Serial No. 98/297,629, and therefore, respectfully requests that such registration be refused.
