NOTICE OF OPPOSITION

Opposer La Posta Group, Inc. (“Opposer”) believes that it will be damaged by registration of the LA POSTA mark (the “Opposed Mark”) applied for in Application Serial No. 98/138,382 (the “Opposed Application”) by applicant Laura Ines Catena (“Applicant”). As grounds for its Opposition, Opposer alleges as follows:

1. Opposer is a corporation formed in New Mexico having its principal place of business at 2410 Calle de San Albino, Mesilla, New Mexico 88046.
2. Opposer currently is and has been in the business of providing restaurant services and retail store services featuring food products and gift items in interstate commerce in the United States.
3. Opposer’s predecessors-in-interest first used the LA POSTA mark in 1939 for the La Posta de Mesilla Restaurant located in the historic La Posta Compound in Old Mesilla, New Mexico (near the city of Las Cruces). Since that time, La Posta de Mesilla has grown to become

one of the most famous restaurants in the Southwest, and correspondingly, Opposer's LA POSTA marks are famous throughout the Southwest and the United States.

The Opposer's Marks

4. Opposer owns a number of U.S. trademark registrations for marks consisting of or containing LA POSTA. Opposer's marks consisting of or containing LA POSTA are collectively referred to as the "LA POSTA Marks," and Opposers registrations for the LA POSTA Marks are referred to as the "LA POSTA Registrations."

5. The LA POSTA Registrations include Reg. No. 0966731 for **LA POSTA** (standard characters), registered August 21, 1973, for "restaurant services" in Class 42. Opposer has used this mark since at least as early as September 16, 1939. Through more than 85 years of continuous use, Opposer has developed substantial goodwill in this mark, and it has become widely known to the general public as a source identifier related to Opposer and its services. Exhibit A contains a copy of the '731 Registration and a printout from the TSDR System ("TSDR") that shows that this registration is active and owned by Opposer. The '731 Registration is now incontestable.

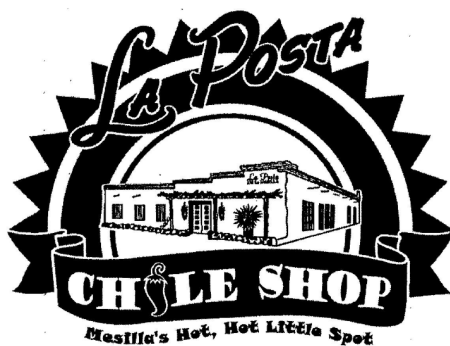
6. Opposer owns Reg. No. 2593885 for **LA POSTA DE MESILLA** (& Design, pictured below), registered July 16, 2002, for "restaurant services" in Class 42:



Opposer has used this mark in connection with its restaurant services since at least as early as September 16, 1939. Through more than 85 years of continuous use, Opposer has developed substantial goodwill in this mark, and it has become widely known to the general public as a source identifier related to Opposer and its services. Exhibit B contains a copy of the '885 Registration

and a printout from the TSDR System that shows that this registration is active and owned by Opposer. The '885 Registration is now incontestable.

7. Opposer owns Reg. No. 2597357 for the **LA POSTA** logo pictured below, registered July 23, 2002, for “retail store services featuring salsa, chili sauce, pepper sauce, burritos, chalupas, cheese sauce, chili peppers, chili powder, corn chips, taco chips, taco shells, chile con queso, enchiladas, hot sauce, package combinations consisting primarily of sauces, corn chips, corn shells, and/or flour shells, seasonings, sopapillas, tacos, tamales, tortilla chips, tortilla shells, tortillas, enchilada sauces, chile pottery (salsa dishes, chip n' dip, platters, bowls), chile art, chile linens, chile oils, candles, posters, ornaments” in Class 35:



Opposer has used this mark in connection with its services since at least as early as November 2, 2000. Through more than 24 years of continuous use, Opposer has developed substantial goodwill in this mark, and it has become widely known to the general public as a source identifier related to Opposer and its services. Exhibit C contains a copy of the '357 Registration and a printout from the Trademark Status & Document Retrieval System that shows that this registration is active and owned by Opposer. The '357 Registration is now incontestable.

8. Opposer owns Reg. No. 7523565 for **LA POSTA** (standard characters), registered October 1, 2024, for “Salsa, chili sauce, pepper sauce, dried chili peppers, chili powder, hot sauce;

food package combinations consisting primarily of sauces, all sold as a unit; seasonings, enchilada sauces” in Class 30. Opposer has used this mark since at least as early as January 31, 2023. Exhibit D contains a copy of the ‘565 Registration and a printout from the TSDR System that shows that this registration is active and owned by Opposer.

9. Opposer owns Reg. No. 7495564 for **LA POSTA DE MESILLA** (standard characters), registered September 3, 2024, for “Salsa, chili sauce, pepper sauce, dried chili peppers, chili powder, hot sauce; food package combinations consisting primarily of sauces, all sold as a unit; seasonings, enchilada sauces” in Class 30. Opposer has used this mark in connection with these goods since at least as early as February 17, 2021. Exhibit E contains a copy of the ‘564 Registration and a printout from the TSDR System that shows that this registration is active and owned by Opposer.

10. Opposer owns pending application Ser. No. 98405518 for **LA POSTA** (standard characters), for “Burritos, chalupas, cheese sauce, corn chips, taco chips, taco shells, enchiladas; corn taco shells, and flour taco shells, sopapillas, tacos, tamales, tortilla chips,” in class 30. Exhibit F contains a printout from the TSDR System that shows the status of this application.

11. Opposer owns pending application Ser. No. 98405523 for **LA POSTA DE MESILLA** (& Design, pictured below) for “Burritos, chalupas, cheese sauce, corn chips, taco chips, taco shells, enchiladas; corn taco shells, and flour taco shells, sopapillas, tacos, tamales, tortilla chips, tortilla shells, tortillas,” in Class 30.

The Applicant and the Opposed Mark:

12. Upon information and belief, Applicant is an individual with an address of 183 Carl Street, San Francisco, California 94117.

13. Upon information and belief, Applicant was born in Argentina and holds dual citizenship in Argentina and the United States.

14. Application serial no. 98/138,382 was filed on August 17, 2023, to register the standard character mark LA POSTA.

15. Applicant seeks to register its mark in connection with “Wines; Alcoholic beverages except beers; Sparkling wines” in international class 033. The Opposed Application was filed under §44(e) based on Argentina Reg. No. 2836799.

16. The Opposed Application was published for opposition on August 20, 2024. On September 16, 2024, Opposer filed a timely ninety-day extension of time request in which to file an opposition proceeding.

Count I – Likelihood of Confusion, 15 U.S.C. § 1052(d)

17. Opposer incorporates and re-alleges the preceding paragraphs as if set forth in full.

18. The Opposed Mark so resembles Opposer’s LA POSTA Marks that use and registration of the Opposed Mark in connection with the applied-for goods would be likely to cause confusion, mistake, or deception as to the source or origin of the Applicant’s goods in violation of section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

19. Opposer’s rights in its LA POSTA Marks and LA POSTA Registrations are senior to Applicant’s rights in her LA POSTA Mark. Opposer began use of and registered most of its LA POSTA Marks many years before the filing date of the Opposed Application. The LA POSTA

‘731 Registration issued more than fifty years before the filing date of the Opposed Application, and the ‘885 and ‘357 Registrations issued more than twenty years before the filing date of the Opposed Application.

20. The Opposed Mark is confusingly similar in sight, sound, and connotation to Opposer’s LA POSTA Marks. Both parties’ marks contain the prominent term “LA POSTA,” which is also either the sole or dominant portion of each LA POSTA Mark.

21. The Opposed Mark is also confusingly similar because the Opposed Application identifies the mark as used in connection with goods that are highly related to the services covered by the LA POSTA Registrations and offered by Opposer under its LA POSTA Marks. In particular, the LA POSTA Mark has been in use since 1939 in connection with restaurant services, which includes on its menu wine and alcoholic beverages.

22. Further, Opposer offers not only restaurant services but also various food items under its LA POSTA Marks. Therefore, when encountering a LA POSTA Mark on food and beverage items that are of the type served in connection with Opposer’s restaurant services, Consumers are likely to believe such goods are related to Opposer’s restaurant services.

23. Because the goods and services of the parties are highly related, the public is likely to be confused, mistaken, or deceived into believing that Applicant’s goods are offered by Opposer or that Opposer has sponsored, endorsed, or is affiliated with Applicant in some way.

24. Applicant is not affiliated with, connected with, endorsed by, or sponsored by Opposer. Additionally, Opposer has not authorized or licensed use of its marks, nor has it approved any of the goods identified as being offered in connection with the Opposed Mark.

25. Use and registration by Applicant of the LA POSTA Mark will thus injure or damage Opposer, as well as the goodwill and reputation related to and represented by the LA

POSTA Marks and registrations.

26. Opposer has no control over the nature or quality of the goods that Applicant intends to offer under the Opposed Mark. Possible dissatisfaction with the Applicant's goods could damage Opposer's goodwill and reputation related to its LA POSTA Marks.

27. Registration of Opposed Mark would further damage Opposer because, if such registration is granted, it may narrow the scope of protection afforded to Opposer's LA POSTA Marks and registrations. Such registration may also tend to restrict, interfere with, damage, or impair the conduct of Opposer's business.

28. Thus, use and registration by Applicant of Opposed Mark is likely to cause confusion, mistake, or deception in the minds of the public, which will cause damage and injury to both Opposer and the public. Registration of Opposed Mark should be denied under at least section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

PRAYER FOR RELIEF

By this Notice of Opposition, Opposer prays for and requests that this Opposition be sustained; that Application Serial No. 98/138,382 be rejected; that registration of the Opposed Mark be refused; and that the Trademark Trial and Appeal Board award all other and further relief as is proper and just.
