

NOTICE OF OPPOSITION

Opposer, Loft IpCo LLC, a Delaware limited liability company having a place of business at 933 MacArthur Blvd., Mahwah, NJ 07430 (hereinafter “Loft” or “Opposer”), believes it will be damaged by the issuance of a trademark registration to RH California, a California corporation having a place of business at 6219 Encinita Ave., Temple City, California 91780 (hereinafter “Applicant”) for its Application Serial No. 98/588,064 filed on June 6, 2024 for the mark STYLOFT in International Class 25 (the “Opposed Application”). Loft opposes registration of this application on the following grounds:

1. LOFT is a premier provider of women’s apparel and accessories. LOFT has created, developed, and used its well-known name and trademarks (the “LOFT Marks”) for over thirty years to advertise, promote, and sell women’s clothing, bags and accessories online at <https://www.loft.com/> and through more than 500 LOFT retail and outlet stores nationwide.

2. Since long prior to the filing date of the application at issue or, on information and belief, prior to any purported use of the mark identified therein, the LOFT Marks have been used

by Loft or its predecessors for retail, apparel, bags, and accessory products and services, and have become well and favorably known to the general public. As a result, consumers immediately identify Loft as the exclusive source of its retail-oriented goods and services.

3. In addition to its established common law rights, Loft has obtained multiple United States trademark registrations for the LOFT Marks in connection with clothing, bags, accessories, and services related thereto, including but not limited to:

4. Loft's registrations for the foregoing marks are valid, subsisting, in full force and effect, uncanceled, and unrevoked, and serve as evidence of its exclusive right to use such marks in commerce on or in connection with the goods and services identified in the registrations as provided by Section 33(a) of the United States Trademark (Lanham) Act, 15 U.S.C. § 1115(a). Moreover, all of the foregoing registrations are statutorily incontestable pursuant to Section 15 of

the Lanham Act, 15 U.S.C. § 1065. Copies of the United States Patent and Trademark Office's ("USPTO") Trademark Status and Document Retrieval ("TSDR") Status for the above referenced marks are attached hereto as **Exhibit A**.

5. The LOFT Marks are distinctive and became famous long prior to the filing date of the Opposed Application, and upon information and belief, prior to the use of the mark at issue in interstate commerce by Applicant, if any.

6. Use of the LOFT Marks has been continuous and the marks have not been abandoned. By virtue of Loft's longstanding and exclusive use and registration of its marks and the considerable time, effort, and expense it has expended on advertising and promoting its business and related offerings under such marks, the LOFT Marks are entitled to the broadest scope of protection under United States trademark laws and represent assets of enormous value to Loft.

7. On June 6, 2024, Applicant filed United States trademark application Serial No. 98/588,064 for STYLOFT in standard characters based on an intent to use the mark in commerce in connection with "Hats; Hosiery; Scarfs; Shoes; Belts for clothing; Bottoms as clothing for adults, children; Clothing layettes; Gloves as clothing; Surf wear; Swim suits; Tops as clothing for adults, children" in Class 25.

8. Registration of Applicant's alleged mark, which is the subject of the Opposed Application, is barred by the provisions of Section 2(d) of the Trademark Act of 1946 because the applied-for mark consists of or comprises a mark which so resembles the LOFT Marks as to cause confusion, mistake, or deception when used in connection with Applicant's applied-for goods.

9. Loft has standing and priority over Applicant because Loft's use, application filing dates and/or registration dates for the LOFT Marks precede the Applicant's filing dates and any purported use of the mark at issue for its application to register the STYLOFT designation.

10. Applicant's alleged mark is highly similar to the LOFT Marks and is likely to cause confusion in the marketplace due, in pertinent part, to the full incorporation of Loft's LOFT mark in connection with clothing and accessories. The goods covered by the Opposed Application are identical to Loft's registered goods and highly complementary to Loft's registered services offered under the LOFT Marks.

11. Upon information and belief, at the time Applicant filed the Opposed Application, it was or should have been fully aware of Loft's LOFT Marks and its rights therein.

12. Because Applicant has essentially copied Opposer's LOFT Marks – differing only by connecting the letters STY with the LOFT mark – for use in connection with goods that are identical and/or complementary to goods and services offered by Loft under the LOFT Marks, the likelihood of confusion, mistake, or deception that would arise from concurrent use and registration of the alleged mark that is the subject of the Opposed Application with Loft's use and registration of its LOFT Marks is that persons are likely to believe that (a) Applicant's goods have their source in Loft, or (b) Applicant and its goods are in some way legitimately connected or affiliated with Loft and its goods and services when, in fact, they are not.

13. Pursuant to Section 13 of the Lanham Act, 15 U.S.C. §1063, Loft will be damaged by the registration sought by Applicant, as such registration would support and assist Applicant in the confusing, misleading, and/or deceptive use of the Opposed Application and would give color of exclusive statutory right to Applicant in violation and derogation of the prior and superior rights of Loft.

14. Accordingly, registration of Applicant's Opposed Application is barred on the grounds that the purported mark so resembles the LOFT Marks as to be likely to cause confusion,

mistake, or deception under the provisions of Section 2(d) of the Trademark Act of 1946, 15 U.S.C. § 1052(d).

15. Further, registration and use of Applicant's alleged STYLOFT mark which is the subject of the Opposed Application would, in violation of 15 U.S.C. § 1125(c), likely dilute the distinctiveness of Loft's famous and highly distinctive LOFT Marks, which became highly distinctive and famous long prior to the filing date of the Opposed Application. Accordingly, Applicant's alleged STYLOFT mark is not entitled to registration under 15 U.S.C. § 1052(d) and Section 13 of the Lanham Act, 15 U.S.C. § 1063.

16. In view of the foregoing, issuance of registration to Applicant for its claimed STYLOFT mark which is the subject of the Opposed Application would be damaging to Loft's LOFT Marks within the meaning of Section 13 of the Lanham Act, 15 U.S.C. § 1063.


