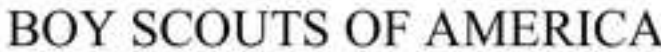

3. Opposer is a well-known youth organization in the United States.

4. Beginning around February 8, 1910, and continuing to the present, Opposer has been engaged in the organization and management of programs for young people.

5. Opposer adopted and began using marks and names incorporating the term “SCOUT” since at least as early as 1910 (Opposer’s marks and names incorporating “SCOUT”, registered and unregistered, are collectively referred to as “Opposer’s Scout Marks” or “Scout Marks”).

6. The United States Congress granted Opposer the exclusive right to use its various marks with 36 U.S.C. § 30905, a federal statute providing that Opposer “has the exclusive right to use emblems, badges, descriptive or designating marks, and words or phrases the corporation [*i.e.*, Opposer] adopts”.

7. Opposer operates various programs for youth, including the CUB SCOUTS, SCOUTS BSA and SEA SCOUTS, which, in addition to the names and ranks BOYS SCOUTS OF AMERICA, BOY SCOUTS, EAGLE SCOUT, SCOUTS, SCOUT, and SCOUTING, are well known and famous names and identities of Opposer (the names and identities set forth in this paragraph are collectively referred to herein as Opposer’s “Scout Names and Identities” and are part of Opposer’s Scout Marks).

8. Opposer has used and/or been known by its Scout Names and Identities since long before the filing date of Applicant’s Subject Application, and before any date of actual first or constructive use Applicant may claim for Applicant’s Mark (defined below).

9. In addition to, and as part of its many programs, Opposer offers various educational programs and activities. As an example, Opposer’s members can learn about nature, outdoor survival, sports, crafts, science, trades, business, and future careers as

they earn merit badges for doing so. There are more than 135 merit badges covering a wide range of topics. See www.scouting.org/skills/merit-badges/.

10. Since its inception, outdoor educational programs and activities such as backpacking, camping, hiking, and orienteering, among others, have been a central focus of Opposer.

11. In fact, Opposer offers awards and merit badges for, among other things, backpacking, camping, hiking, orienteering, and wood carving, see, e.g., www.scouting.org/merit-badges/camping/; www.scouting.org/merit-badges/hiking/; and www.scouting.org/merit-badges/wood-carving/ and, in particular, offers award badges for successfully demonstrating knife use and safety, see, e.g., <https://www.scouting.org/awards/awards-central/totin-chip/> (the Totin' Chip award badge).

12. Opposer's youth members often use knives for Opposer's outdoor educational programs and activities, and when participating in Opposer's various adventures. See, e.g., <https://www.scouting.org/cub-scout-adventures/whittling/> (Whittling); <https://www.scouting.org/cub-scout-adventures/knife-safety/> (Knife Safety).

13. The use of knives is such a core part of Opposer's programs, activities and adventures that knives have become associated with Opposer.

14. In fact, a federal appellate court and the U.S. Patent & Trademark Office have recognized that the term "SCOUT" as used with knives is indicative of Opposer. See *Adolph Kastor & Bros., Inc. v. Fed. Trade Comm'n*, 138 F.2d 824, 60 USPQ 154 (2d Cir. 1943) (enjoining use of "SCOUT" on pocket knives because the word falsely suggested sponsorship by Opposer), and *Boy Scouts of America v. Winchester*

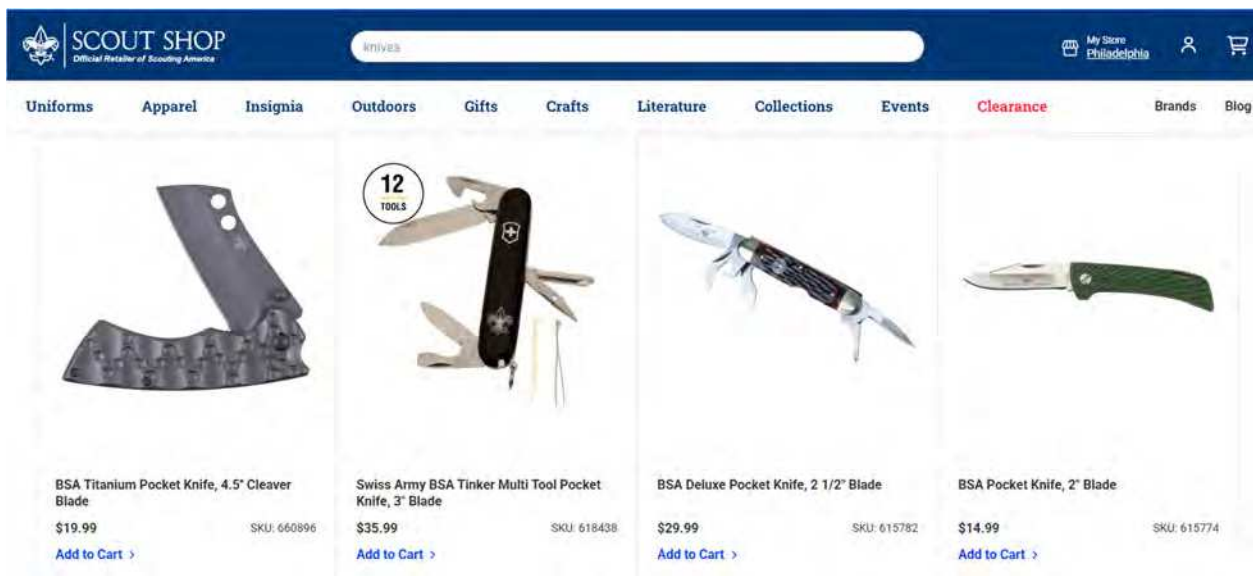
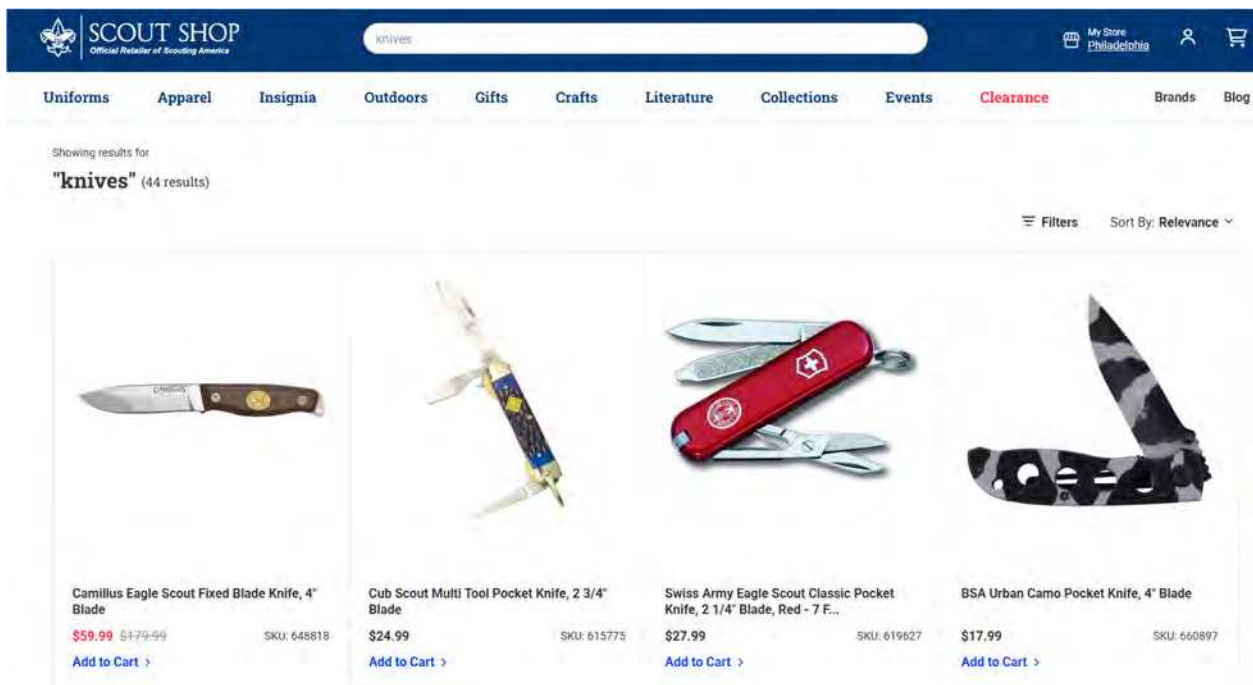
Repeating Arms Co., 15 Trademark Rep. 142 (1925) (denying manufacturer's application to register the phrase "WINCHESTER SCOUT" for knives because use of "SCOUT" falsely suggested sponsorship by Opposer).

15. Beginning shortly after its founding in 1910 and up until the present, Opposer has contracted with manufacturers for the production of knives and has granted licenses to the manufacturers to mark such knives with Opposer' trademarks to identify the knives as official and/or approved knives of Opposer.

16. Opposer and its licensees have promoted and advertised the sale and distribution of knives under Opposer's various trademarks and names, which have included BOY SCOUTS OF AMERICA, CUB SCOUTS, a trefoil fleur-de-lis design, BOY SCOUTS, SCOUT KNIFE, SCOUT, BSA, OFFICIAL CUB SCOUT KNIFE, OFFICIAL BOY SCOUT KNIFE, and EAGLE SCOUT.

17. In addition to its educational programs, activities and adventures, and since a date prior to any priority date that Applicant could rely on in this Opposition, Opposer has also sold, among other things, knives, through brick-and-mortar locations under the name "Scout Shop."

18. Opposer also operates an online retail store under the name "Scout Shop" at URL <https://www.scoutshop.org/>, which online Scout Shop has operated since a date prior to any priority date that Applicant could rely on in this Opposition, and which sells knives that include thereon Opposer's famous fleur-de-lis trademark, as shown below:

19. Opposer began using its Scout Marks in the United States long before the filing date of the Application, and long before any date of actual first use Applicant may claim.

20. Opposer is the owner of, and will rely on herein, the following valid and subsisting United States trademark registrations which include trademarks, service marks, and collective membership marks (collectively, “Opposer’s Registered Scout Marks”), all of which form part of Opposer’s Scout Marks:

True and correct copies of the pleaded registrations from the U.S. Patent and Trademark Office's database showing the current status and title thereof are attached as **Exhibit A**.

21. In view of Opposer's Registered Scout Marks, Opposer has priority in this Opposition.

22. Opposer is also the owner of common law rights resulting from its continuous and extensive use over decades of its marks, names, symbols and designs in connection with its various members, programs, goods and services (collectively, "Opposer's Common Law Scout Marks"), and which are part of Opposer's Scout Marks.

23. Opposer's Common Law Scout Marks include, without limitation the following: (a) SCOUT as used to identify a member of Opposer's organization and Opposer's goods and services, including, but not limited to camping, hiking, and other outdoor activities and goods associated therewith; (b) SCOUTS as used to identify membership in Opposer's organization, troops and units of Opposer, and goods and services of Opposer including, but not limited to camping, hiking, and other outdoor activities and goods associated therewith; (c) SCOUTING, BOY SCOUTS OF AMERICA, BOY SCOUTS, CUB SCOUTS, EAGLE SCOUTS and SCOUTS BSA as used in association with Opposer's organization, participation in Opposer's programs, activities and adventures, and goods and services of Opposer including, but not limited to camping,

hiking, and other outdoor activities and goods associated therewith; and (d) SCOUT SHOP as used in connection with the sale of, among other items, camping and outdoors items such as knives.

24. Opposer's Common Law Scout Marks have been continuously and extensively used in commerce by Opposer and are inherently distinctive or have obtained secondary meaning since long before the filing date of the Subject Applications, and long before any subsequent date of actual first use that Applicant may later claim.

25. Opposer's Scout Marks constitute a family of marks that include the term "SCOUT".

26. Opposer has established a valuable reputation and substantial goodwill in the Scout Marks by reason of their long use, extensive promotion, sale of goods, and providing of services under the Scout Marks.

27. Because of Opposer's long use and extensive marketing efforts and offer and sale of goods and services under its Scout Marks, Opposer's Scout Marks are well-known, famous, and the public has come to associate said Scout Marks with Opposer.

28. Applicant's Mark as proposed for registration is substantially similar to and/or identical to Opposer's Scout Marks.

The Subject Application

29. Applicant filed U.S. Trademark Application Serial No. 98589837 on March 24, 2024 (the "Subject Application"), seeking registration of the mark SCOUTRAT ("Applicant's Mark") for use in connection with "Daggers; Penknives; Folding knives; Hand tools, namely, pincers; Hobby knives; Manicure sets; Oyster openers; Razor blades;

Table cutlery, namely, forks, spoons, knives; Thin-bladed kitchen knives; Hand tools, namely, shovels” in Class 008 (collectively, “Applicant’s Goods”).

30. Applicant’s Mark as proposed for registration is substantially similar to and/or identical to Opposer’s Scout Marks.

31. Applicant’s Goods, for which Applicant seeks registration of Applicant’s Mark, are identical, similar or related to the goods, services or collective membership for which Opposer uses and/or has registered its Scout Marks.

32. Applicant’s Goods also target the same classes of purchasers as Opposer’s goods, services and/or collective membership services.

33. Applicant filed the Subject Application based on use, claiming first use and first use in commerce dates of April 9, 2024, for Applicant’s Mark.

34. The Subject Application includes a Declaration, verified by Applicant’s attorney, stating, in relevant part, that, “[t]he mark is in use in commerce and was in use in commerce as of the filing date of the application on or in connection with the goods/services in the application” and that “[t]he specimen(s) shows the mark as used on or in connection with the goods/services in the application and was used on or in connection with the goods/services in the application as of the application filing date[.]”

35. The Subject Application also includes a Declaration, verified by Applicant’s attorney, that “[t]he signatory being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements and the like may jeopardize the validity of the application or submission or any registration resulting therefrom, declares that all statements made of his/her own

knowledge are true and all statements made on information and belief are believed to be true.

36. In support of its use-based Subject Application, Applicant filed the following three specimens of use of Applicant's Mark: (a) a purported printout of a webpage allegedly found at URL <https://sh.com.gl/products/scoutrat-folding-knives-mini-folding-pocket-knife-sharp-camping-survival-hiking-knives>, showing a photograph of a folding knife bearing the word "Scoutrat"; (b) unlabeled photographs of a folding knife bearing the word "Scoutrat"; and (c) screenshots purporting to show three orders of Scoutrat knives allegedly shipped to customers in the United States on June 6, 2024, just one day before Applicant filed the Subject Application (collectively, "Applicant's Specimens").

37. Upon information and belief, and after investigation, Applicant was not using Applicant's Mark in commerce in the United States in connection with some or all the goods identified in the Subject Application on April 9, 2024, as attested to in the Subject Application, or at the time Applicant filed the Subject Application on June 7, 2024.

38. Upon information and belief, and after investigation, Applicant has never used Applicant's Mark in commerce in the United States in connection with some or all the goods identified in the Subject Application, as attested to in the Subject Application.

39. Applicant's Specimens purportedly show use of Applicant's Mark only in connection with a folding knife.

40. However, the following goods are also identified in the Subject Application: daggers; penknives; hand tools, namely, pincers; hobby knives; manicure sets; oyster openers; razor blades; table cutlery, namely, forks, spoons, knives; thin-bladed kitchen knives; or hand tools, namely, shovels.

41. Applicant's Specimens do not show use of Applicant's Mark in connection with any of the goods listed in Paragraph 40 above.

42. Further, a May 13, 2025, Google internet search using the term "scoutrat" did not return any results showing use of Applicant's Mark in connection with any of the goods listed in Paragraph 40 above. A true and correct copy of a printout of the May 13, 2025 Google internet search results is attached as **Exhibit B**.

43. Additionally, upon information and belief, and after investigation, Applicant's Specimens are suspect for the reasons stated below and do not show actual use of Applicant's Mark in the United States in connection with folding knives.

44. Despite including a purported date and time stamp at the top of each of page, Applicant's first Specimen, a purported printout of a webpage showing a folding knife bearing the word "Scoutrat," does not identify a URL address on any of its pages.

45. When a user prints a webpage, the website URL typically appears on each page together with the date and time stamp. Such is not the case here.

46. In the block labeled "Webpage URL" on the Subject Application, Applicant identifies the URL for the alleged webpage as <https://sh.com.gl/products/scoutrat-folding-knives-mini-folding-pocket-knife-sharp-camping-survival-hiking-knives>.

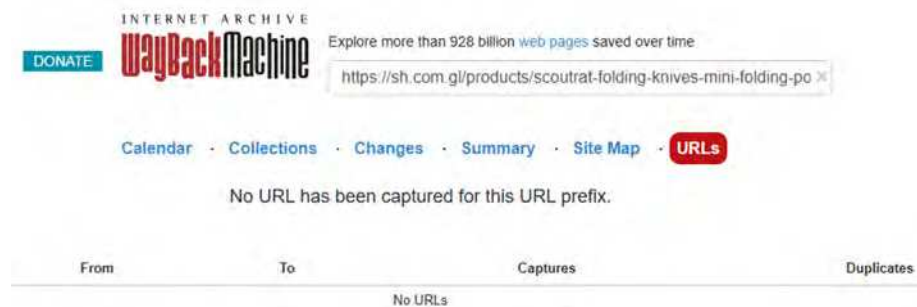
47. However, when a user attempts to access that URL, he or she receives the following message stating, in relevant part, "403 Forbidden":

A true and correct printout of the screen found at URL <https://sh.com.gl/products/scoutrat-folding-knives-mini-folding-pocket-knife-sharp-camping-survival-hiking-knives>, as accessed on May 13, 2025, is attached as **Exhibit C**.

48. Further, when a user searches the Wayback Machine Internet Archive using the URL cited by Applicant, the user receives the following screen, stating that “No URL has been captured for this URL prefix”:



A true and correct printout of the screen received as result of a May 13, 2025 search of the Wayback Machine Internet Archive using the URL cited in the Subject Application is attached as **Exhibit D**.

49. Applicant's second Specimen is comprised solely of photographs of a single folding knife bearing the word "Scoutrat." The photographs do not show the sale and/or shipment of Applicant's Goods in or to the United States.

50. Applicant's third Specimen is comprised of screenshots purporting to show three orders of "Scoutrat" knives allegedly shipped to customers in the United States on June 6, 2024, just one day before Applicant filed the Subject Application.

51. The screenshots appear to be Applicant's **internal** business records and are not invoices sent to customers evidencing use of Applicant's Mark.

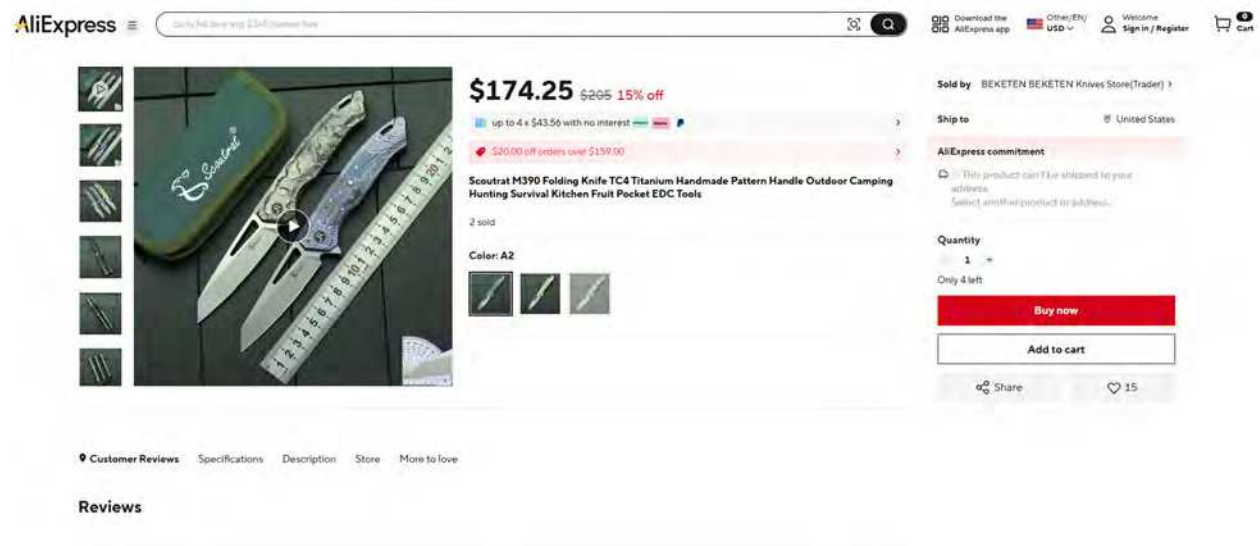
52. Further, the names and addresses of the purported customers are redacted in their entirety, except for the words “United States.” Thus, the identities and alleged street addresses of the purported U.S. customers cannot be verified.

53. Notably, a May 13, 2025 Google internet search using the search term “scoutrat knives” returned only three potential results for Applicant’s Goods. A true correct printout of the results of the May 13, 2025 Google search is attached as **Exhibit E**.

54. The first Google result is for an AliExpress listing labeled “Scoutrat M390 Folding Knife TC4 Titanium Handmade.”

55. AliExpress is a Chinese online marketplace.

56. When a user clicks on the link for the AliExpress listing, the user is taken to the following screen that purports to show a Scoutrat folding knife for sale for \$174.25:

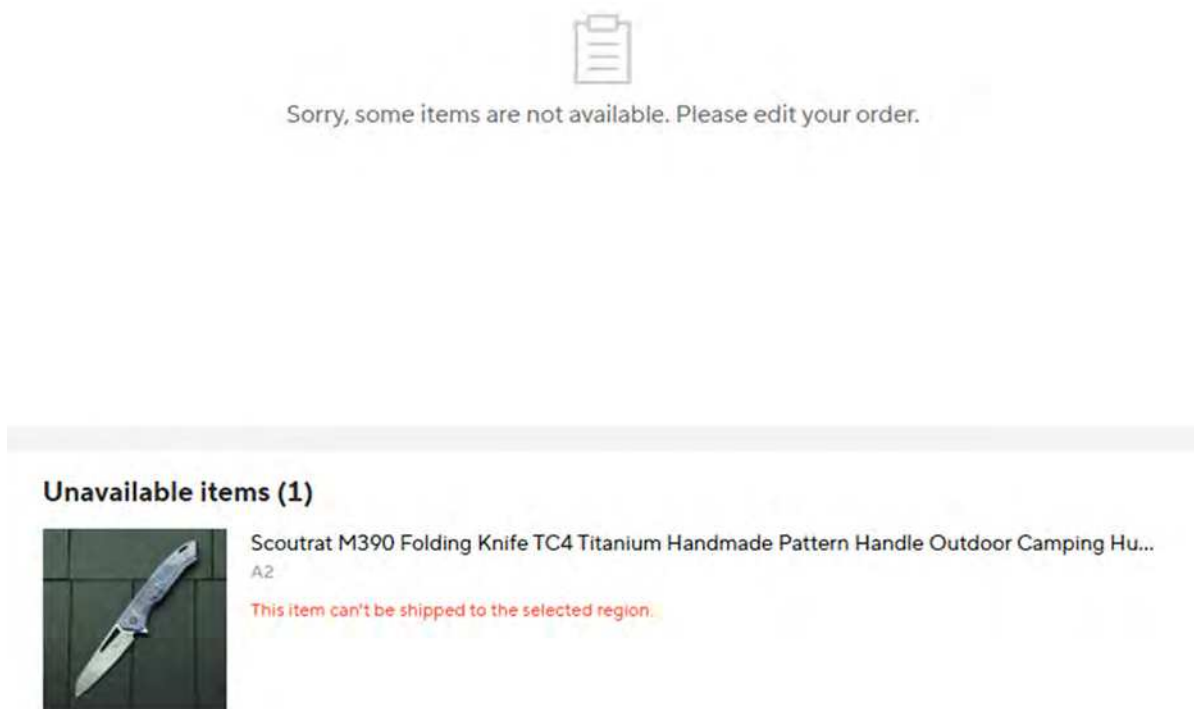

57. Notably, the list price for the Scoutrat folding knife is \$174.25 on sale (\$205.00 regular price)—nearly 7 times the \$25.98 price listed for the Scoutrat folding

knife depicted in Applicant's Specimens.

58. Further, when a user tries to add the Scoutrat product to the cart for delivery to a United States address, the user receives the following message stating, in relevant part: "This item can't be shipped to the selected region":



A true and correct copy printout of this screen, as accessed on May 13, 2025, is attached as **Exhibit F**.

59. Based on the excessively high purchase price and the inability to add the product to the shopping cart for a United States shipping address, Opposer does not believe the AliExpress listing to be a legitimate vehicle for purchasing a Scoutrat knife and shipping it to the United States.

60. The second Google result identifies a purported Amazon.com listing for "SCOUTRAT M390 Blade Titanium Handle Dual Color Oxidation pocket knife." See Ex. E.

61. However, when a user clicks on the link for the Amazon.com listing, the user receives the following message:

62. The third (and final) Google result identifies a second purported Amazon.com listing for "SCOUTRAT pocket folding knife, sandblasted M390 blade." See Ex. E.

63. However, when a user clicks on the link for that Amazon.com listing, the user receives the following message:



https://www.amazon.com/-/zh_TW/dp/B0CNTQK5LG (last visited May 13, 2025).

64. After diligent investigation, Opposer found no evidence that Applicant used Applicant's Mark in commerce in the United States in connection with any of Applicant's Goods on or before the Subject Application's filing date or that Applicant is currently using the mark in commerce in the United States in connection with any of Applicant's Goods.

65. Moreover, further calling into question the veracity of the Declarations that Applicant's counsel verified in the Subject Application, Opposer notes that several of the applications that Applicant's counsel has prosecuted before the United States Patent and Trademark Office ("USPTO") have been the subject of trademark oppositions alleging fraud and nonuse. See *e.g.*, U.S. Opposition No. 91297560 (asserting fraud and nonuse); U.S. Opposition No. 91297395 (same); U.S. Opposition No. 91297046 (same); U.S. Opposition No. 91294629 (same); U.S. Opposition No. 91297098 (asserting non-use); U.S. Opposition No. 91293953 (same).

66. Upon information and belief, and after investigation, Opposer believes that Applicant has never sold any of Applicant's Goods in the United States under Applicant's Mark and, thus, the Subject Application is void because Applicant fraudulently filed it on a use basis when the mark was not actually in use in commerce in the United States.

FIRST GROUND FOR RELIEF
LIKELIHOOD OF CONFUSION – 15 U.S.C. 1052(d)

67. Opposer repeats and re-alleges each and every allegation set forth in each of the preceding paragraphs as if fully set forth herein at length.

68. Applicant's Mark so resembles Opposer's Scout Marks, when used with or in connection with Applicant's Goods, as to be likely to cause confusion, or to cause mistake, or to deceive.

69. For these reasons, among others, relevant persons, including, without limitation, those persons for whom Opposer's collective membership marks are displayed, are likely to mistakenly believe that Applicant's Goods, emanate from, are endorsed by, or are in some way associated with Opposer's organization and the goods and services that it provides.

SECOND GROUND FOR RELIEF
FALSE ASSOCIATION – 15 U.S.C. 1052(a)

70. Opposer repeats and re-alleges each and every allegation set forth in each of the preceding paragraphs as if fully set forth herein at length.

71. Applicant's Mark is similar to and/or a close approximation of Opposer's Scout Names and Identities as identified above.

72. Applicant's Mark, when used with or in connection with Applicant's Goods, would be viewed by consumers as pointing uniquely and unmistakably to Opposer.

73. Opposer is not connected with Applicant or the goods offered or sold, or intended to be offered or sold, by Applicant under Applicant's Mark.

74. The fame or reputation of Opposer is of such a nature that a connection with Opposer would be presumed by consumers when Applicant's Mark is used with or in connection with Applicant's Goods.

THIRD GROUND FOR RELIEF
DILUTION THROUGH BLURRING – 15 U.S.C. 1125(c)

75. Opposer repeats and re-alleges each and every allegation set forth in each of the preceding paragraphs as if fully set forth herein at length.

76. Opposer's Scout Marks are distinctive and famous.

77. Opposer's Scout Marks have been famous from a time before the filing dates of the Subject Applications, before Applicant's claimed priority dates, and before any subsequent date of actual first use that Applicant may later allege.

78. Applicant's Mark is likely to cause dilution by blurring the distinctive quality of Opposer's Scout Marks.

79. If Applicant were granted registration of the Subject Applications herein opposed, it would thereby obtain at least a *prima facie* exclusive right to the use of Applicant's Mark. Such registration would be a source of damage and injury to Opposer.

FOURTH GROUND FOR RELIEF
VOID AB INITIO FOR NON-USE UNDER 15 U.S.C. § 1051(a)

80. Opposer repeats and re-alleges each and every allegation set forth in each of the preceding paragraphs as if fully set forth herein at length.

81. Upon information and belief, and after investigation, Applicant was not using Applicant's Mark in United States commerce in connection with some or all the goods identified in the Subject Application at the time Applicant filed the Subject Application for Applicant's Mark pursuant to Section 1(a) of the Lanham Act, 15 U.S.C. § 1051(a).

82. Upon information and belief, and after investigation, Applicant is not currently using Applicant's Mark in United States commerce in connection with some or all the goods identified in the Subject Application.

83. Because Applicant was not using Applicant's Mark in United States commerce in connection with some or all the goods identified in the Subject Application on or before the filing date of the Subject Application for Applicant's Mark, the Subject Application is void *ab initio* with respect to such goods under Section 1(a) of the Lanham Act, 15 U.S.C. § 1051(a).

84. By reason of the foregoing, Opposer is likely to be harmed by the issuance of a registration for Applicant's Mark as shown in the Subject Application.

FIFTH GROUND FOR RELIEF
FRAUD BASED ON FALSE DECLARATION OF USE

85. Opposer repeats and re-alleges each and every allegation set forth in each of the preceding paragraphs as if fully set forth herein at length.

86. As part of the Subject Application, Applicant's counsel verified a Declaration on Applicant's behalf stating, *inter alia*, "the mark is in use in commerce and was in use in commerce as of the filing date of the application on or in connection with the goods/services in the application."

87. After investigation, Applicant's Specimens submitted in connection with the Subject Application are suspect and, upon information and belief, Applicant was not using Applicant's Mark in United States commerce in connection with some or all the goods identified in the Subject Application at the time Applicant filed it pursuant to Section 1(a) of the Lanham Act, 15 U.S.C. § 1051(a).

88. Because, on information and belief and after investigation, Applicant was not using Applicant's Mark in United States commerce in connection with some or all the goods identified in the Subject Application at the time Applicant filed it pursuant to Section 1(a) of the Lanham Act, the Declarations submitted in support of the Subject Application was false.

89. Applicant knew at the time it filed the Subject Application that it was not using Applicant's Mark in United States commerce in connection with some or all the goods specified in the Subject Application and that the Declarations submitted in support of the Subject Application were false.

90. By falsely asserting that it was using Applicant's Mark in United States commerce in connection with all the goods specified in the Subject Application as of its filing date, Applicant intended to deceive the USPTO. Indeed, upon information and belief, Applicant's false statement was made for the very purpose of obtaining a registration for Applicant's Mark to which Applicant was not entitled.

91. The USPTO would not have approved the Subject Application for publication but for the false statement that Applicant was using Applicant's Mark in United States commerce in connection with all the goods identified in the Subject Application at the time Applicant filed it pursuant to Section 1(a) of the Lanham Act, 15 U.S.C. § 1051(a). Thus, the falsehood was a material misstatement.

92. As a result of Applicant's willful and materially false statement made in connection with the Subject Application, Applicant has committed fraud against the USPTO, which invalidates the Subject Application.

93. By reason of the foregoing, Opposer is likely to be harmed by the issuance of a registration for Applicant's Mark as shown in the Subject Application.
