NOTICE OF OPPOSITION

Opposer, Farmhouse Foods, Inc., a corporation organized and existing under the laws of California, with a principal place of business at 3685 Mt. Diablo Blvd., Suite 325, Lafayette, California 94549, believes that it will be damaged by the issuance of a registration for the alleged mark shown in Application Serial No. 98482252. Opposer hereby opposes same pursuant to Section 13(a) of the Lanham Trademark Act of 1946 (“Lanham Act”), 15 U.S.C. § 1063(a).


As grounds for opposition, Opposer alleges as follows:

1. Opposer manufactures and sells high-quality seasoned rice and pasta products that are sold throughout the United States.
2. Opposer is the owner of valid and subsisting United States Trademark Registration Nos. 1855320 (FARMHOUSE word mark, issued September 20, 1994), 4658523



(FARMHOUSE Design Mark , issued December 23, 2014), 2745639



(FARMHOUSE Design Mark , issued August 5, 2003), and 2967321 (MAKE IT DELICIOUS. MAKE IT FARMHOUSE. word mark, issued July 12, 2005) on the Principal Register in the United States Patent and Trademark Office (hereinafter the "FARMHOUSE Marks") for rice and seasoned rice mixes and pasta and seasoned pasta mixes, which have become incontestable within the meaning of Section 15 of the Lanham Act, 15 U.S.C. § 1065. Attached as Exhibit 1 is a true and correct printout from the United States Patent and Trademark Office electronic database showing the current status and title of the registrations as of June 10, 2025.

3. Opposer has used the FARMHOUSE word mark in interstate commerce in the United States continuously since March 1992 in connection with the manufacture, distribution, provision, offering for sale, sale, marketing, advertising, and promotion of rice and seasoned rice mixes and pasta and seasoned pasta mixes.
4. As a result of its widespread, continuous, and exclusive use of the FARMHOUSE Marks to identify its goods and Opposer as their source, Opposer owns valid and subsisting federal statutory and common law rights to the FARMHOUSE Marks.
5. Opposer's FARMHOUSE Marks are distinctive to both the consuming public and Opposer's trade.
6. Opposer has expended substantial time, money, and resources on marketing, advertising, and promoting the goods sold under the FARMHOUSE Marks, including through various promotional channels. During the period from January 1995 to April 2025 alone, Opposer has expended in excess of \$20 million US Dollars ([\$20,000,000]) on the marketing, advertising, and promotion of the goods sold under the FARMHOUSE Marks.
7. The goods Opposer offers under the FARMHOUSE Marks are of the highest quality as evidenced by its continued success in its over thirty (30) years of offering its goods under the FARMHOUSE word mark.
8. As a result of their distinctiveness, widespread use, and promotion throughout the United States for decades, Opposer's FARMHOUSE Marks are "famous" trademarks within the meaning of Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c), and became famous

prior to the date of first use alleged in the opposed application or any other priority date on which the applicant may rely.

9. Upon information and belief, Applicant, Trenchers Farmhouse, LLC, on April 3, 2024, filed trademark Application Serial No. 98482252 to register the proposed mark



for “Pasta; Sauces; Fresh pasta; Pasta sauce; Tomato-based sauces” in International Class 30 and “Online retail grocery store services; Wholesale food distributorship services; Retail grocery store services” under International Class 35 (hereinafter the “TRENCHERS FARMHOUSE Mark”).

10. Applicant allegedly began using the proposed mark on April 1, 2023, over thirty (30) years after Opposer began using Opposer’s FARMHOUSE word mark.
11. Opposer’s FARMHOUSE Marks have priority over the proposed mark because Opposer’s use and registration dates predate Applicant’s filing date, alleged date of first use, or any other date on which the Applicant may rely for purposes of priority.
12. Applicant’s proposed TRENCHERS FARMHOUSE Mark is confusingly similar to Opposer’s FARMHOUSE Marks. The marks are similar in appearance, sound, and commercial impression, as they share the identical and dominant term “FARMHOUSE.” Moreover, the TRENCHERS FARMHOUSE Mark and the FARMHOUSE Marks are used in connection with closely related food products—namely, pasta and rice goods. As a result, consumers encountering the TRENCHERS FARMHOUSE Mark are likely to believe that Applicant’s goods and services are affiliated with, sponsored by, or otherwise connected to Opposer, when no such relationship exists.

FIRST GROUND FOR OPPOSITION -- LIKELIHOOD OF CONFUSION

13. The proposed mark is barred from registration because it consists of or comprises a mark which so resembles Opposer’s previously used and registered FARMHOUSE Marks as to be likely, when used in connection with the alleged goods and services of Applicant, to cause confusion, mistake, or deception within the meaning of 15 U.S.C. § 1052(d).

SECOND GROUND FOR OPPOSITION -- DILUTION

14. Opposer’s FARMHOUSE Marks are distinctive and “famous” within the meaning of Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c).
15. Opposer’s FARMHOUSE Marks became distinctive and famous prior to the filing date of or date of first use alleged in Applicant’s application or any other date on which Applicant may seek to rely for purposes of priority.
16. Registration by Applicant of the proposed TRENCHERS FARMHOUSE Mark for

Applicant's proposed goods and services would be likely to impair the distinctiveness, and cause dilution by blurring, of Opposer's famous FARMHOUSE Marks in violation of 15 U.S.C. § 1125(c). Accordingly, pursuant to 15 U.S.C. § 1063, the proposed TRENCHERS FARMHOUSE Mark is not entitled to registration.

17. Registration by Applicant of the proposed TRENCHERS FARMHOUSE Mark for Applicant's proposed goods and services would be likely to tarnish the reputation, and cause dilution by tarnishment, of Opposer's famous FARMHOUSE Marks in violation of 15 U.S.C. § 1125(c). Accordingly, pursuant to 15 U.S.C. § 1063, the proposed TRENCHERS FARMHOUSE Mark is not entitled to registration.

WHEREFORE, Opposer respectfully prays that its opposition be sustained and that registration to Applicant be refused.
