**NOTICE OF OPPOSITION**

Opposer Six Continents Limited (“IHG”) believes that it will be damaged by the registration of Nastassia Marie Peters’ Application Serial No. 98528922 for the mark RUBY HALL EVENT SPACE for “rental facilities for social functions” in Class 43 (the “Application”) and opposes the same. Allegations with respect to IHG are based upon actual knowledge. All other allegations are based upon information and belief.


**IHG and Its RUBY Marks**

1. Six Continents Limited is a United Kingdom private limited company with a principal place of business at 1 Windsor Dials, Arthur Road, Windsor, Berkshire, United Kingdom SL41RS.
2. Six Continents Limited is a subsidiary of InterContinental Hotels Group, one of the world’s largest hotel companies, with over 6,700 properties spanning more than 100 countries. IHG’s hotel portfolio includes some of the industry’s most recognized and iconic brands, including RUBY, HOLIDAY INN, INTERCONTINENTAL, SIX SENSES, REGENT, CROWNE PLAZA, KIMPTON, HOTEL INDIGO, CANDLEWOOD SUITES, VOCO, AVID, and others, as shown below.



3. In addition to its rights in RUBY per se, IHG owns several registrations and pending applications for RUBY marks (individually and collectively referred to as the “RUBY Marks”), including:

The registrations are incontestable and constitute conclusive evidence of the validity of the marks, IHG’s ownership of them, and IHG’s exclusive right to use the marks for the services specified in the registrations pursuant to 15 U.S.C. §§ 1065 and 1115(b).

4. The RUBY Marks are used for hotel and related services and products. The RUBY Marks are prominently featured throughout RUBY hotel properties and marketing, including websites dedicated to the RUBY brand (including <https://www.ruby-hotels.com>, <https://www.ihg.com/content/us/en/ruby-hotels>), and social media.

**Applicant and Its RUBY HALL EVENT SPACE Application**

5. Applicant Nastassia Marie Peters is a citizen of the United States with an address at 178 Columbus Ave. #237190, New York, New York 10023-9998.

6. On May 1, 2024, Applicant filed intent-to-use (as amended) Application Serial No. 98528922 for the mark RUBY HALL EVENT SPACE covering (as amended) “rental facilities for social functions” in Class 43.

**Count One  
Likelihood of Confusion, 15 U.S.C. § 1052(d)**

7. IHG repeats and realleges each and every allegation set forth in the preceding paragraphs.

8. IHG has used in commerce and registered its RUBY Marks well before Applicant's May 1, 2024 filing date and any other priority date or first use-in-commerce date on which Applicant can rely for the Application.

9. Applicant's RUBY HALL EVENT SPACE mark so resembles IHG's prior used and registered RUBY Marks, and the services covered by IHG's used/registered marks and Applicant's applied-for services are identical or closely related, such that consumers will likely be confused, mistaken, or deceived as to the source of the parties' respective services under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. § 1052(d).

WHEREFORE, IHG believes that it will be damaged by registration of the mark shown in Application Serial No. 98528922 and respectfully requests that registration to the Applicant be refused.
