**NOTICE OF OPPOSITION**

Opposer, BELOUS LAW CORPORATION, a corporation organized and existing under the laws of the State of California and having an address of 3756 W Avenue 40, Suite K #471, Los Angeles, CA 90065 (“Opposer”), believes that it will be damaged by registration of the above-referenced mark, and hereby opposes the same. As grounds for this Opposition, Opposer respectfully alleges, as follows:

1. Opposer is the exclusive owner of the mark LAWFLUENCE in connection with legal and related services throughout the United States (the “LAWFLUENCE Mark”), of common law rights therein by virtue of its continuous and extensive commercial use of the LAWFLUENCE Mark since at least as early as June 1, 2019, and of U.S. Registration No. 6,125,745 for the LAWFLUENCE Mark, in a standard character format, covering “*Legal services; legal services, namely, preparation of applications for trademark registration and legal services related to influencers and entrepreneurs; legal advisory services; legal support related work; legal consultation services*” in International Class 45 (the “LAWFLUENCE Services”). True and correct

copies of the Certificate of Registration for, along with the particulars of, U.S. Registration No. 6,125,745 (the “LAWFLUENCE Registration”) obtained from the U.S. Patent and Trademark Office’s Trademark Status & Document Retrieval system, are attached hereto as Exhibit 1 and are hereby made of record.

2. The LAWFLUENCE Registration is valid, in full force and effect, and incontestable pursuant to Section 15 of the Trademark Act, 15 U.S.C. §1065.

3. The mark subject to this Opposition Proceeding is LEGALFLUENCE ACADEMY, as set forth in U.S. Application Serial No. 99/084,940 (the “Opposed Mark”), which seeks to register the Opposed Mark, in a standard character format, for *“Educational services, namely, conducting online training sessions in the field of business and distribution of course and educational materials in connection therewith”* in International Class 41 (collectively, the “Opposed Services”)

4. Applicant, Bounds Enterprises LLC, a limited liability company organized and existing under the laws of the State of Missouri and having an address of 420 Nichols Road, Suite 200, Kansas City, Missouri 64112, filed Application Serial No. 99/084,940 with the U.S. Patent and Trademark Office on March 14, 2025, based upon an alleged first commercial use date of January 1, 2025.

5. Because Opposer first used the LAWFLUENCE Mark on, and in connection with, the LAWFLUENCE Services well prior to Applicant’s alleged first commercial use date of the Opposed Mark, and such use has been continuous, Opposer has priority of use.

6. By virtue of Opposer’s continuous and extensive marketing, sale and rendering of the LAWFLUENCE Services under the LAWFLUENCE Mark, the LAWFLUENCE Mark has come

to be recognized by the relevant public as identifying the LAWFLUENCE Services as having their origin, or otherwise associated exclusively, with Opposer.

7. The Opposed Mark is confusingly similar, *inter alia*, in appearance, sound, meaning and overall commercial impression to the LAWFLUENCE Mark.

8. The Opposed Services are identical to, overlapping with and/or closely related to the LAWFLUENCE Services and/or are in the natural scope of expansion of the LAWFLUENCE Services for which Opposer uses the LAWFLUENCE Mark.

9. Opposer has not authorized or consented to Applicant's use or application to register the Opposed Mark.

10. Accordingly, it is likely that consumers will mistakenly believe that the Opposed Mark is connected to or associated with Opposer and/or the LAWFLUENCE Services.

11. Registration of the Opposed Mark is likely to cause confusion, cause mistake or to deceive the public in violation of Section 2(d) of the Lanham Act, 15 U.S.C. §1052 (d), and would be inconsistent with Opposer's rights in the LAWFLUENCE Mark and will cause damage to Opposer.

12. Accordingly, the LAWFLUENCE Mark, as applied to the LAWFLUENCE Services, on the one hand, and the Opposed Mark, as applied to the Opposed Services, on the other hand, are so similar as to be likely to cause confusion and, by reason of the foregoing, Opposer is likely to be harmed by registration of the Opposed Mark.

WHEREFORE, Opposer respectfully prays that registration of the Opposed Mark not be permitted and/or that the Honorable Trademark Trial and Appeal Board grant to Opposer such other and/or further relief as it may deem just and proper.
