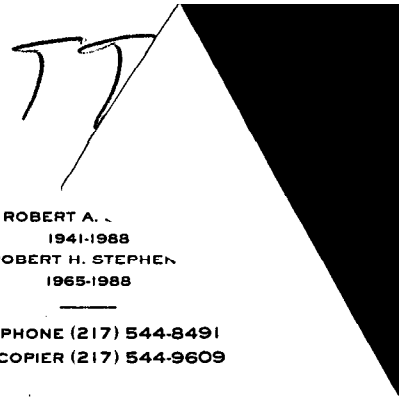


WITHDRAWAL OF CANCELLATION PROCEEDING


