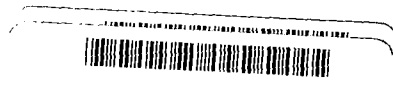


The parties have exchanged settlement offers and additional time is needed in order that the




