Registrant hereby requests a ninety (90) day extension of time within which to file its Answer to the Cancellation proceeding, namely, from March 25, 2004 to June 23, 2004. One of Petitioner's Attorneys, Nancy Rubner Frandsen, has given her consent to this extension on the second page of this motion.

The parties have reached a settlement of this matter. As part of the settlement, Registrant will surrender its registration for partial cancellation. A draft of the proposed Partial Cancellation is attached as Exhibit A. The Settlement Agreement was executed by Registrant on March 9, 2004 and sent to attorneys for Petitioner on March 11, 2004. On March 24, 2004, Petitioner's attorney called Registrant's attorney to advise that the Settlement Agreement has been executed by Petitioner. Once the amendment to the registration has been approved by the USPTO, the


parties will file with the TTAB a Stipulation of Dismissal without prejudice and signed by both parties. A draft of the proposed dismissal document is attached as Exhibit B.

WHEREFORE, Registrant hereby requests a ninety (90) day extension of time within which to file its Answer so that it may have adequate time to file the above-referenced documentation to conclude this proceeding.




